Narrative

On 11/01/2022 at approximately 1131 hours, as a uniformed officer with the Ocean County Sheriff's Office Civil Process Unit, I arrived at Chase Bank located at 499 Route 70, Brick, NJ 08723 in my marked patrol vehicle to serve court ordered bank levies. Once my patrol vehicle was parked a woman later identified as Deidre Lynn Bridgeman (D.O.B. 06/03/1978) approached my vehicle. Deidre Lynn Bridgeman asked if I was called to this location regarding her. I advised her no, I was there for my weekly paperwork involving the bank. I then asked Deidre Lynn Bridgeman if she needed any assistance.

Deidre Lynn Bridgeman then went on to explain to me that she was taking her mother (later identified as Erica Bridgeman, D.O.B. 02/13/1949) to Chase Bank to obtain copies of her bank statements that were needed as proof of income to obtain an apartment that they had an appointment to go see that day. Deidre Lynn Bridgeman went on to explain that she believes her mother is suffering with Alzheimer's and is in a declining state of mind and needs to get into an assisted living apartment now. Deidre Lynn Bridgeman told me she is trying to get assistance from various resources (including Doctors) on how to deal with this disease her mother has. Deidre Lynn Bridgeman did visually appear worried and genuinely concerned over her mother.

Deidre Lynn Bridgeman stated earlier to my arrival she was driving to this Chase Bank and once she entered the shopping plaza parking lot her mother became upset that it was not her normal Chase Bank she goes to and opened the car door, attempting to get out of the moving vehicle. Deidre Lynn Bridgeman stated she then stopped the vehicle to allow her mother to get out safely. The mother then walked away from the vehicle. This incident happened in front of Houlihan's Restaurant which is located next to Chase Bank. Deidre Lynn Bridgeman pulled away and proceeded to the Chase Bank parking lot. She advised me she lost sight of her mother as she was driving to park her vehicle at the bank. I arrived shortly after this incident and that is when Deidre Lynn Bridgeman approached me.

Deidre Lynn Bridgeman then wanted to go into the bank to see if her mother made it into the bank before starting a search in the shopping plaza for her. We walked into the bank together and Deidre Lynn Bridgeman located her mother inside sitting with a bank representative. I proceeded to serve my bank levies to a different bank representative and once completed I got a verbal confirmation from Deidre Lynn Bridgeman that all was well with her and her mother.

Upon exiting Chase Bank, I was approached by bank representatives asking to speak to me privately. They advised me they have concerns regarding elder abuse

and that Deidre Lynn Bridgeman was trying to force her mother to withdrawal all her money from her account. One bank representative later identified as Robert Novielli (bank manager) explained to me that Erica Bridgeman recently sold her house in North Carolina and has a large sum of money in her account. They stated that the mother came in upset and said her daughter was forcing her to do this. That her daughter, whom she lives with, is mean to her, always asks her for money and makes her buy food. Erica Bridgeman wants to close her account and get an apartment on her own.

At this time I stepped outside and contacted my direct supervisor, Sgt. Gronczewski #00110, to inform him of the situation. I then made contact with Deidre Lynn Bridgeman (who was in her car waiting for her mother) advising her of the allegations/concerns of the bank staff. I informed her to stay in her vehicle while I figure out what is going on.

I went back inside to speak with the bank staff once again and they were now telling me Erica Bridgeman wanted to close her account to remove her son off of the account. I asked if she asked for bank statements too and they advised me yes.

I proceeded outside once again to speak with Deidre Lynn Bridgeman. Deidre Lynn Bridgeman went into further details how her mother's mental state is breaking down. How she keeps calling the police on her for little odd things that do not make sense like a missing TV remote control, etc. How her mother had copies of her pension paperwork for the apartment, but lost them earlier that morning. Thus, why they needed the bank statements now as proof of income. Deidre Lynn Bridgeman expressed again true concerns over her mother's mental deterioration.

In the middle of this conversation, Erica Bridgeman came out of the bank and proceeded to get into the passenger seat of the car. She had a calm demeanor, was not visibly upset and was not showing any ill will towards her daughter. Erica Bridgeman did appear confused as to why I was talking with her daughter and wanted to know who called me. Before explaining to Erica Bridgeman my reason for talking with her daughter, I asked Erica Bridgeman what her reason for coming to the bank today was. Erica Bridgeman first stated that she did not remove any money from the bank, she was there to obtain bank statements for an apartment she was going to look at soon with her daughter, to close her current account so she could remove her son off of it and to open a new account solely in her name. Erica Bridgeman then became upset when I explained to her why I was there and that the bank was having concerns regarding her daughter's intentions. Erica Bridgeman stated again that she was not there to take any money out of the account. That her daughter did not ask for any money and did not force anything upon her. Erica Bridgeman stated that the bank advised her that they did remove her son off of her account and that they informed her to follow up in a few days with them.

At this point in time, no crime has occurred and I advised Deidre Lynn Bridgeman and Erica Bridgeman that they were free to leave and that I had no further questions. I informed Deidre Lynn Bridgeman that I would be generating an informational report on this incident. I asked Deidre Lynn Bridgeman if she would like some county phone numbers for organizations she can contact for services for her mother's Alzheimer's. Deidre Lynn Bridgeman gladly accepted and came over to my patrol car to take a picture with her phone of my printout of organizations. I wished Deidre Lynn Bridgeman the best of luck and she thanked me and left the scene without incident.

I went back into the bank and informed Robert Novielle that I was generating an informational report on this incident since no crime was committed. I left the scene without incident.

BWC was operational. All parties were advised they were being recorded. Reference BWC footage from both 22S021411 and 22S021416.
