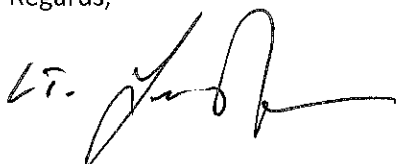

I, along with Lt Radsniak, Sgt Leonhardt, Sgt McNally, Officer Ippolito, Officer Tobias, Officer Popiel, Officer Rossi, and Officer Nickerson, responded to the area of Rt 88 and Northstream Pkwy for a report of a motor vehicle accident. Upon arrival, I observed vehicle NJ:A39KLC on the Eastbound shoulder of RT 88 in front of Academy of Dance (3000 RT 88). At this time, Officer Popiel was speaking with the driver, identified as Kara Costa, next to her vehicle.

After positioning my vehicle to assist in directing traffic, I was flagged down by a witness, identified as [REDACTED]. [REDACTED] advised me that she observed Costa's vehicle traveling East on Rt 88 at a high rate of speed. [REDACTED] informed me that she observed Costa's vehicle as it turned right into Academy of Dance before striking the building. [REDACTED] went on to state that after the Costa's vehicle came to it's final rest, she observed Costa remove alcohol from the vehicle.

After speaking with [REDACTED] another witness, identified as Gabriel Simon, informed me of a situation prior to the crash. Simon went on to inform me of a possible [REDACTED] that Costa had been involved in. Reference [REDACTED] for additional details. Simon advised me that he, along with Kara Callahan and Melissa Cutler, proceeded to a private residence located in Point Pleasant to pick up Costa. After retrieving Costa, the three proceeded back to Simon's residence located in Brick. Simon advised me that during the ride, he believed that Costa was intoxicated and appeared as if she may get sick.

Costa was then brought back to Simon's residence in Brick where he went into the house to get water for her. While at Simon's residence, Costa got out of Simon's vehicle and entered her personal vehicle that was at that location. Costa had informed them that she wanted to return to the location she was picked up from in an attempt to retrieve her cell phone. At that time, Cutler and Callahan attempted to prevent her from leaving. Callahan attempted to physically remove the keys from the vehicle but was unsuccessful in doing so.

Costa then left the residence at a high rate of speed. Simon then attempted to follow Costa but it was unsafe to continue so he backed off. Simon next came across the crash and pulled over to give a statement about the events prior to the crash. Simon also advised me that Costa had an incident earlier in the day in which her brakes had not worked properly and stated that was the reason for her vehicle being at his residence. Cutler and Callahan later arrived on scene. Cutler and Callahan confirmed they too believed Costa was intoxicated and possibly involved in a prior [REDACTED]. No new details were presented after speaking with Cutler and Callahan.

Costa was then released by First Aid after signing the refusal form. I then spoke with Costa who advised me that she was driving East on Rt 88 near Northstream Pkwy. Costa stated that she observed the vehicle in front of her, operated by Michael Menzel, suddenly hit its brakes. Costa advised me that she attempted to stop but her brakes failed. Costa then impacted the rear of Menzel's vehicle. Costa stated that her vehicle then continued East on Rt 88. Costa claimed she was unable to stop the vehicle so she pulled into the parking lot of Academy of Dance. The vehicle then continued through the parking lot and struck the building causing damage. Costa informed me that her vehicle then rolled backwards out of the parking lot before finally coming to a rest on the shoulder of Rt 88 Eastbound.

I then asked Costa if she had been drinking this evening which she denied. While speaking with Costa, her eyes appeared droopy and her speech was slurred. Additionally, Costa would sway slightly while standing.

Costa was then informed that she would be asked to perform Standardized Field Sobriety Tests. Sgt Leonhardt then had Costa perform the Standardized Field Sobriety Tests. (See Sgt Leonhardt's Supplemental Narrative for additional details)

Costa was then placed under arrest for 39:4-50 (Driving While Intoxicated). The alcohol referenced by [REDACTED] was then located under the "Nature's Reward" business sign near the vehicle. The alcohol, four Corona Extra bottles and an open miniature bottle of Jim Bean, was located in a 24 count Corona Extra box. Additionally, an open miniature bottle of Jim Bean was found on the ground directly next to the rear passenger side door. While searching Costa's vehicle for the vehicle's registration and proof of insurance, a green grinder, typically used with marijuana, was observed in plain view behind the driver's seat. The grinder had a green vegetative substance and seeds inside of it. In addition, an open bottle of Jerry's Vodka was found in the pouch in the back of the driver's seat.

Costa was then placed in the rear of Officer Tobias's marked patrol car and seat belted in. Sgt Leonhardt then advised Costa of her Miranda Rights at 2325hrs. Costa was advised that she would be audio and video recorded while in the vehicle. Officer Tobias then transported Costa to Police Headquarters.

Sgt Leonhardt and I then secured the evidence and returned to Police Headquarters. Costa was then advised of her Operating Under the Influence (OUI) Rights to which she responded "Yes." A 20 minute observation was then completed. Sgt Leonhardt then operated the Alcotest 7110 MKIII-C and retrieved breath samples from Costa (See Sgt Leonhardt's Supplemental Narrative for additional details). Costa's Blood Alcohol Content Level was then determined to be 0.14%. Costa was then again advised of her Miranda Rights on 09/04/2018 at 0040hrs. A Drinking Driver Questionnaire was then completed with Costa. Costa was then fingerprinted and photographed. I then contacted Cutler on Costa's behalf and requested that she come to Police Headquarters to pick her up per John's Law. Cutler arrived and a Potential Liability Warning Form was completed. Costa was then released to Cutler on 09/04/2018 at 0211hrs.

Costa was issued 1524-B-070467 for 39:4-50, 1524-B-070468 for 49:4-96, 1524-B-070469 for 39:4-97, 1524-B-070470 for 39:3-44, 1524-B-070471 for 39:4-51b, and 1524-B-070472 for 39:4-49.1. Additionally, Costa was charged with 2C:33-15A, 2C:35-10A(4), and 2C:36-2 on complaint-summons 1524-S-2018-000174. Costa received a court date of 09/17/2018 at 0830 hours for the above listed summonses and charges.

After being medically assessed by First Aid members at the scene, it was determined that Ms. Costa did not suffer any significant injuries, and she elected to sign off for further treatment at the hospital. I then asked Ms. Costa a series of questions regarding the incident. As Ms. Costa spoke, I could clearly detect the odor of an alcoholic beverage emanating from her breath, however, she denied consuming any alcoholic beverages that day. Furthermore, Ms. Costa's posture was loose and she would occasionally sway while standing still, and her face was flushed. I then asked Ms. Costa to perform a series of field sobriety tests which she agreed to. The results are as follows:

One-Leg Stand: After explaining and demonstrating the test to Ms. Costa, she failed to raise her right leg to the desired height of 6". She also used her arms to balance herself and was unable to maintain her balance on one leg for a duration longer than 5 (1000) seconds. Ms. Costa attempted this test twice.

Walk and Turn: Ms. Costa had a difficult time maintaining her balance, keeping one foot placed in front of the other while standing, during the instructional phase of this test. Once the test began, Ms. Costa did walk the 9 steps forward and back as instructed, however she stepped off line on steps 3, 5, 6, and 7 on the approach, and steps 4, 5, 6, 7, and 8 on the return. Ms. Costa did not touch heel-to-toe throughout the entire test.

Horizontal Gaze Nystagmus: Ms. Costa displayed a distinct and sustained nystagmus in both eyes during Smooth Pursuit and again at Maximum Deviation. Onset was detected almost immediately.

Following these tests, Ms. Costa was placed under arrest for Driving While Intoxicated. She was handcuffed, placed into the rear of the patrol vehicle, and was subsequently transported to Police Headquarters for processing. At headquarters, all radios and electronic devices were removed from the processing room. I then read Ms. Costa the Standard Statement for Operators of a Motor Vehicle, after which she agreed to submit breath samples. After conducting a 20 minute observation period on Ms. Costa, she provided (2) sufficient breaths into the Alcotest. Her readings were found to be .14% BAC. These results were analyzed through the N.J. State Police Alcotest Calculator and were found to be within acceptable tolerance.

The MVR recording device in my patrol vehicle was activated. The operator, later identified as Thomas Conaty, was standing outside of the vehicle speaking with P.O. Rossi. Thomas was wearing a tee-shirt and pants. He was not wearing shoes or socks. As I approached Thomas, he was speaking words that I was unable to understand, as a result of his voice being slurred. I engaged Thomas in conversation. I immediately observed that Thomas's eyes were bloodshot and his eyelids were droopy. Thomas's knees were sagging and he was swaying from side-to-side. I asked Thomas how many alcoholic beverages he consumed, he replied, "3 or 4 Budweiser beers". Thomas admitted that he drove from his residence in Brick, NJ. He went on to say that he was the one driving when the motor vehicle accident occurred.

I asked Thomas to tell me the time without looking at a clock. He replied "4:00 am". The actual time on my watch was 2:28 am. I asked Thomas to recite the English Alphabet starting with the letter C and ending with the letter R. Thomas recited the following: A, B, C, D, E, F, G, A, F, J, then stopped. Next, I asked Thomas to count backwards starting with the number thirty-three and ending with ten. Thomas counted numbers in the following order: 33, 29, 27, 26, 27, 27, 21. At this point, I terminated the test.

I advised Thomas that I was going to have him perform multiple tests. Thomas was said he was ok performing the tests without his shoes. Thomas stated that he has an injury to his lower back. Thomas said his injury was affecting him, however, he was unable to be specific how it was affecting him. Thomas stated that he did not consume any narcotics or medications.

One Leg Stand. I advised Thomas that I was going to have him perform the one leg stand test. I instructed Thomas to stand with his arms down along his sides, and his feet together while I explained the test. I instructed Thomas not to begin the test until ordered to do so. I advised Thomas that he must keep his arms down along his sides and lift the foot of his choice approximately six inches off of the ground, with his toe pointed towards the sky. I advised Thomas that at the same time he must count starting at 1001, 1002, 1003 and so on, until instructed to stop. While explaining the test, Thomas was swaying from side-to-side the entire time. When I asked him if he understood my instructions, he replied, "No". Thomas went on to say that he cannot perform the test as a result of a recent surgery to his lower back. Thomas continued to exhibit slurred speech the entire time he was talking to me.

Walk and Turn Test. I advised Thomas that I was going to have him perform the walk and turn test. I instructed Thomas to stand in the following position while I explained the test: arms down along his sides, left foot in front of his right foot touching heel-to-toe. Thomas was unable to maintain the position. I advised Thomas not to begin the test until instructed to do so. I told Thomas that he must keep his arms along his sides and walk nine steps forward, touching heel-to-toe and count the steps out loud (e.g. 1, 2, 3, 4 and so on). After completing the nine steps, I told Thomas that he must turn around and walk nine steps heel-to-toe in the opposite direction, again, counting the steps out loud. I demonstrated the test for Thomas. It should be noted, I did allow Thomas to perform the test on a white line painted on the parking lot. When I asked Thomas if he understood my instructions, he raised his hands in the air and stated he was involved in a really bad accident and he was unable

to perform the test. Again, Thomas exhibited slurred speech the entire the entire conversation.

P.O. Rossi performed Horizontal Gaze Nystagmus testing.

During the testing process, I was able to smell an odor of an alcoholic beverage emanating from Thomas's breath. At one point, I did observe a case of Natural Light beer located on the passenger floor of the vehicle. Upon further investigation, I observed multiple empty Natural Light beer cans on the floor of the vehicle. There was a total of ten unopened 12 ounce Natural Light beer cans, one unopened 12 ounce Natural Light beer can, and six 12 ounce empty beer cans.

Based upon my observations, Thomas was placed under arrest for Driving While Intoxicated 39:4-50. I handcuffed Thomas utilizing the double-lock technique. I searched Thomas and placed him in the rear seat of my patrol vehicle, secured with a seatbelt. I advised Thomas he was being audio and video recorded. Thomas was transported to Police Headquarters, along with his property.

P.O. Rossi and Sergeant Miller remained at the scene with the vehicle. Tow-By-Us duty tow impounded the vehicle to satisfy the NJ Attorney General guideline regarding the twelve-hour minimum impound requirement. P.O. Rossi seized the beer cans and later transported them to Police Headquarters.

Upon arrival at Police Headquarters, I entered the sallyport, then secured my firearm in a lockbox. I escorted Thomas into the booking area. I removed all portable electronic devices from the booking area. I read Thomas his Miranda Warning. I read Thomas the NJ Standard Statement form. I asked Thomas twice if he will submit samples of his breath for testing, both times he replied, "No". I advised Thomas he was also being charged with Refusal To Submit Breath Samples 39:4-50.4a. Thomas was fingerprinted and photographed. I completed a Suicide Evaluation form. I completed a Property Receipt form. I made contact with Thomas's brother, George Conaty, who agreed to respond to Police Headquarters.

George Conaty arrived at Police Headquarters, agreeing to take responsibility for Thomas when released. I completed a Potential Liability Warning form. I provided George with the original copy. I issued Thomas copies of the following summonses:

I advised Thomas of his mandatory court date on 9/17/18 at 0830 hours. Thomas was released into the custody of George, along with his property and a copy of the Property Receipt.

I entered the beer cans into the BEAST evidence system. I secured the beer cans in temporary storage locker seven. Detective Hill was advised via email.

On 09/18/2018 at 09:14 hrs, I, P.O. Loren MacIver, was dispatched to the parking lot of Gerard's Wine and Spirits(2310 Bridge Avenue) for a report of a motor vehicle having struck a light pole within the parking lot. Upon arrival to the scene with Sgt. Woit, P.O. Kavanagh, and P.O. Maloney, I observed a grey Kia vehicle(NJ E25GKE) that had struck a parking lot light post and the vehicle was observed to still be in contact with the post with its engine still running. Officers turned off the vehicle's engine and I observed a female subject, identified as Janice Vroome, sitting on a chair and speaking with Sgt. Woit and P.O. Maloney near the entrance door to the nearby building. Vroome was first asked by officers if she was injured and she stated with slow, slurred speech that she was not. I immediately detected an odor of alcoholic beverages emanating from Vroome while speaking with her. I asked Vroome if she had consumed alcoholic beverages and she first denied consuming any before stating that she had in fact consumed one drink the previous evening. Vroome stated she had drank the remainder of her husband's rum and that she drove her vehicle to the liquor store to buy more rum before he realized it was gone. Vroome stated she had ingested one prescribed Alprazolam pill just prior to police arrival to the scene. Vroome then showed officers her prescription bottle of Alprazolam and it was confirmed that it was in fact her own prescription. Vroome was then placed under arrest at the scene for Driving While Intoxicated (39:4-50). Field sobriety tests were not conducted due to Vroome's physical condition and due to the fact that Vroome had already fallen onto the concrete sidewalk from possible impairment. Vroome was walked to the my patrol vehicle (Car #3) and seated into the back seat. Vroome was not handcuffed due to the fact that she had been walking with the assistance of a cane. Vroome was then transported to Police Headquarters. Sleepy Hollow Exxon arrived to the scene to tow and impound Vroome's vehicle.

Vroome was read the N.J. Attorney General's Standard Statement for Motor Vehicle Operators (N.J.S.A. 39:4-50.2(e)) and Vroome's replies were noted as, "May I read that?" and "We both know I'm trashed off my ass." Vroome ultimately refused Alcotest breath tests. Vroome was then processed and placed into Cell #4. A Property Receipt was then completed for Vroome's personal belongings. Vroome was issued three separate summonses for the following Title 39 violations: Reckless Driving (39:4-96 E-ticket # 1524E18001248), Operating Under the Influence of Liquor or Drugs (39:4-50 E-ticket # 1524E18001249), and Refusal to Take Samples of Breath(39:4-50.2 E-ticket # 1524E18001252). The court date was set for 10/01/2018 at 4:15PM.

Vroome's husband, Brian R. Vroome arrived at Police Headquarters at 11:00 hrs, and he read the Potential Liability Warning(N.J.S.A. 39:4-50.22). Brian acknowledged and signed the form and was given his copy. Janice Vroome was then released to Brian.

I spoke with Gerard's Wine and Spirits manager Brian P. Hall on 09/19/2018. Hall stated there was no damage incurred to the light post. Hall provided me with video surveillance footage of the incident, which was admitted into evidence. The surveillance footage was submitted as two separate brief videos. The first video showed Vroome's vehicle pulling too far forward through the lined parking spots while the second video showed Vroome lose her balance before falling onto the sidewalk, as she had been walking away from her vehicle after the collision had already taken place.
