On 03/29/2019 at 2332 hours I, P.O. Gunnell was on patrol traveling East on Rt 88 coming over the Rt 88 Bridge. As I was coming over the crest, I noticed a vehicle attempting to make a left hand turn onto Rt 88 Westbound from Memorial Dr. The vehicle appeared that it was going to stop. The vehicle then suddenly continued, which caused me to have to apply my brakes in order to not strike the suspect vehicle. The vehicle then quickly accelerated, which caused the tires to spin. I was able to turn my vehicle around and as I came back over the bridge, I saw that the suspect vehicle made a right hand turn onto Herbertsville Rd. There was one vehicle between my patrol vehicle and the suspect vehicle.

The suspect vehicle stopped at the four way stop on Herbertsville Rd and River Ave. The suspect had the right of way and waited at the intersection for approximately ten seconds prior to driving forward. As the suspect accelerated, the suspect did this too quickly causing the rear wheels to spin. After this, I was able to get behind the suspect vehicle which was traveling at a high rate of speed. I estimated the speed to be approximately 60 MPH. The suspect got stuck behind another vehicle which caused him to slow down. While traveling West on Herbertsville Rd, the suspect was unable to maintain lane by traveling with both driver side tires on the center lane near Hardenburgh Ave. The driver was able to correct himself and again near Ida Dr, the driver swerved to the fog lane and back to the center lane marking. At that point I activated my emergency warning lights and performed a motor vehicle stop. The driver came to a stop in the middle of the intersection of Pleasant Pl and Herbertsville Rd.

I approached the vehicle and identified the driver as James Komninakis. Upon approaching the vehicle, I asked for the driving credentials. I was able to view that James hand movements were delayed and he was fumbling with his paperwork. James asked what the problem was and why asked why he was being pulled over. James felt that he was doing nothing wrong. When I was explaining his violations, James stated that he was doing the precincts. When questioned what he meant, he just repeated that he was doing the precincts. Eventually he was able to explain that he was doing HVAC work at two New York City Police Departments. While James was speaking, he was slurring his words. I was able to detect an odor of an alcoholic beverage coming from his breath. I asked where he was coming from and he point forward and stated "right there". I asked if he any drinks that evening and he replied yes. When asked how many drinks he had, he replied that he did not have any drinks. P.O. Aurin arrived on scene.

Based on his actions and response to questions, I advised James that I wanted him to perform a test while he remained in the vehicle. I asked James if he understood and was able to recite the English Alphabet. James stated that he could. I asked James to recite the alphabet from the letter "D" to the letter "R". James stated that he understood and recited A,B,C,D,E,F,G,H,R. James paused then recited J,K,L,M,N,O,P,Q,R,S,T,L,V. James then asked if I wanted him to continue. I asked James out of the vehicle.

I brought James to the side of his vehicle to perform field sobriety tests. While walking to the side of the street, James was unsteady on his feet. His speech continued to be slurred. I performed Horizontal Gaze Nystagmus Test on James. Several times during the test, James was unable to keep his head straight. James refused to realize that he was continually moving his head. I was able to view in both eyes, a lack of smooth pursuit, distinct and sustained nystagmus at maximum deviation, and onset of nystagmus prior to 45 degrees.

Prior to performing the walk and turn, I asked James to back up down the street to allow room for the test. As he did this, he lost balance. I asked James if he had any injuries that would prevent him from performing the test

and he answered, no. Prior to explaining the test, I asked James to stand with his right foot in front of his left foot. Instead of doing this, James raised his right foot off the ground. James was eventually able to put his feet in the correct position but was unable to hold this position without keeping his hands down to his side. I advised James to not start the test until after I explained and demonstrated the test. While explaining the test, James started walking and counting his steps. I again explained the process. After again explaining and demonstrating the test, James advised that he understood. James took nine steps forward and lost balance on his 4th and 6th step. As James turned around he lost balance and almost fell over. James took nine more steps back. James lost balance on his 2nd and 3rd step back. When James finished his nine steps, James turned around to face me and again lost balance, almost falling over.

The next test was the One Leg test. I explained and demonstrated the test. As James began, he raised both of his arms for balance. James raised his right leg. He lost balance at the count of two. James counted 1,2,3,4,4,5,6,7,8,5 and put his foot down. Based on my interaction with James, his driving actions and the results of his field sobriety tests, I placed James under arrest for Driving While Intoxicated(DWI). James was handcuffed using the double lock method. James was placed in the rear of my patrol vehicle. He was advised that he was audio and video recorded while in the rear of the vehicle. James was secured using a seat belt. Headquarters was advised of the arrest and a duty tow was requested. I approached the vehicle and identified the passenger as Gina Munafo. Gina stated that they were at Europa South earlier in the evening and then Uncle Vinnies Comedy Club. Gina stated that James had several drinks that evening and she attempted to get him to stop drinking. P.O. Aurin stayed with Gina and the vehicle until Sleepy Hollow came and towed the vehicle. Eventually P.O. Aurin transported Gina to Headquarters.

I transported James to Headquarters where he was placed in the processing room. All electronic devices were taken out of the room. I read James his Miranda Warning rights and he stated that he understood. I read James the NJ Attorneys General's Standard Statement for Motor Vehicle Operators form. When asked if he was willing to supply a breath sample in order to determine his blood alcohol concentration(BAC), James replied that he wanted a lawyer. I attempted to explain to James that he was not allowed a lawyer to be present during this test. He again demanded a lawyer several times. I read James the last paragraph and he again replied that he wanted a lawyer. All information was entered into the Alcotest 7100 MKIII-C and refusal was entered. James was given a phone call to get a ride home. James contacted his father who stated that he was already at Headquarters, picking up Gina. He advised that he would stay at Headquarters and drive both James and Gina home.
