On 05/03/2019 at 0204 hours I, P.O. Gunnell was responding to the area in front of Baron's Bagels(3003 Rt 88) for a report of a vehicle that crashed into a pole. This was called in by P.O. Henrich who was driving past the crash while on patrol. Prior to arrival, P.O. Henrich stated that the male appeared fine but called out First-Aid for precautionary reasons due to the airbags being deployed in the vehicle.

Upon arrival NJ Registration X63FSL was crashed up against pole# BT 333 PPB. Based on the damage to the vehicle and the airbags being deployed, a tow was requested. The driver, Korey Petino was outside of the vehicle. I instructed Korey to exit the roadway and into the parking lot of Baron's Bagels. I asked Korey if he was physically injured and he advised that he was fine and had no injuries from the crash. He advised that he was wearing his seatbelt during the crash. When asked where he was going, he pointed Westbound and stated that he was going home. I asked if he lived in Bricktown and he advised that he lived in Point Pleasant off of River Ave. When advised that was in the opposite direction he answered that he wasn't going home and was just going for a drive. While speaking, Korey's words were slurred. I was able to smell an odor of an alcoholic beverage coming from his breath. I asked where he was coming from and he stated that he was driving his friends home. He stated that he was driving them home from Amendment 21, a bar located in Point Beach. I asked if he any drinks this evening and he replied that he had two gin and tonics.

Based on actions, I asked Korey to perform field sobriety tests. I asked Korey if he was able to understand and recite the English Alphabet. Korey stated that he could. I asked him to recite the alphabet from the letter "D" to the letter "R". Korey stated that he understood and recited D,E,F,G,H,I,J,K,L,M,N,O,P,R,Q,S,T,U,V,W,S,K.

The next test was the Horizontal Gaze Nystagmus Test. During the test, I had to instruct Korey several times to keep his head still and follow with his eyes only. I was able to view in both eyes, lack of smooth pursuit, distinct and sustained Nystagmus at maximum deviation, and onset of Nystagmus prior to 45 degrees.

Walk and Turn

I asked Korey if he had any injuries that would prevent him from performing any tests. He answered that he was fine. I brought Korey in front of a straight line in the parking lot. I asked Korey to stand with his right foot in front of his left foot while I explained the test. I asked him to not perform the test until I explained and demonstrated. As I began to explain the test, Korey started to walk down the line. I again had to explain to wait for me to explain the test. Korey was unable to stand with his right foot in front of his left foot. I was able to explain and demonstrate the test and Korey advised that he understood. He began the test and was able to walk nine steps. Korey did not touch heel to toe on any step and lost balance on his 2nd, 4th, 5th and 8th step. Korey turned around and took nine more steps. Korey was unable to touch heel to toe on any step back and lost balance on his 4th step.

One Leg Stand

I explained and demonstrated the test to Korey and he advised that he understood. Korey lifted his right foot and dropped it when he got to the count of 3. Korey again raised his foot and began counting at 4. Korey then counted 5,6,7,10,8,9,10 and again dropped his foot. Korey was raising his hands for balance during this test.

While Intoxicated(DWI) based on his actions and performance on field sobriety tests. I handcuffed him using the double lock method and placed him in the rear of my patrol vehicle. He was advised that he was audio and video recorded while in the rear of my patrol vehicle. I was able to retrieve Korey's cell phone, keys and wallet from the vehicle. P.O. Henrich stayed with the vehicle until the tow, Ocean Bay Auto arrived. A call was also placed to Verizon to respond due to the pole being cracked at the base.

I transported Korey to Headquarters where he was placed in the processing room. He was placed on the bench. I made sure that all portable electronic devices were taken out of the room. I read Korey his Miranda Warning Rights to which he stated that he understood and signed the card. Korey was read the New Jersey Attorney General's Standard Statement for Motor Vehicle Operators Form. When asked if he was willing to supply a breath sample in order to determine the blood alcohol concentration(BAC) in his system, Korey answered "Yes". Drinking Driving Questionnaire was filled out. I waited the standard twenty minutes before operating the Alcotest 7110 MKIII-C. I used the internal clock on the Alcotest to ensure that the twenty minutes has passed. When prompted Korey was able to supply two proper breath samples. Mouthpieces were changed after each sample. The results of Korey's breath samples were found to be .17%BAC. They were entered into the NJSP Alcotest calculate and found to be within an acceptable tolerance.

Korey was given a phone call and was able to make contact with his friend, Taylor Struyf. When asked, Taylor stated that she would come down to Headquarters. I finger printed and photographed Korey. I issued him summons#070112- DWI, 070113- Reckless Driving, 070114- Failure to maintain lane. All were set with a court date of 05/06/2019 at 1600 hours. Taylor responded to Headquarters and signed the potential liability form taking Korey into her custody.
