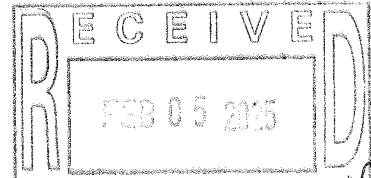

12/26/2024 17:09	Report of Lt. Bucceri #145 On the above date and time Mr. Franmer Ferreras-Diaz reported that his license plate (NJ reg 5LWU9) was stolen. Mr. Ferreras-Diaz stated that on 1/11/24 he sold his 1998 Suzuki Katana motorcycle to a Mr. Yaseen Jalal (bill of sale photo provided). Mr. Ferreras-Diaz stated that Mr. Jalal had agreed to send the license plate back to Mr. Ferreras-Diaz once he returned home with the motorcycle. Mr. Ferreras-Diaz stated that since that time he has made multiple attempts to contact Mr. Jalal all of which were unsuccessful. In the span of roughly 1 year Mr. Ferreras-Diaz stated that he has gotten numerous toll violations where his license plate was utilized. I then ran NJ reg 5LWU9 and confirmed that the plate was registered to Mr. Ferreras-Diaz. I then entered NJ reg 5LWU9 into NCIC as stolen with NIC/P648748718 and provided Mr. Ferreras-Diaz with a case number. The printout was then added to the stolen license plate binder for 2024. No further action was taken.
