ARTICLE I - RECOGNITION

- A. The Board hereby recognizes the East Windsor Regional Supportive Staff Association as the exclusive representative for collective negotiations as defined in the New Jersey Public Employer-Employee Relations Act, N.J.S.A. 34:13A-1 et seq., concerning grievance and terms and conditions of employment for employees under contract by the Board in the following job categories:

The Board agrees not to negotiate with any organization other than that designated as the representative pursuant to Chapter 123, Laws of 1974.

The term "Board" shall include its members and agents.

- B. Unless otherwise indicated, the term "employee," when used hereinafter in this agreement, shall refer to all employees represented by the Association in the negotiating unit as above defined, and references to male employees shall include female employees.
- C. Unless otherwise indicated, references to "Chief School Administrator" when used in this agreement shall encompass the meaning of Chief School Administrator or his/her designee.
- D. The parties reserve the right to petition PERC in the event of a unit dispute.

- E. All other individuals employed by the Board not specifically enumerated above are excluded from the negotiations unit. For any new position created by the Board, the Association shall retain the right to petition the Board and PERC, if necessary, for inclusion in the unit at any time during the duration of this agreement.

ARTICLE II - FUTURE NEGOTIATIONS

- A. The parties agree to enter into collective negotiations over a successor agreement in accordance with N.J.S.A. 34:13A-1 et seq.
- B. This agreement shall not be modified in whole or in part by the parties except by an instrument in writing duly executed by both parties.
- C. During the term of this agreement neither party shall be required to negotiate with respect to any such matter, whether or not within the knowledge or contemplation of either or both of the parties at the time they negotiated or executed this agreement.

ARTICLE III - GRIEVANCE PROCEDURE

A. **Definitions**

1. A "grievance" is a claim by an employee or the Association based upon the interpretation, application, or violation of this agreement, policies or administrative decisions affecting the terms and conditions of employment of an employee or a group of employees.
2. An "aggrieved person" is the person or persons making the claim. All employees, including the grievant, shall continue under the direction of the Chief School Administrator and administration regardless of the pendency of any grievance, until such grievance is properly determined.
3. A "party in interest" is the person or persons making the claim and any person who might be required to take action or against whom action might be taken in order to resolve the claim.

B. **Purpose**

The purpose of this procedure is to resolve differences, at the lowest possible administrative level, concerning the rights of the parties regarding the terms and conditions of employment of the employees covered by the contract.

C. **Procedures**

1. **Level one -**

- a. Any employee covered by this contract who has a grievance shall, within ten (10) business office work days, of the occurrence, discuss it first with his/her immediate supervisor in an attempt to resolve the matter informally at that level. If an individual employee files a grievance independent of the

Association, the Association shall be notified, prior to any meeting, for the purpose of attending.

- b. If, as a result of the discussion, the matter is not resolved to the satisfaction of the employee within five (5) business office work days, he/she shall set forth his/her complaint in writing to his/her supervisor. The supervisor shall communicate his/her decision to the employee in writing within five (5) business office work days of receipt of the written grievance. If an individual employee files the grievance independent of the Association, the Association shall be given a copy of the written complaint and supervisor's decision.

2. **Level two -**

The employee may appeal the supervisor's decision within seven (7) business office work days to the Director of Personnel. The appeal to the Director of Personnel must be made in writing and must set forth the grounds upon which the grievance is based. The Director of Personnel shall request a report on the grievance from the supervisor in writing, shall confer with the concerned parties, and, upon request, with the employee or supervisor separately. Either party may request a separate meeting. He/she shall attempt to resolve the matter as quickly as possible but within a period not to exceed ten (10) business office work days. The Director of Personnel shall communicate his/her decision in writing, along with supporting reasons, to the employee and the supervisor. The Superintendent/Chief School Administrator may, in his discretion, bypass Level two and have an appeal of a supervisor's decision heard at Level three by the Superintendent/Chief School Administrator or his designee.

3. **Level three -**

If the grievance is not resolved to the employee's satisfaction, he/she may request, within five (5) business office work days, a review by the Chief School Administrator. The request shall be submitted in writing to the Chief School Administrator and include all related papers. The Chief School Administrator shall review the grievance, hold an informal appearance within twelve (12) business days of receipt with the employee, unless waived, and render a decision in writing within twelve (12) business days of the appearance. A copy of the Chief School Administrator's decision shall be forwarded to the Association.

4. **Level four -**

If the grievance is not resolved to the employee's satisfaction, he/she may request, within five (5) business office work days, a review by the Board. The request shall be submitted in writing through the Chief School Administrator, who shall attach all related papers and forward the request to the Board. A committee of the Board shall review the grievance, hold a hearing with the employee, if requested, within fifteen (15) business days of receipt of the grievance, and render a decision in writing within fifteen (15) business days. A copy of the Board's decision shall be forwarded to the Association.

5. **Level five -**

The Association may submit to arbitration by the Public Employment Relations Commission any grievance that has not been resolved to the satisfaction of the Association under Level Four of this procedure.

- a. The Association shall notify the board within thirty (30) calendar days of the Board's decision of its intent to submit the matter to arbitration.
- b. The parties shall follow the rules of the Public Employment Relations Commission for determining an arbitrator.
- c. The arbitrator shall limit himself/herself to the issues submitted to him/her and shall consider nothing else. He/she can add nothing to, nor subtract anything from, the agreement between the parties or any policy of the Board. The decision of the arbitrator shall be final and binding. Only the Board and the aggrieved and his/her representatives shall be given copies of the arbitrator's report of findings and recommendations. This shall be accomplished within thirty (30) days of the completion of the arbitrator's hearings. The costs for services of the arbitrator, including per diem expenses, if any, and actual and necessary travel subsistence expenses, shall be borne equally by the Board and the Association.
- d. All meetings and hearings under this procedure shall be conducted in private, and shall include only such parties in interest and their designated or selected representatives heretofore referred to in this article.

D. **Year End Grievance**

In the event a grievance is filed at such time that it cannot be processed through all the steps in the grievance procedure by the end of the school year, and, if left unresolved until the beginning of the following school year, could result in irreparable harm to the party in interest, the time limits set forth herein shall be reduced as mutually agreed to so that the grievance procedure may be exhausted prior to the end of the school year or as soon thereafter as is practicable.

E. **Rights of Employees to Representation**

Any aggrieved person may be represented at all stages of the grievance procedure by himself/herself, or, at his/her option, by a representative selected or approved by the Association. The Association President shall be notified by the Administration and the Association shall have the right to be present and to state its views at all stages of the grievance procedure.

F. **Reprisals**

No reprisals of any kind shall be taken by the Board or by the Association against any party in interest, any member of the Association, any representative, or any participant in the grievance procedure by reason of such participation.

G. Group Grievance

If, in the judgment of the Association, a grievance affects a group or class of employees, the Association may submit such grievance in writing to the Chief School Administrator via the Director of Personnel and the processing of such a grievance shall commence at level three of the grievance procedure.

H. Separate Grievance File

All documents, communications and records dealing with the processing of a grievance shall be filed in a separate grievance file and shall not be a part of the personnel file of any grievant, party in interest, or other participant.

ARTICLE IV - RIGHTS OF THE ASSOCIATION

- A. There shall be no discrimination, interference, restraint or coercion by the Board of Education or the Association or any of its representatives against members of the Association because of their membership or lack of membership in the Association. No employee shall be prevented from wearing pins or other identification of membership in the Association or its affiliates. Representatives of the Association and its parent organization shall be permitted to transact reasonable official Association business on school property, at reasonable times, provided that this shall not interfere with or interrupt normal school operations.
- B. The Association shall have the right to use school mailboxes, inter-school mail facilities and computer communication facilities. (A courtesy copy of non-confidential material shall be forwarded to the Chief School Administrator or his/her designee.) The responsibility for the contents of communications rests wholly with the author. The Association agrees to hold the Board harmless in the event of claims arising out of the distribution of Association material. In the posting of the Association materials and the use of mailboxes, all such material will be published on official Association stationery and dated. Such material shall be presumed to be authorized by the Association.
- C. The Association shall have the right to use school facilities and equipment after school hours in accordance with district procedures for facility usage. Approval shall not be unreasonably withheld. The Association shall supply all materials and supplies and pay for the reasonable cost of any repairs necessitated as a result thereof.
- D. Whenever any employee is required to appear before the Board or committee thereof, concerning any matter which could adversely affect the continuation of that employee in his/her office, position, or employment, or salary, or any increments pertaining thereto, then he/she shall be given notice in accordance with applicable laws and regulations. The written notice shall include a statement of the right of the employee to have Association representation at the meeting. Any questions or criticism by a supervisor or administrator of any employee and his/her work methodology shall be performed with all due professional courtesy, in confidence and, to the extent practicable, not in the presence of students, parents, co-workers, or members of the public, in a location that respects the privacy of both parties.

E. Information

In response to reasonable requests from time to time, the Board of Education agrees to make available within a reasonable amount of time, at no cost to the Association, all available information concerning the support service programs and the financial resources of the district that are a matter of public record.

F. Bulletin Boards

The Association shall have, in each school building, the partial use of a bulletin board as assigned by the principal or supervisor for Association notices provided copies are presented in advance for posting to the appropriate administrator/supervisor. All such material will be published on official Association stationery and shall be presumed to be authorized by the Association and dated.

G. Personal Privacy

The personal life of any employee shall not affect the employee's employment except as it may prevent the employee from performing his/her assigned duties.

H. Release Time for Meetings

Whenever a representative of the Association is requested/required, by the Chief School Administrator, to participate during working hours in negotiations and/or grievance proceedings, he/she shall suffer no loss in pay. Whenever practicable, management will make an earnest attempt to schedule meetings with the Association at mutually convenient times outside the working hours of the representative. When meetings must be held during the representative's working hours, management will notify the supervisor of the employee that the meeting has been requested.

I. NJEA Convention

Two (2) Association officials shall be granted one (1) additional day each year to attend the NJEA Convention.

J. New Employee Data

The Board shall notify the Association, in writing, of the name, address and salary level of each new employee.

K. School Calendar

The Chief School Administrator may consult with representatives of the Association before recommending the school calendar for the next school year. Final determination of the school calendar will rest with the Board.

ARTICLE V - COMPLAINT PROCEDURE

A. Procedural Requirement

If a formal complaint regarding an employee is submitted to any member of the administration by any parent, student, or other person who does or may influence evaluation of an employee, it shall be reduced to writing and shared with the employee.

B. Meeting with Principal or Immediate Supervisor

The principal or immediate supervisor shall meet with the employee to apprise the employee of the full nature of the complaint.

C. Right to Representation

The employee shall have the right to be represented by the Association at any meetings or conferences regarding such complaint. No initial conversation shall be held with an employee who is the subject of a third-party complaint without the employee's immediate supervisor present.

ARTICLE VI - RIGHTS OF THE PARTIES

A. Management Rights and Privileges

The Board reserves to itself sole jurisdiction and authority over matters of policy and retains the right, subject only to the limitations imposed by the language of this agreement, in accordance with applicable laws and regulations

1. to direct employees of the school district;
2. to hire, promote, transfer, assign and retain employees in positions in the school district, and, to suspend, demote, discharge or take other disciplinary action against employees;
3. to relieve employees from duty because of lack of work or for other legitimate reasons;
4. to maintain efficiency of the school district operations entrusted to them;
5. to determine the methods, means and personnel by which such operations are to be conducted; and
6. to take whatever actions may be necessary to carry out the mission of the school district in situations of emergency.

B. Employee Rights

No employee shall be arbitrarily discharged. As used in this provision, "arbitrary" shall mean without sufficient reason. Any such action shall be subject to the grievance procedure set forth in Article III for those employees who are not entitled to an alternative statutory appeal process.

ARTICLE VII - EMPLOYEE/ADMINISTRATION LIAISON

The Association President and the Chief School Administrator shall have the opportunity to meet monthly at a mutually convenient time to discuss current problems and practices of mutual interest and concern if such a meeting is requested by either party.

It is clearly understood that these representatives are not to be construed in any way as a negotiating team and are without the power to modify the current agreement.

ARTICLE VIII - WORK YEAR - NON-TRANSPORTATION

- A. The work year for ten (10) month employees listed below shall consist of 185 days according to the adopted school calendar between September 1st and June 30th.

Educational Assistants

- B. The work year for all ten (10) month secretaries shall begin September 1st and conclude June 30th with holidays as outlined in ARTICLE XVIII - VACATION DAYS, Section B.
- C. The work year for twelve (12) month employees listed below shall be in accordance with the adopted school calendar between July 1st and June 30th.

ARTICLE IX - WORK HOURS

A. **Work Hours**

1. **Custodians**

Work hours shall be eight (8) consecutive hours per day including a thirty (30) minute duty free lunch or supper period. Lunch or supper shall be eaten and breaks taken on the job site to which the employee has been assigned. Work hours will be determined by the Custodial Supervisor as approved by the School Business Administrator in accordance with the needs of the district and include no "clean up" time at the beginning or ending of the workday. Work days will be Monday through Friday or Saturday through Wednesday. Employees hired before July 1, 2016 will not be involuntarily assigned to this shift. Saturday-Wednesday shift would take place beginning October 1st of the school year through March 11th of the school year. April 1st through September 30th staff would be assigned to the Monday through Friday 3-11 shift.

Employees assigned to the Saturday through Wednesday shifts will work the hours as follows during the October-March time period:

Saturday and Sunday;	8:00am – 4:00pm
Monday, Tuesday, and Wednesday	3:00pm – 11:00pm
Thursday and Friday	Off

Any hours above 40 per week would be overtime.

This shift is not anticipated to be needed at every school implementation

Practice: see addendum #3

a. Shift reassignment:

In the event a chief custodian is reassigned from night shift to the day shift, he/she shall be given an additional shift differential of \$7.50 during 2002-03, \$7.75 during 2003-04, and \$8.00 during 2004-05 for each day assigned.

2. **Computer Technicians/Computer Technician Trainer/Courier/Graphics Technician**

a. Computer Technicians, Computer Technician Trainer and Graphics Technician/Secretary work hours shall be eight (8) hours per day including a thirty (30) minute duty free lunch period, a fifteen (15) minute break in the morning and a fifteen (15) minute break in the afternoon. Work hours will be determined by the appropriate supervisor or his/her designee as approved by the Assistant Superintendent.

b. The Courier work hours shall not exceed eight (8) hours per day, including a thirty (30) minute duty free lunch period if the work day exceeds five (5) hours. Compensation shall be at the hourly rate, as calculated from the salary on the miscellaneous guide, for hours approved by the appropriate supervisor or his/her designee as determined by the Assistant Superintendent.

3. **Educational Assistants**

Work hours shall be seven (7) hours (including a thirty (30) minute duty free lunch period and two fifteen (15) minutes breaks to be scheduled in coordination with the teacher and principal. Educational Assistants shall sign in and out at the main office or other designated area of their school building each time they arrive at and depart from the building. The district may extend the workday of any Educational Assistant by $\frac{1}{4}$ hour for any school year or portion of a school year based on the needs of the district. Educational Assistants whose day is extended will be compensated for the additional time based on the educational assistant's per diem rate. This $\frac{1}{4}$ hour will first be staffed by volunteers. If an insufficient number of volunteer Educational Assistants is available, this time will be filled by Educational Assistants assigned by the principal. The selection of the Educational Assistant will be the sole decision of the principal. Educational Assistants will receive two (2) weeks' notice prior to the beginning or ending of such a workday increase.

a. Confirm current practice of Educational Assistants performing ten (10) hours of in-service on their own time after hours with no compensation in lieu of two (2) in-service days which shall be added to 183 days for a total work year not to exceed 185 days.

4. **Secretaries**

Work hours shall be seven (7) hours (including a fifteen (15) minute break in the morning and a fifteen (15) minute break in the afternoon, excluding a thirty (30) minute duty free lunch period).

5. **Mechanics/Bus Driver**

Work hours shall be eight (8) hours per day excluding a thirty (30) minute duty free lunch period. Hours will be determined by the Supervisor of Transportation.

6. **Maintenance Workers/HVACR Specialist/Electrician/Painter/Heavy Equipment Operator**

a. **Day**

The day shift shall consist of eight (8) consecutive work hours between the hours of 6:00 a.m. and 6:00 p.m., Monday through Friday, hours to be established by the Director of Buildings and Grounds as approved by the School Business Administrator, exclusive of a thirty (30) minute lunch period, but including a ten (10) minute clean-up period and two (2) fifteen (15) minute breaks which must be taken at the worksite (building) at which the employee is assigned at the time the break occurs. The School Business Administrator shall not arbitrarily change said work hours with representatives of the Association and shall notify the Association within two (2) calendar days of any proposed change in work hours.

b. **Night**

The night shift shall consist of eight (8) consecutive work hours between 2:30 p.m. and 12:00 a.m., Monday through Friday, exclusive of a thirty (30) minute supper period, but including a ten (10) minute clean-up period and two (2) fifteen (15) minute breaks which must be taken at the worksite (building) at which the employee is assigned at the time the break occurs.

c. **Shift Reassignment**

In the event a Maintenance Worker/HVACR Specialist/Electrician is reassigned from the day shift to the night shift, he/she shall be given one week notice except in the event of an emergency. Effective July 1, 1996, employees so reassigned will receive an additional five (5) percent shift differential for each day assigned. Schedule changes on days when students are not in attendance shall not be considered a shift change.

B. **Overtime**

1. **Bus Drivers/Black Seal Custodians/Chief Custodians/Custodians/Maintenance Workers/HVACR Specialist/Courier/Mechanic/Van Attendants/Electrician**

All hours over forty (40) hours per week shall be considered overtime. The overtime rate of pay shall be 1-1/2 x basic hourly salary. The basic hourly salary shall be computed as salary divided by 52 weeks divided by 40. Any employee asked to work on paid holiday shall be paid 1-1/2 x basic pay above his/her regular salary.

Each employee shall be guaranteed a minimum of two (2) hours recall when necessary plus travel time not to exceed one (1) hour each way.
Maintenance employees shall mark their availability for overtime on a daily basis.

2. Educational Assistant/Secretaries/Computer Technicians/ Graphics Technician

All hours over forty (40) hours per week shall be considered overtime. The overtime rate of pay shall be 1-1/2 x basic hourly salary. The basic hourly salary shall be computed as salary divided by 52 weeks for twelve-month employees; 43 weeks for ten-month employees divided by 35.

C. Inclement Weather

The following essential personnel are required to work on inclement weather days when schools are closed, have a delayed opening, or have an early dismissal: black seal custodians, custodians, chief custodians, maintenance workers, electricians, and HVAC specialists.

When there is a delayed opening Secretarial Staff must report to work one (1) hour before the students. Those individuals may utilize a vacation day (12 month employees only) or a personal day if they feel they cannot report to work, or they may make up the time or have a deduction for the time not worked. Time must be made up by the end of the next full pay period, in minimum blocks of thirty (30) minutes with the dates and times attached to the payroll report and signed by the administrator. Secretaries may utilize thirty (30) minutes of their lunch/break time as make up time beginning with the day of the event, provided that a thirty (30) minute lunch period remains on any day they make up time. The Chief School Administrator may at his/her discretion extend the period for makeup time when frequent closing/delays occur.

Bus drivers and van attendants will not report to work during inclement weather when schools are closed.

D. Mandated Training

All employees who are directed to participate in mandated training/professional development shall be compensated at the employee's regular rate of pay for each hour. The district will schedule the training and its location. If training cannot be scheduled during the regular work day for transportation and/or custodial employees it will be scheduled immediately before or after the regular work day at the regular rate of pay or the OT rate if applicable. Payment for mandated training shall be submitted to the Board for approval at the Board meeting occurs no later than six (6) weeks after the training is completed by the employee.

E. Drug Testing

Any time a member is required to submit to on premises drug testing beyond his/her scheduled work hours, the member shall receive a flat fee of fifteen dollars (\$15.00).

ARTICLE X - ASSIGNMENTS, REASSIGNMENTS AND PROMOTIONS

- A. Employees who desire a change in assignment or transfer may file a written statement of such desire with the Chief School Administrator not later than April 15. Such statement shall include the position(s) to which the employee desires to be assigned and the school or schools to which he/she desires to be transferred, in order of preference. The best interest of the school system, the job requirements and the wishes of the individual employee shall be considered in the determination of requests for voluntary reassignment and/or transfer.
- B. No later than June 15 of each school year, or one (1) week before the last day of the school year for students, the Director of Personnel shall post in all work sites a list of known vacancies and those which are anticipated for the following school year. "Work sites" are defined as schools, environmental service office, bus port, community education center, senior center and student services office. A copy of known vacancies will be forwarded by electronic mail to the President of the Association at the time of posting.
- C. Recruitment: Vacancies in the school system will be made known to the staff as they arise. Staff members may apply for any open position and applications for transfers to new or vacant positions will be considered in light of their qualifications and the needs of the school district. Staff members who apply and meet the basic job qualifications will be granted an interview.
 - 1. When school is in session, notices of vacancies will be posted within four (4) days, in each work site, with a copy forwarded to the Association President, following the regular Board of Education meeting in which the vacancies were determined.
 - 2. Notice of vacancy will include job area, school, effective date and procedure for applying including salary and job description.
 - 3. During summer months, notice of vacancy will be posted as in (1) and (2) above.
- D. **Involuntary Transfer and Reassignments**
 - 1. Notice of an involuntary transfer or reassignment shall be given to the employee, in writing, at least ten (10) working days prior to transfer or reassignment. A copy of all transfers will be forwarded to the Association President.
 - 2. Wherever possible, no vacancy shall be filled by means of an involuntary transfer or reassignment if there is a volunteer available and qualified in the judgment of the Board to fill said position.

ARTICLE XI - EMPLOYEE EVALUATION

A. **Frequency**

Employees shall be evaluated by their immediate supervisors at least one (1) time in each school year, to be followed in each instance by a written evaluation report. Educational Assistants will be evaluated by the school administration. Employees shall receive their final evaluation no later than May 15th of each year of this agreement.

B. **General Criteria**

1. **Open Evaluation**

All monitoring or observation of the work performance of an employee shall be conducted openly and with full knowledge of the employee. The use of eavesdropping, public address, cameras, audio systems, and similar surveillance devices shall be strictly prohibited.

2. **Copies of Evaluation**

An employee shall be given a copy of any visit or evaluation report prepared by his/her evaluators at least one (1) day before any conference to discuss it. No evaluation shall be submitted to the central office, placed in the employee's file or otherwise acted upon without a conference between the supervisor and the employee if either individual requests one. No employee shall be required to sign a blank evaluation form. Within ten (10) calendar days of signing the evaluation, an employee may submit a written response to the evaluation. This written response shall be attached to all copies of the evaluation.

C. **Personnel Records**

1. **File**

An employee shall have the right, upon request, to review the contents of his/her personnel file and to receive copies at Board expense of any documents contained therein. The review shall be scheduled within two (2) workdays of the request. An employee shall be entitled to have a representative(s) of the Association accompanies him/her during such review. At least once every year, an employee shall have the right to indicate those documents and/or other materials in his/her file which he/she believes to be obsolete or otherwise inappropriate to retain.

Said documents shall be reviewed by the Chief School Administrator or his/her designee and if, in fact, they are obsolete or otherwise inappropriate to retain, they shall be destroyed.

2. **Derogatory Material**

No material derogatory to an employee's conduct, service, character or personality shall be placed in his/her personnel file unless the employee has had an opportunity to review the material. The employee shall acknowledge that he/she has had the opportunity to review such material by affixing his/her signature to the copy to be filed with the express understanding that such signature in no way indicates agreement with the contents thereof. The employee shall also have the

right to submit a written answer to such material and his/her answer shall be reviewed by the Chief School Administrator or his/her designee and attached to the file copy.

3. No Separate File

Although the Board agrees to protect the confidentiality of personal references, and other similar documents, it shall not establish any separate personnel file which is not available for the employee's inspection.

D. Non-Renewal, Termination, Suspension, Reduction

1. A written notice of non-renewal shall be given to each employee not offered employment on or before June 15. A copy shall be forwarded to the Association President.

2. Employees shall not be reduced in rank, suspended, terminated or have their employment increment withheld without written notice from the Chief School Administrator.

An employee who receives a notice non-renewal or reduction in rank, suspension, termination, or employment increment being withheld may, within five (5) working days thereafter, request a statement in writing of reasons for such action from the Chief School Administrator which statement shall be given to the employee in writing within five (5) working days after receipt of such request.

3. Informal Appearance

The employee who has requested the written statement may make a request in writing, within five (5) days of receipt of the statement, for an informal appearance before the Board.

Within twenty (20) days after receipt of a request, the Board or committee of the Board will meet with the employee.

The purpose of granting an informal appearance before the Board to the employee is to provide an opportunity to dissuade the Board from its action. The informal appearance before the Board is not to be an adversary proceeding.

The employee may be represented by an individual of his/her choice before the Board and may present witnesses on his/her behalf.

4. Board Determination

The Board shall issue its written determination as to the employment or non-employment of said non-tenured employee for the next succeeding school year within five (5) days after the next regular meeting of the Board of Education. Said proceedings shall be completed and the Board's determination presented to the employee no later than August 15 for those terminated as of June 30.

E. Termination/Resignation

1. A terminated employee, except one terminated for good cause as defined in Article VI of this Agreement shall receive two (2) weeks' notice of termination or two (2) weeks' pay in lieu of notice, plus accumulated vacation pay, if applicable, based

on the proportion of full months worked in the contract year. This provision, however, shall not apply to probationary employees during their first sixty (60) physical days of employment.

2. An employee who is resigning from his/her position shall give the normal two (2) weeks' notice.
3. If the full two (2) weeks' notice is not given, by an employee is resigning from his/her position, vacation, if applicable, shall be paid only in the same proportion as the amount of notice actually given. For this purpose, ten (10) full working days shall be used in calculating the amount of notice given by the employee.
4. Full unused vacation shall be paid to an employee resigning from his/her position, unless proper notice has not been given. All such vacation time shall be paid at the salary rate currently in effect except that employees whose employment terminates at the end of a contract year shall be paid at the rate in effect during that contract year.

ARTICLE XII - SALARY POLICY

A. Method of Payment

1. **Twelve (12) Month**
Twelve (12) month employees shall be paid in twenty-four (24) semi-monthly installments.
2. **Ten (10) Month**
Ten (10) month employees shall be paid their base salary in twenty (20) equal semi-monthly installments. Base pay for bus drivers and van attendants will be the work hours assigned for each of the 181 days during the contract year times the hourly rate. Other runs such as field trips, PE programs, or any other runs lasting less than 180 days are excluded from the base pay computations but may be assigned during the base salary work hours with no additional compensation. Paychecks for bus drivers and van attendants shall indicate number of regular hours worked, number of overtime hours, as well as the information already included.
3. **Exceptions**
When a pay day falls on or during a school holiday, school vacation, or weekend, employees shall receive their paychecks on the last previous working day.
When a pay day falls during an employee's vacation, the employee may request his/her paycheck on the last previous working day. Such request must be received by the business office at least ten (10) working days prior to the date the check is requested.
4. **Electronic Deposit**
Electronic deposit of paychecks shall be made to the bank of the employee's choice.

There shall be no early issuance of checks except in special hardship cases as determined by the Chief School Administrator on a case-by-case basis. Hardship exceptions cannot be granted for employees electing direct deposit of their pay.

5. **Final Pay**

Each employee shall receive his/her final pay and the pay schedule for the following year on his/her last working day in June.

ARTICLE XIII - SALARIES/REIMBURSEMENTS

- A. Effective the 2007-2008 school year, the “square footage” adjustments for Chief Custodians will be revised to reflect the school renovations, and the stipend amounts will be adjusted to the figures listed below:

B. **Miscellaneous**

1. An employee who works during the summer months shall be paid an hourly rate equivalent to his/her current contract according to the salary guide effective July 1st of the same year. In no case shall the rate of pay be less than the employee's own regular rate unless the employee has requested to perform extra work during the summer in a different job title, in which case the pay rate for that title shall be applicable.

C. **Black Seal Boiler License**

1. Maintenance personnel and chief custodians who hold a black seal boiler license shall receive a stipend of seven hundred dollars (\$700) in addition to his/her salary. Effective July 1, 2006, the stipend will be \$750. Effective July 1, 2007, the stipend will increase to \$800 per year.
2. All custodians who hold a black seal boiler license, except chief custodians, shall be placed on the appropriate step of the Black Seal Custodian Salary Guide;

however, no additional stipend shall be granted to those placed on said Black Seal Guide.

- D. Heavy Equipment Operator approved by the administration receives a stipend of two thousand five hundred dollars (\$2500.00) per year in addition to his/her salary.
- E. Asbestos removal certified unit members who are approved by the administration for asbestos removal shall receive a stipend as follows in addition to his/her salary. Individuals who receive this stipend will be required to work overtime to perform the related duties required by the stipend, if there are no volunteers. Such involuntary assignments will be made on a rotating basis among members who receive such stipends.

Annual asbestos stipends are as follows:

Holder of Operations and Maintenance License	\$1800.(as per the 2002-05 contract)
Holder of Operations and Maintenance License, and Floor Tile Removal License and Supervisor of Floor Tile License	\$2500.
Holder of Floor Tile Removal License	\$1800.
Holder of Floor Tile Removal License and Supervisor of Floor Tile License	\$2000.

- F. Assistant Pool Operator certified unit members approved by the administration and assigned to a building with a pool shall receive a stipend of one thousand three hundred dollars (\$1300) per year in addition to his/her salary. Any member of the bargaining unit assigned to maintain the chemical balance of the pool shall be reimbursed one thousand dollars (\$1000) per year in addition to his/her salary.

G. Longevity

- 1. During each year of this agreement, the Board of Education will pay a longevity stipend to individuals who have completed at least fifteen (15) years of employment in the East Windsor Regional School District.
- 2. For the purposes of longevity calculations the following provisions will apply:
 - a. A year is defined as at least five (5) months of active service in the school year for ten-month employees and at least six (6) months of active service in the school year for twelve-month employees.
 - b. Time spent as a substitute or as a permanent employee on an unpaid leave of absence will not be credited toward seniority.
 - c. Resignation/termination eliminates all years of service accrued for longevity purposes except that individuals terminated due to a reduction in force who are rehired from the eligibility list will retain all previous years of service.

3. Longevity stipend - \$1000 for fifteen (15); \$1200 for twenty four (24) years of completed service as of June 30.

- H. Chief Custodians – who are absent no more than four (4) days may “sell back” unused sick days according to the following schedule, provided such payment is in compliance with State law or regulation:

- I. Lead Abatement removal certified unit members who are approved by the administration shall receive a stipend of twelve hundred and fifty dollars (\$1250.00) in addition to his/her salary. Individuals who receive this stipend will be required to work overtime to perform the related duties required by the stipend, if there are no volunteers. Such involuntary assignments will be made on a rotating basis among members who receive such stipends.

J. **Professional Improvement**

Employees are eligible for tuition reimbursement for professional improvement courses provided that

1. Courses are related or beneficial to the employee's current field of work or another position within the school district.
2. Courses must be approved in advance by the Chief School Administrator or his designee.
3. Courses must be successfully completed (where grades are provided, a grade of “B” or higher must be attained).
4. Unless there are unexpended funds available at the end of the contract year, not more than nine (9) credits or the equivalent of three (3) courses per year shall be reimbursed to a maximum amount not to exceed the prevailing College of New Jersey rate for a three credit course. Requests for reimbursement and proof of successful completion of courses are to be submitted to the Office of the Director of Personnel.
5. The total amount available for tuition reimbursement for the entire unit in any contract year shall be \$4250; unexpended funds shall not carry over to the next contract year. Effective July 1, 2006, the total amount available for tuition reimbursement shall be increased to \$5,500. If in 2006-2007 the entire \$5,500 is expended, the amount available for 2007-2008 shall be increased to \$6,500.

6. Prior to the end of each school year, a joint committee of the Association and the School Administration will meet to discuss in-service programs for the next year. The Superintendent shall designate the Administration representative(s) and the Association leadership shall select its committee designees.

ARTICLE XIV - EMPLOYMENT PROCEDURES

A. Reemployment

By June 15, if possible, of each year, the Board shall give to each employee covered by this agreement a written offer of employment for the next succeeding contract year with such changes in salary and benefits as may be required by law or agreement between the Board and the Association.

B. Placement on Salary Schedule

1. New employees shall be placed on step one (1) of the salary guide except that credit may be given on the salary guide for experience in a related field. No one will be hired with a placement higher than step 5 of the salary guide regardless of his/her years of credited service.
2. Paraprofessionals - Clerical
 - a. The following positions that were called Paraprofessional-Clerical in previous agreements are now classified as 10-month Secretaries:
 - All para clerks working in nurses offices in all the schools
 - Any and all para clerks working outside the classroom in clerk positions will now be classified as 10-month secretaries
 - High school house offices paraprofessionals who work for an administrator
 - Middle school paraprofessionals who report to an assistant principal
 - Guidance office paraprofessionals
3. Any movement between job classifications as indicated below will result in salary guide placement as follows:

EDUCATIONAL ASSISTANT TO TEN-MONTH SECRETARY

Advance the Educational Assistant one step on his/her existing guide and then increase that rate by 12.5% to adjust for the longer work day (half hour more per day) and the longer work year (approximately 10 days per year); then place that employee on the ten-month secretary guide at a salary that most closely approximates the educational assistant's adjusted salary, but in no case will the person be placed on the maximum step.

EDUCATIONAL ASSISTANT TO SECRETARY

Advance the Educational Assistant one step on his/her existing guide and then increase that rate by 33% to adjust for a longer work day (half hour more per day) and the longer work year (43 more days: i.e., 243 day work year less 15

vacation days less 185 day Educational Assistant work year); then place that employee on the secretary guide at one (1) step lower than the adjusted salary, but in no case will the person be placed on the maximum step.

C. **Adjustment to Salary Schedule**

Twelve-month employees who work less than six (6) months and ten-month employees who work less than five (5) months in a school year will remain on the same salary step for the subsequent contract year except in the case of employees promoted/transferred in accordance with section B3 above who will be advanced a step on the guide. Time on unpaid leave of absence does not count as months worked.

D. **Substitutes**

1. Any district custodian who serves as a temporary maintenance worker shall be compensated on the first step of the maintenance salary guide effective on his first day in the position.
 - a. A temporary maintenance worker shall have the same work hours as permanent maintenance workers, inclusive of non-paid lunch.
 - b. A temporary maintenance worker is eligible for overtime on equal standing as all maintenance workers. There shall be no eligibility for custodial overtime while in the substitute position.
 - c. A temporary maintenance position shall be for no longer than twelve (12) consecutive months due to the same absence. After eleven (11) consecutive months the district shall meet with EWRSSA to assess the need for the temporary position past the initial twelve (12) months.
 - d. All other terms and conditions of the collective bargaining agreement shall remain the same.
2. The Board retains the right to assign substitute drivers/van attendants as needed. No driver or van attendant shall be assigned secretarial work outside his/her regular work hours, even if under doctor's order to do light duty.
3. Substitutes will only be used in replacement of a permanent staffed position on a temporary basis. Notice of use of substitutes and positions shall be sent to the Association President on the 20th day.

E. **Probationary Period**

A probationary period of 60 physical work days is permitted to ascertain the employment suitability of persons being hired. By the end of the 60-day probation period, a formal written decision on continuation of regular employment must be delivered to the probationary worker. During the 60-day period, the probationary worker will be paid regular wages and will receive benefits. Employees, other than transportation employees who successfully complete the probationary period, shall be reimbursed by the Board for the cost of fingerprinting/background checks. (See Article XXII Section C.2.c. for transportation reimbursement.) The Board's decision to discontinue the employment of

a probationary employee shall not be subject to arbitration but shall be subject to the grievance procedure.

F. Temporary Positions

1. Temporary positions in Grounds/Maintenance may be created by the Board of Education for the grass growing season, April 1st through December 31st only.
2. Temporary positions in Transportation may be created during July and August.
3. Individuals in temporary positions shall be paid substitute wages and receive no benefits.
4. Temporary positions, including summer temporary help, shall be posted as in 1 and 2 above. Unit member applicants shall be given priority over non-unit member applicants for all temporary summer positions.
5. Summer secretarial positions, including secretarial/office positions at transportation, shall be staffed from the approved clerical substitute list.
6. Any Black Seal Custodian who is Board approved and assumes the duties of the Chief Custodian in his/her absence, shall be compensated on the Chief Custodian's pay guide at a step that is equivalent to his/her current salary as a Black Seal Custodian, plus the building square footage, after twenty (20) consecutive days in the position of Chief, retroactive to the first day. In no case shall the rate of pay be less than the employee's regular salary.

- a. All other terms and conditions of the collective bargaining agreement shall remain the same.

ARTICLE XV - REDUCTION IN FORCE

- A. In the event of a reduction in force, the decision of what educational programs or support areas will be retained will be made by the Chief School Administrator based on district need.
- B. In the case of secretaries, reduction in force will be in accordance with N.J.S.A. 18A:17-2 and the tenure provisions contained therein.

C. Seniority

In the event of any reduction in force (RIF) within a job category, employees shall be laid off in reverse order of seniority determined as follows:

1. Effective July 1, 2009, school district seniority for new hires is defined as service by regularly employed employees in the school district in the collective bargaining unit covered by this agreement upon successful completion of three (3) years of service with the District following which seniority shall be retroactive to the start date of employment as herein defined. For those members covered by this

agreement who were hired into this bargaining unit prior to January 1, 2006, school district seniority shall be based upon the length of continuous service from initial month of employment under this unit's contract with the District. For those employees hired after January 1, 2006, seniority will be assigned at the time of Board approval based on the date and time the employee's application was received in the Personnel Department.

2. Seniority for all regularly employed full and part-time employees in a category shall be determined according to the date employed by the Board in that category; except that bus drivers/van attendants shall be placed on a seniority list in the order of appointment by the Board and after having been employed one week as a regular bus driver/van attendant.
3. Employees on an approved leave of absence without pay will be given credit for past experience in this district (seniority and salary) upon his/her return to work. A leave of absence without pay does not count toward seniority.
4. An employee may accrue seniority rights only in categories in which they have been employed. Employees promoted from one category to another continue to accrue seniority in their previous category(ies).
5. Effective September 1, 2001, for the purpose of seniority, there will be three (3) separate Educational Assistant categories: Paraprofessional-Classroom and Paraprofessional-Bilingual. Educational Assistants hired on or after July 1, 1995, or the effective date on which the new categories were established, will be hired as either Paraprofessional-Classroom, or Bilingual and will accrue seniority rights only in the category in which he/she actually performed service to the district.
6. Seniority shall be terminated only in the event of dismissal or resignation from the district. Individuals, who were in a position represented by EWRSSA, accepted a different position not represented by EWRSSA, and are RIFFED from that position or request and are granted reassignment to a position represented by EWRSSA, shall have prior seniority restored. No seniority shall be accrued during any period of suspension without pay. However, any employee who has been absolved and/or has their pay reinstated shall also have their seniority restored for that period.
7. Paraprofessionals hired before July 1, 1995, shall retain all prior seniority credit and shall continue to accrue credit through additional service. They shall be maintained on a single seniority list entitled "Pre 1995 Paraprofessionals". These Educational Assistants shall be permitted to move between clerical and classroom assignments subject to the following conditions:
 - If an Educational Assistant moves from one assignment to another (i.e., clerical to classroom), the Educational Assistant must complete training for the new assignment. The training shall not exceed 18 hours. The Educational Assistant shall not receive compensation for such training and shall undertake it on his/her own time. Sessions comprising this program shall be no longer than three hours in duration and occur no more than two nights per week.

8. In the use of seniority reduction, the employee(s) affected by such a reduction will be the most junior employee(s) within his/her current category of employment (as listed in the salary guide). Those employees thus affected who have accrued seniority in another category would maintain the same rights in replacing a less senior employee in his/her next previous category of employment.
9. If any full-time and/or part-time employee shall be dismissed as a result of a reduction in employees by the Board for any reason, such employees shall be noted on a preferred eligible list in the order of seniority for a period of three (3) years from date of dismissal for the purpose of reemployment whenever a vacancy occurs in a similar job category from which the employee was dismissed. Employees currently on layoff are grandfathered.
10. If any full-time and/or part-time employee listed on the eligible seniority list for reemployment refuses an offer for reemployment by the Board and/or fails to report to work within fifteen (15) calendar days, the employee shall forfeit his/her seniority for reemployment by the Board and be removed from the eligible list.

ARTICLE XVI – LEAVE OF ABSENCE

A. **Leaves without Pay**

1. **Other**

Leaves of absence without pay for good causes may be approved or rejected upon written application to the Chief School Administrator. Such application is to be received by the Chief School Administrator thirty (30) days prior to the commencement date of the requested leave. In emergency situations, in which thirty (30) days' notice would not be possible, the request must be submitted in writing for the approval or disapproval of the Chief School Administrator and would be subject to the concurrence of the Board in writing.

During leaves without pay, employees who wish to continue insurance coverage may do so at their own expense.

2. **Child Care, Maternity, Paternity, or Adoption**

An employee may request, in writing to the Chief School Administrator, a leave of absence without pay for child care, maternity, paternity, or adoption, for a period of not more than one (1) employee work year. A leave for child care, maternity, paternity, or adoption shall, on application, be granted for a period through the balance of the employee work year in which the leave commences. Requests for extensions shall be submitted to the Chief School Administrator and shall be approved or disapproved at the option of the Board on a case-by-case basis.

- a. This leave of absence may exist for one (1) employee work year and up to one (1) full year's extension thereafter until the beginning of the next employee work year. At this time, the employee must return or officially resign the position.

- b. This leave of absence may be shortened upon written request to the Chief School Administrator and Board of Education for approval. This approval will be based upon the staffing needs of the district at the time of request and the satisfactory assurance that the employee is again able to devote full time to his/her position.
- c. Employees on this leave of absence may be employed as regular substitutes in the district any time following the birth or adoption of the child upon written request to the Chief School Administrator and approval of the Board of Education.

B. Leaves with Pay

During the first year of employment, all leaves with pay, with exception of days for jury duty or subpoena by court and military leaves of absence shall be prorated to the nearest half-day according to the percent of the employee's work year under contract.

1. Personal Illness Days

The Board agrees to provide the employees with fourteen (14) days per year at full pay for personal illness if employed 12 months of the year; and twelve (12) days per year at full pay for personal illness if employed 10 months of the year. Unused days may be accumulated for use in subsequent years. Transportation department employees only: The Board agrees to provide ten (10) personal illness days for ten month employees and twelve (12) personal illness days for 12 month employees.

N.J.S.A. 18A:30-6. Prolonged absence beyond sick leave period. When absence, under the circumstances described in section N.J.S.A. 18A:30-1 of this article, exceeds the annual sick leave and the accumulated sick leave, the Board of Education may pay any such person each day's salary less the pay of a substitute, if a substitute is employed or the estimated cost of the employment of a substitute if none is employed, to a maximum of twelve (12) days for twelve-month employees and ten (10) days for ten-month employees; but in no case less than half pay except transportation department employees who will have the full amount of the substitute or the projected cost deducted.

For transportation department employees only: The Chief School Administrator or his designee will review all such requests for additional days and approve or reject them on a case-by-case basis. Denials of requests are not subject to the grievance procedures.

In accordance with N.J.S.A. 18A:30-4, the employee may be required to provide a doctor's certificate for any absence for which sick leave is claimed.

A sick day for bus drivers/van attendants shall be the work hours assigned for each of the 181 workdays. (Runs such as field trips, PE programs, or any others lasting less than 180 days are excluded from the base pay computations.)

Employees shall be given a written accounting of accumulated sick leave days no later than the last day of September in each school year.

2. **Illness in the Immediate Family Days**

The Board agrees to provide the employees with three (3) days per year at full pay for illness in the immediate family (father, mother, husband, wife, brother, sister, child, civil union/domestic partner, mother-in-law, father-in-law and immediate household).

The Board further agrees (determined on an individual basis) that, after all such illness in the immediate family days as indicated in the preceding paragraph are exhausted, an additional seven (7) days per year may be provided at the employee's rate of pay less substitute pay, but in no case less than half pay for the employee.

An absence because of an illness in the immediate family which exceeds ten (10) days per year may be granted by the Chief School Administrator at full deduction in pay.

All unused illness in the immediate family days as of June 30th of each year shall be cumulative as personal illness days except that no more than fifteen (15) days shall be carried over as personal illness days.

In accordance with practice established by the former Superintendent, the parties acknowledge that the Superintendent may request, and East Windsor Regional Supportive Staff Association ("EWRSSA") unit members shall provide written verification of the circumstances surrounding a leave of absence due to family illness before or after a school holiday or other school closing.

In the event that the Superintendent discerns a pattern of absences before or after a school holiday or other school closing in the case of a particular employee, the Superintendent may request further documentation reasonably likely to establish the legitimacy of absence, including, but not limited to, written verification of illness from the family member's physician.

3. **Bereavement Leave**

- a. The Board agrees to provide all unit employees with bereavement leave as set forth herein below. It is understood that the "days" specified shall be per event and at full pay.

Category 1 (immediate family) - five (5) day entitlement:

Mother, father, husband, wife, child, brother, sister, mother-in-law, father-in-law, son-in-law, daughter-in-law, step-mother, step-father, step-child, step-brother, step-sister, or other members of the immediate household;

Category 2 - three (3) day entitlement:

Grandparents, grandchildren, step-grandparents, step-grandchildren, brother-in-law, sister-in-law;

Category 3 (other family members) - one (1) day entitlement:

Uncles, aunts, cousins, nieces, and nephews.

- b. After all such death in the immediate family days are exhausted, the Board agrees that additional days may be granted by the Chief School Administrator at full deduction in pay.
- c. After the death in other than the immediate family day is exhausted, the Board agrees that additional days may be granted by the Chief School Administrator at full deduction in pay.

4. **Marriage Days**

The Board agrees to provide employees with three (3) days per year at full pay for marriage. After such marriage days are exhausted, the Board agrees that additional days may be granted by the Chief School Administrator at full deduction in pay.

5. **Days for Jury Duty or Subpoena by Court**

The Board agrees to provide an employee full pay for each day that the employee's presence in court is required by subpoena. The Board further agrees to provide an employee full pay for each full day that the employee is required to be in court for jury duty. The Board will not provide reimbursement for an employee whose absence is due to a legal action taken by the employee against the Board or administration. An employee is still entitled to use other appropriate leave days for a subpoena or court appearance.

The Board of Education will reimburse employees, at the employee's rate of pay in effect, for time incurred after working hours for required appearances in court for a work related incident.

6. **Days for Other Reasons**

Effective the 2007-2008 school year, the Board shall provide three (3) days leave of absence with pay per year for religious, legal business, household or family matters which require absence during school hours. Application to the Chief School Administrator for days for other reasons shall be made within two (2) days of the requested day except in cases of emergency. The Chief School Administrator reserves the right to require additional information regarding the reason prior to making his/her decision to approve or reject the request. Days for other reasons may not be used on the day before or after a holiday or any scheduled school closing.

Commencing July 1, 2007, all unused days for other reasons as of June 30 of each year shall be accumulated as personal illness days except that no more than fifteen (15) days shall be carried over as personal illness days.

7. **Military Leaves of Absence**

Military leaves of absence will be granted in accordance with federal and state statutes governing such leaves.

ARTICLE XVII - PAYMENT FOR ACCUMULATED UNUSED SICK LEAVE

- A. Effective July 1, 1988, any supportive staff employee who retires according to the provisions of the P.E.R.S. in order to receive immediate benefits as opposed to "deferred" benefits and has either twenty (20) continuous years of employment service in the East Windsor School District or has twelve (12) continuous years of service in the East Windsor Regional School District and reaches the minimum age of sixty (60) upon the employee's effective date of retirement shall be eligible for payment for unused sick leave, provided such payment is in compliance with State law or regulation.
- B. In order to receive prompt payment, supportive staff employees must notify the Chief School Administrator no later than December 1 of the year preceding the effective date of retirement.
- Those who comply with the December 1 notification requirement and retire between December 1 and the following June 30 after notification, shall receive said payment on or about July 1 following the effective date of retirement.
 - Those who comply with the December 1 notification and retire after the following July 1 shall receive said payment thirty (30) days after the effective date of retirement.
 - Those who fail to provide notification by December 1 but retire between December 1 and June 30 shall receive said payment on the second July 1 following notification.
 - Those who fail to provide notification by December 1 but retire between July 1 and December 1 shall receive said payment on or about the July 1 following retirement.
- C. Payment for a retiring supportive staff employee, as Defined in Section A, herein above, will be based on one-half (1/2) – i.e. two (2) for one (1) – of all the employee's accumulated days in accordance with the schedule set forth below. Effective July 1, 2020, the maximum individual payment will increase to three thousand five hundred (\$3,500) dollars.
- Twenty-two and one-half dollars (\$22.50) per accumulated sick day for one-half (1/2) of all days up to and including fifty (50) days.
 - Twenty-seven and one-half dollars (\$27.50) per accumulated sick day for one-half (1/2) of all days beyond fifty (50) days.

ARTICLE XVIII - VACATION DAYS

(Excluding: Bus Drivers, Educational Assistants, 10-month Secretaries, and Van Attendants)

- A. The Board agrees to provide full-time contracted twelve-month employees vacation days each budget year (July 1 through June 30) according to the following schedule, which becomes effective July 1, 2007:

1	During the first budget year of employment, vacation days are earned at the rate of one and a quarter (1¼) per month to a maximum of fifteen (15). During this year only, vacation days may be used as earned.	15 days per year*
2	Two (2) years to ten (10) years as a 12-month employee	15 days per year
3	Eleven (11) years to twenty (20) years as a 12-month employee	20 days per year
4	Twenty-one years or more as a 12-month employee	25 days per year

* Vacation days are earned on the 15th day of each month.

Any ten (10) month employee who accepts a twelve (12) month position shall receive full credit on the vacation guide for years served in the District.

Effective July 1, 2016, 10-month Secretaries will be entitled to up to five (5) vacation days per school year that may be taken only when students are not in school, excluding the two (2) days immediately before the first day of school and the two (2) days immediately after the last day of school in June. These days may not be taken any other time of the year and unused days do not accumulate. Vacation days must be requested electronically and scheduled with the principal's/supervisor's permission.

Use of Vacation Days:

During the first budget year of employment, vacation days are earned at the rate of one and a quarter (1¼) per month to a maximum of fifteen (15). During this year only, vacation days may be used as earned.

Employees starting on or before January 15th will receive fifteen (15) vacation days on the following July 1st. Employees starting after January 15th will continue to accrue vacation days at one and a quarter (1 ¼) per month until July 1st of the following year.

Vacation days must be electronically entered and scheduled with the principal's/supervisor's permission. During a vacation period, a leave of illnesses for more than three consecutive days, which are verified by a physician in writing, may be granted by the Chief School Administrator.

Effective July 1, 2007, employees may "bank" eight (8) days to be used in the budget year following the year they should have been used. Such days must be used at the discretion of the supervisor during that following budget year. Employees must notify the Personnel Office by June 30 of the intent to bank days.

B. Holidays

1. The Board agrees to an eighteen (18) day holiday schedule according to the school calendar for twelve-month employees. These days are to be determined by the

Chief School Administrator after the school calendar has been adopted by the Board of Education.

2. The Board agrees that ten-month clerks will receive as holidays those holidays designated for twelve-month employees which occur during the ten-month employee's work year, and including those days listed as winter and spring vacation from September 1 to June 30.

ARTICLE XIX - DEDUCTION FROM SALARY

- A. The Board of Education agrees to make all individually authorized payroll deductions in accordance with Chapter 233, Laws of 1969, N.J.S.A. 52:14-15, 9e.
- B. **Annuities**
The Board provides the employees with an opportunity to select and join an insurance program for the purpose of participating in a tax deferred annuity.
- C. **Agency Shop**
 1. **Purpose of Fee**
If an employee does not become a member of the Association during any year (i.e., from July 1 to the following June 30) which is covered by this agreement, said employee will be required to pay a representation fee to the Association for that year. The representation fee will be deducted, prospective only, beginning July 1, 1982. The purpose of this fee will be to offset the employee's per capita cost of services rendered by the Association as majority representative.
 2. **Fee Notification**
Prior to the beginning of each membership year, the Association will notify the Board, in writing, of the amount of the regular membership dues, initiation fees and assessments charged by the Association to its members for that membership year. The Association will certify to the Board prior to the start of each membership year that the amount of the representation fee to be assessed does not exceed 85% of dues, fees and assessments that are expended toward the cost of benefits available only to members of the majority representative.
 3. **Fee for Part-Time Employees**
Employees who are employed on a part-time work schedule equal to at least 50% time and who choose not to become Association members will pay the representation fee. Employees who are employed less than 50% time will not be required to pay the fee.
 4. **Fee for Those Employed After the Start of the School Year**
Employees who are employed after the beginning of the regular contract year who choose not to become members shall be required to pay a representation fee on a prorated basis.

5. **Demand and Return System**

The Association will submit to the Board proof of the establishment and maintenance of a demand and return system through which non-members may appeal the amount of the representation fee.

Furthermore, the Association agrees to make all non-Association members aware of their legal rights of appeal and of the procedures available for such an appeal. The Association recognizes that no representation fee may legally be deducted until after the Board has received evidence of the establishment and maintenance of the demand and return system.

6. **Non-Member Notification**

Once during each membership year covered by this agreement, the Association will submit to the Board a list of those employees who have not become members of the Association for the then current membership year. The Board will deduct from the salaries of such employees the appropriate representation fee and promptly will transmit the amount so deducted to the Association.

7. **Indemnification**

The Association shall indemnify and hold the Board harmless against any and all claims, demands, suits and other forms of liability, except for counsel fees and other legal costs and expenses that may arise out of or by reason of any action taken or not taken by the Board in conformance with this provision.

8. **Payroll Deduction Schedule**

The Board will deduct the representation fee in equal installments, as nearly as possible, from the paychecks paid to each employee on the aforesaid list during the remainder of the membership year in question. The deductions will begin with the first paycheck paid thirty (30) days after receipt of the aforesaid list by the Board.

9. **Mechanics**

Except as otherwise provided in this Article, the mechanics for the deduction of representation fees and the transmission of such fees to the Association will, as nearly as possible, be the same as those used for the deduction and transmission of regular membership dues to the Association.

10. **New Employees**

On or about the last day of each month, beginning with the month this agreement becomes effective, the Board will submit to the Association, a list of all employees who began their employment in a bargaining unit position during the preceding thirty (30) day period. This list will include names, job titles, and dates of employment for all such employees.

- D. The Association will secure the signatures of its members on the Automatic Payroll Deduction Forms and deliver the signed forms to the Board (School Business Administrator).

- E. The Association shall indemnify, defend and save the Board harmless against any and all claims, demands, suits or other forms of liability that shall arise out of or by reason of action taken by the Board in reliance upon salary deduction authorization cards submitted by the Association to the Board (School Business Administrator).

ARTICLE XX - INSURANCE PROTECTION

A. **Injury Insurance**

The Board maintains, at Board expense, insurance coverage for these employees for all injuries occurring in the performance of their duties and which are promptly reported to the employee's immediate superior.

B. **Health Insurance (Other than Transportation)**

The Board maintains at Board expense, subject to employee contributions per ***Chapter 78**, and in accordance with terms that follow, group health insurance coverage for staff and dependents as follows:

Hospitalization plan, a medical plan, a major medical plan, a prescription plan, and a dental plan. When an employee and an employee's spouse/partner are both employed in the school district only one member of the family will be permitted to enroll in more than "employee only" coverage.

1. Major Medical Deductible: \$100 per individual/\$200 per family per calendar year;
2. Hospital admittance deductible of \$100 per person, \$200 per family per calendar year.
3. Lifetime Maximum: two million dollars
4. Prescription Plan: Co-payment: \$10 for generic drugs and \$30 for name brand drugs \$10 for generic mail order-90 day supply and \$30 for brand name mail order-90 day supply.
5. Major Medical Coinsurance: 80/20
6. CIGNA PPO dental plan has a \$75 (seventy-five) deductible for employee only and \$150 (one hundred fifty) for other tiers as listed above. DHMO plan has no deductibles.

Effective July 1, 2020, employment payments towards health benefits shall be as follows:

The Board shall offer seven (7) plans:

Equivalent Plan to New Jersey Educators Health Plan (NJEHP)

All employees eligible for health benefits shall receive the following stipends:

- C. In the event of any change in the contracted insurance carrier or carriers, the employee shall be guaranteed coverage of benefits equal to or better than the present contract.
- D. At any time during the term of the contract, the Board of Education may change health insurance coverage to the New Jersey State Health Benefits Plan.
- E. Effective July 1, 2016 the Aetna PPO plan is removed from this agreement. The current Aetna POS is available.

OPT OUT PROVISION

An employee who provides proof of other insurance (for the employee or spouse) and opts out of group health insurance coverage shall be entitled to a payment as stated below for each year coverage is waived for any of the following tiers:

Employee child(ren)	\$3,900
Employee Spouse	\$6,400
Employee Family	\$7,400

The Opt-Out Plan allows an employee to change his/her election under certain special circumstances.

Employees hired after the date of the May 14, 2021, Memorandum of Agreement shall not be eligible for the opt out provision.

Transportation Employees

The Board maintains employee only coverage at Board expense subject to employee contributions per ***Chapter 78 or 44** and in accordance with terms that follow, group health insurance coverage for staff and dependents as follows: hospitalization plan, a medical plan, a major medical plan, a prescription plan, a dental plan. and a coordination of benefits provision for married couples who are both employees of the East Windsor Regional School District.

1. Dependent coverage may be obtained at an additional cost. To be eligible for dependent coverage, the employee must have individual coverage through the district.
2. The Board will contribute 50% of premium cost for dependent coverage for transportation employees only who work twenty (20) hours or more per week.
3. The Opt-Out feature for this group will be applied as follows: The Board will pay the opting out employee 25% of the single coverage premium and, if applicable, 25% of the Board's 30% contribution toward dependent coverage premium.
4. Health insurance will become effective the first (1st) of the month following thirty (30) days of contracted employment.

C. Liability Insurance

The Board shall maintain, at Board expense, a liability policy which affords personal liability and legal expense protection for the employees up to \$100,000 per year per employee (to a maximum for all employees of \$1,000,000 per year) as regards action of the employee in the course of his/her work.

****Chapter 78 (P.L. 2011) Health Benefits Reform governs employee's contributions toward health care. The percentage rate of contribution is determined based on the employee's annual salary and the selected level of coverage. The increased employee contributions will be phased in over a 4-year period with a minimum contribution required to be at least 1.5% of salary.***

ARTICLE XXI - MISCELLANEOUS

- A. Whenever any notice is required to be given by either party to this agreement to the other, pursuant to the provision(s) of this agreement, either party shall do so in writing with acknowledgment.

- B. The Board and the Association agree to share equally in the cost of reproducing this agreement as arranged.
- C. All custodians, maintenance workers, mechanic/bus driver, HVACR specialists, electrician, painters, and head mechanic shall be provided with Five (5) full uniforms each year. To be ordered no later than September 30th.
- D. All Transportation employees will be provided with a windbreaker with insignia.
- E. The Board will provide rain slickers to the Educational Assistants who are required to work outside; however, the slickers must remain at the schools. Maintenance personnel, mechanic/bus driver, custodians, and chief custodians who have successfully completed their probationary period and who are assigned to work in extreme weather conditions such as snow shall be given an initial clothing allowance of two hundred and twenty dollars (\$220) effective July 1, 2016, in the first year of employment. A separate check and one hundred and sixty dollars (\$160) per year effective January 1, 2016, each year thereafter toward the purchase of "foul weather gear" which shall become the personal property of the employee. Said clothing allowance shall be paid on or about December 15th each year.
- F. A committee comprised of Assistant Superintendent, School Business Administrator/ Board Secretary, Supervisor of Transportation, the Association President, and representatives from Transportation staff will meet and discuss issues related to the Transportation Procedures Manual.
- G. All employees who are issued uniform and/or jackets must report for duty wearing the issued clothing. Transportation employees must wear flat, sturdy shoes that are suitable for driving.

ARTICLE XXII - TRANSPORTATION EMPLOYEES

A. **WORK YEAR**

The standard work year for school bus drivers and van attendants shall consist of 180 days between September 1st and June 30th, based on the EWRSD school calendar. One (1) additional day with pay for employee orientation will be scheduled in advance during the week prior to the official opening of school. At the beginning of the school year, each employee shall be given a calendar or work days for the year.

School bus drivers and attendants who pick an out-of-district run will additionally follow the work day schedule of the out-of-district calendar on days when the EWRSD schools are closed. Drivers and attendants will be paid for contracted hours at the regular rate

of pay for the added days of work, which will result in a work year greater than 180 days. The calendar for each out-of-district run may be provided at the time the run is picked.

All required hours should be contracted hours. If employees are required to come in to work, employees will be paid for the day. Contracts will be for the total number of calendar days.

B. WORK HOURS

1. Bus Drivers/Van Attendants

Hours shall be as established by the Supervisor of Transportation. A minimum of four (4) hours per day is guaranteed.

2. All hours over forty (40) hours per week shall be considered overtime. The overtime rate of pay shall be 1.5 times the basic hourly rate

a. Cancellations

(1) If a field trip or athletic trip is scheduled on other than a regular workday and is not canceled within two hours of the start of the trip, the driver shall be paid for two hours work at his/her rate of pay.

(2) Bus drivers covering field trips or athletic trips shall be paid from the time they sign in until the time they sign-out at the completion of the trip and they shall not lose pay for layover time.

b. Notification of absence or tardiness

In all cases of absences or lateness, the Supervisor of Transportation or designee shall be notified by 6:00 a.m. or one (1) hour prior to the driver's first run, whichever is earlier, so that necessary arrangements can be made; supervisor's phone number or designee will be posted. If a driver/attendant fails to notify the office that he/she is going to be late and the route is covered by another driver at start time, the driver will be sent home and docked pay. Requests to be excused are to be directed to the Chief School Administrator who will accept or reject them and determine whether or not there is to be a loss of pay.

- c. Athletic trips will be paid a minimum of two (2) hours' time.

C. FITNESS FOR DUTY

1. Medical Examinations (Bus Drivers/Van Attendants)

- a Regular and substitute drivers shall have a pre-employment medical examination as arranged by the Supervisor of Transportation and provided by the school district physician, or the applicant may be examined by his/her personal physician as prescribed by N.J.S.A. 18A:16-2.5. Van Attendants shall have pre-employment and annual medical examinations arranged by the Supervisor of Transportation and provided by the District to certify that they are physically able to perform the essential functions of the job. All pre-employment and annual medical examinations shall certify that the employee

is physically able to perform the essential functions of the job. The employee and the association shall receive a copy of the essential functions prior to the exam.

- b. The full cost of the license renewal medical examination shall be borne by the school district if the employee elects to utilize the services of the school physician. The Board shall pay the full cost of the pre-employment medical examination which shall be conducted by the school physician.

2. **Bus Drivers License**

- a. N.J.A.C. 6:21-11.1 is quoted in part ". . . to be eligible for employment as a school bus driver every applicant shall possess a valid bus driver's license approved by the Department of Law and Public Safety, Division of Motor Vehicles."
- b. Each driver shall be responsible to maintain and update his/her bus driver's license at his/her expense.
- c. Transportation employees will be reimbursed thirty-five dollars (\$35) for cost of fingerprinting.

D. **BUS DRIVER ASSIGNMENTS**

1. Runs and packages will be established by the Supervisor of Transportation according to the best interests of the school district and its students. By August 20th of each year, two copies of job packages including a description of runs and times shall be posted in the Transportation Department. Job packages shall be defined as including a.m. and p.m. runs. An am run is one that normally starts between the hours of 6am and 9am, whereas a pm run is one that normally starts between the hours of 1pm and 4pm. The total daily job packages excluding mid-day runs shall be rounded to the next higher quarter hours. A mid-day run is one that normal starts between the hours of 9am and 1pm. A regular run package shall be for a minimum of three and one-half (3.5) hours. However, the needs of the District may occasionally require the creation of a job package of less than four (4) hours or the pairing of a mid-day run with an am and/or pm run to create a package equal to the minimum three and one half (3 ½) hours.. In addition to the job package, all drivers shall be paid for a fifteen (15) minute bus pre-check and a fifteen (15) minute bus cleanup period per day. Runs and routes may be changed or reassigned at the discretion of management provided that the number of hours assigned to a driver, or pay, is not reduced. A late run is scheduled for every student day with a specific pick up time and location. All late runs will be a minimum of one and one half (1.5) hours each. A driver may choose to incorporate a late run into their regular run package (D 1.) A late run shall be included in "Leave with Pay" (Article XVI B).
 - a. A driver will not be asked to punch out for a layover created by a temporary change in a drivers normal; work schedule of less than forty five (45) minutes.
2. All drivers shall be responsible for fueling their vehicle.

3. Each bus driver shall be paid to complete a dry run and attend a safety meeting within ten (10) business days prior to the opening of school. The dry run will begin at approximately the scheduled run time. The total dry run and meeting will be compensated at the regular rate of pay. The date for the dry run and pick run shall be posted prior to the end of the school year.
4. Bus drivers requested to "pick up" a bus from a garage for repairs, etc. on other than a regular workday, shall be paid at the driver's regular hourly rate for the time worked.
5. Job packages may have additional runs added. Additional pay will not start until the driver is working more than (4) hours per day.
6. In the event that there are new runs added or other runs that become vacant during the course of the work year, the most senior drivers shall have the opportunity to take the new run or other run, if his/her schedule makes performance of the run possible. Vacancies shall not result in lateral changes of schedule. All temporary routes will be promptly posted as vacant upon notification that the driver of that run will not be returning to work. A temporary route is defined as a vacancy due to personal illness, worker compensation, personal leave or family leave.
7. A driver's job package may not exceed seven and a three quarter (7 $\frac{3}{4}$) hours including a fifteen (15) minute bus pre-check and fifteen (15) minutes bus cleanup period per day. A driver's final adjusted schedule may not normally exceed eight (8) hours. Should the adjusted schedule exceed eight (8) hours at any point during the year, the District reserves the right to require that the driver change the mid-day or late portion of his/her run so that overtime is not incurred and without reduction in compensation.
8. Any job package that increases by more than fifteen (15) minutes for more than fifteen (15) consecutive days shall be considered a change in the job package and shall be posted for bid.
9. Additional runs and extra work may be assigned during the layover time for which the driver is being paid.
10. The Transportation Supervisor shall have the right to temporarily transfer bus drivers to meet emergencies and other unusual requirements, with no reduction in pay.
11. All job packages which become vacant during the work year must be posted for five (5) consecutive work days on the designated Association bulletin board. The job posting shall include the description of runs and times and effective date for filling the vacancy. The most senior bus driver who applies to the Transportation Supervisor for the vacancy shall be transferred to that vacancy. All interested drivers may then select the just vacated position in seniority order. This procedure will be repeated one time. The vacancy created by the third selection will be filled by a new contractual employee for the remainder of the school year. Lateral transfer will not be permitted.

12. If a run is cancelled because the students are not going in on any given day, the driver shall be notified and given an alternate assignment for the day. Such assignment must fall within the realm of the driver's normal work assignment and hours.
13. A driver who does not work his/her regular run due to absence shall not be eligible for extra work on that day including field trips and athletic trips. For the purposes of this paragraph only, an employee is prevented from performing his/her regular run due to attendance at court-summoned jury duty shall not be considered "absent."
14. The Supervisor of Transportation will establish which driver will be assigned to each run in accordance with current policies and this agreement.
15. New runs and permanent vacancies will be filled throughout the year based upon the seniority of qualified bidders.
16. A temporary vacancy may only last for thirty (30) working days. At the end of thirty (30) working days that run must be posted for rebid. After 30 days a temporary vacancy will be posted as such. When the initial driver returns the temporary replacement driver will go back to the route he/she left. A copy of all temporary vacancies will be sent to the Association President and Personnel Department.
17. The driver seniority lists will be developed in accordance to seniority procedures in Article XV C of this agreement. Driver seniority lists shall be updated as needed, maintained and posted by the Supervisor of Transportation with a copy sent to the President. The Supervisor of Transportation is required to inform, in writing, the Association President of any changes on the list and once runs are awarded the pick sheet will be posted on the Bulletin Board for employee's review. This list will be made available for review. This list will contain the following information.
 - a. One list shall consist of all night and weekend drivers.
 - b. The second list will consist of all regular drivers on the seniority list who are available between East Windsor School hours.

Once a driver has been assigned a trip, he/she will not be assigned extra work until the list has been run through and his/her name has come to the top again. If the driver cannot run the trip, he/she shall notify the Supervisor of transportation at least 48 hours prior to the trip (except in the event of an emergency) in order that the supervisor may offer the trip to the next driver on the list. Employees presently on light duty (verified with notes from physicians) will not be eligible for any of these trips.

18. Whenever possible, the Supervisor of Transportation will advise a driver(s) of a field trip at least twenty-four (24) hours in advance.

19. All special runs, including trips and athletics, shall be offered to available bus drivers on a rotating basis as per the revised Transportation Department trip procedures.
20. Transportation office is responsible for providing drivers with approved trip destination directions no later than 24 hours in advance of assigned trip.
21. Prior to a trip, the Supervisor of Transportation or her designee shall provide to the driver(s) assigned:
 - a. a detailed itinerary of the trip assigned;
 - b. recommended route to follow;
 - c. sufficient monies to cover all tolls, parking fees and miscellaneous expenses anticipated;
 - d. all necessary information to obtain assistance in the event of an emergency.
22. Summer bus driving/van attendant assignments, when required, will be allocated by the Supervisor of Transportation on the basis of seniority. Payment for summer work will be at the driver's/van attendant's proper step on the salary guide for the upcoming school year.
23. All extra work is to be offered first to regular employees based on seniority and availability, using the entire seniority list until exhausted, to those qualified, available and willing to do the work. The list is to be expanded to cover employees up to seven (7) hours, but not if assignment would create overtime.

E. CALCULATION OF TIME

Absence for $\frac{1}{2}$ or less of the employee's base hours shall be deemed a half day. Absence for more than $\frac{1}{2}$ the employee's base hours shall be deemed a full day's absence.

F. SALARY PLACEMENT

1. Credit shall be given to new bus drivers for prior experience in bus or other equivalent driving. The equivalency of experience will be determined by the Board. Newly hired drivers shall be placed on the salary guide step based on actual years of experience. No one will be hired at a salary higher than an in district employee with equivalent or greater years of credited experience. Credit shall only be given for the time actually worked as a driver.
2. Five calendar months or more experience in a school year will constitute credit for one full year experience on the salary guide. A calendar month shall be interpreted as all school days within a month, regardless of the number of hours driven per day. This credit shall apply to rate of pay only of all new employees.

3. Newly hired drivers who do not possess a valid CDL shall be placed on the “trainee” step of the salary guide for a period of six (6) months after acquisition of the CDL. The trainee step shall be equal to the substitute driver rate plus one half (1/2) the difference between the substitute driver rate and the first step on the bus driver guide for that year. Upon successful completion of the six (6) month period, the employee’s salary shall be adjusted to Step 1 of the guide, retroactive to the initial date of service.
4. All drivers will be given the opportunity to be trained for air brake endorsement. Seniority will be used to determine the employee who will be trained first.
5. Effective July 1, 2007, the position of Mechanic/Bus Driver shall be paid according to the Maintenance Mechanic salary guide.

G. EXTRA POSITIONS AND ASSIGNMENTS

1. The position of Driver Trainer/School bus Safety Instructor shall be a posted position. A description of duties will be available with the posting. The Driver Trainer/School Bus Safety Instructor shall be compensated at the driver’s regular rate of pay. There will be no pay for pre-training training.
2. The position of Mechanics Helper shall be a posted position. A description of duties will be available with the posting. The Mechanics Helper shall be compensated at the driver’s regular rate of pay. There will be no pay for pre-training training.
3. The foregoing position will be posted and bid for the period of July 1 – June 30 of each school year.
4. Other extra work that is assigned outside the driver’s regular hours shall be paid at a posted rate, not the driver’s regular rate and shall be assigned by management according to seniority and proof of physical ability. It will be first offered to transportation employees, then will be open to other unit members and then may be opened to non-district employees.
5. If sufficient volunteers for snow removal are not found in transportation, then snow removal will be open to other unit members and then may be opened to non-district employees.

H. SELL BACK OF UNUSED SICK DAYS

Drivers/Van Attendants - who are absent no more than four (4) days, may “sell back” unused sick days according to the following schedule, provided such payment is in compliance with State law or regulation:

<u>Days Absent</u>	<u>Sell Back</u>	<u>\$ Per day</u>
0	5	\$ 60
1	4	\$ 50
2	3	\$ 50
3	2	\$ 50
4	1	\$ 50

For the purposes of the sell back, an absence is non-attendance at work for any reason other than personal days. Absence due to a work related injury/illness is considered absence for the purposes of the sell back.

BOOKEEPER

Effective July 1, 2016, the position of Bookkeeper shall be placed on the Secretary II salary guide.

As long as the individual in the position remains in the position it will be reflected as an off guide position.

The salary increase for this off guide step will be reflected in the negotiated salary guides.

There shall be three Secretarial levels:

Secretary I	(10 and 12 month)
Secretary II	(10 and 12 month)
Secretary III	(12 month)

All current clerks shall be either a Secretary I or Secretary II (Addendum I)

There shall be a \$1000 increase applied to the 2015-2016 clerk base for the Secretary II differential. This shall be the 2015-2016 Secretary II base for the purpose of negotiated salary compensation.

All current Secretaries shall be a Secretary III.

Effective date of Tentative Agreement:

All attached tentative are effective July 1, 2019.

ARTICLE XXIII - DURATION

The Board and the Association agree that all negotiable items have been discussed during the negotiations leading to this agreement and that no additional negotiations on this agreement will be conducted on any item, whether contained herein or not through the life of this agreement, which has a term of July 1, 2019, through June 30, 2022. If a successor agreement has not been ratified by the termination date of this agreement, this agreement will remain in full force and effect until such time as a successor agreement has been ratified.
