In Grecio vs. Borough of Haddon Heights 449 (N.J. You may contact the GRC by toll-free telephone at 866-850-0511, by mail at P.O. Box 819, Trenton, NJ, 08625, by email at grc@dca.state.nj.us, or at their website at www.state.nj.us/grc. The GRC can also answer other questions about the law. All questions regarding complaints filed in Superior Court should be directed to the Court Clerk in your County. If you should have any questions regarding the case, please feel free to contact this law enforcement agency.

Subsequent to a shoplifting investigation at Macy's the defendant, Joann Brower, was placed under arrest for shoplifting \$1,015.45 worth of merchandise.
