Hi Ron, The township committee and DPW are deciding how to do the install (township committee member Michael Misertino and town clerk, Dena Hrebenak). When we wrote the grant, we had priced it to have DPW do most of the prep and install work to keep the price down and have asphalt delivered. They will need to rent/borrow a roller. If they decide to have a contractor do any part of the install, it would have to go out to bid for anything that is not a professional (attorney, engineer) service for any amounts over \$1,800. Bids are awarded to the lowest qualified bid. The grant was \$24,000 with a minimum 20% match - we estimated that the township would spend about \$42,000 in out of pockets and labor.

If you think he would still be interested, I can get more information sent your way once I get an update.

Please see below the announcement concerning the release of Green Acres funding. Given the Tennis/Basketball courts by the Recreation Building have been a subject of conversation since 2010 or longer, I wanted to alert you to this grant opportunity that can be specifically applied to the Green Acres property controlled by Mansfield Township. The deadline to participate is February 15, 2017.

This Green Acres parcel, as you know, is functionally obsolete as it stands. While the Township approved the process for submitting a change of use letter to Green Acres to move this from Tennis/Basketball courts to a Community Garden, the Environmental Commission has decided not to pursue the Community Garden at this location given that other neighbor municipalities offer garden plots to non-residents and have had a difficult time meeting capacity rental goals to make the community gardens self-sufficient financially.

Note that the EDAC team will be piloting a survey/polling questionnaire regarding Amenities/Communications within the Township- this was presented to Township Committee by Betsy Griggs. We hope to have your input and share the results of the questionnaire to support whatever the proposed restoration project will be to ensure that the Green Acres can be reintroduced for safe public use.

Green Acres Program Funding

The Christie Administration is making \$67.4 million in Department of Environmental Protection Green Acres program funding available for open space, recreation and stewardship projects across the state, Commissioner Bob Martin announced on 11-22-16.

The Green Acres program is accepting applications immediately from municipalities, counties and nonprofit groups for grants and loans for land acquisitions, park development and stewardship projects. Green Acres funding allows governments and nonprofits to leverage millions of additional preservation dollars through matching federal, state, county and local funds, as well as from private sources. In addition to providing recreational opportunities, Green Acres projects help protect water quality and stimulate economic development by creating jobs. This makes cities and towns more attractive places to live and work.

The Green Acres program will evaluate the applications and prepare a recommended list of awards for presentation to the Garden State Preservation Trust for approval. Funds awarded to governments and organizations can be used for a wide variety of projects, such as preservation of nature preserves and wildlife habitats, creation of urban waterfront parks and greenways, and development of athletic fields and playgrounds.

For the first time, the Green Acres program will also accept applications for land stewardship activities. Land stewardship is defined as an activity that goes beyond routine maintenance to restore and enhance lands for recreational and conservation purposes.

Together with public and private partners, the Green Acres program has directly protected more than 680,000 acres – or more than 1,060 square miles. The program has also funded hundreds of recreational areas that provide a wide range of activities, including city parks, playgrounds, athletic fields, boat ramps, docks, fishing piers, natural areas and environmental education.

A study by Penn State University concluded that investments in parks and recreational services have a positive effect on health and fitness and may result in less strain on the health care system. Studies also demonstrate that people are more likely to be more physically active if they live close to parks and recreational sites. As such, the New Jersey Department of Health has included DEP in implementing the Governor's Population Health Challenge, calling for state agencies to work collaboratively to promote health in policymaking.

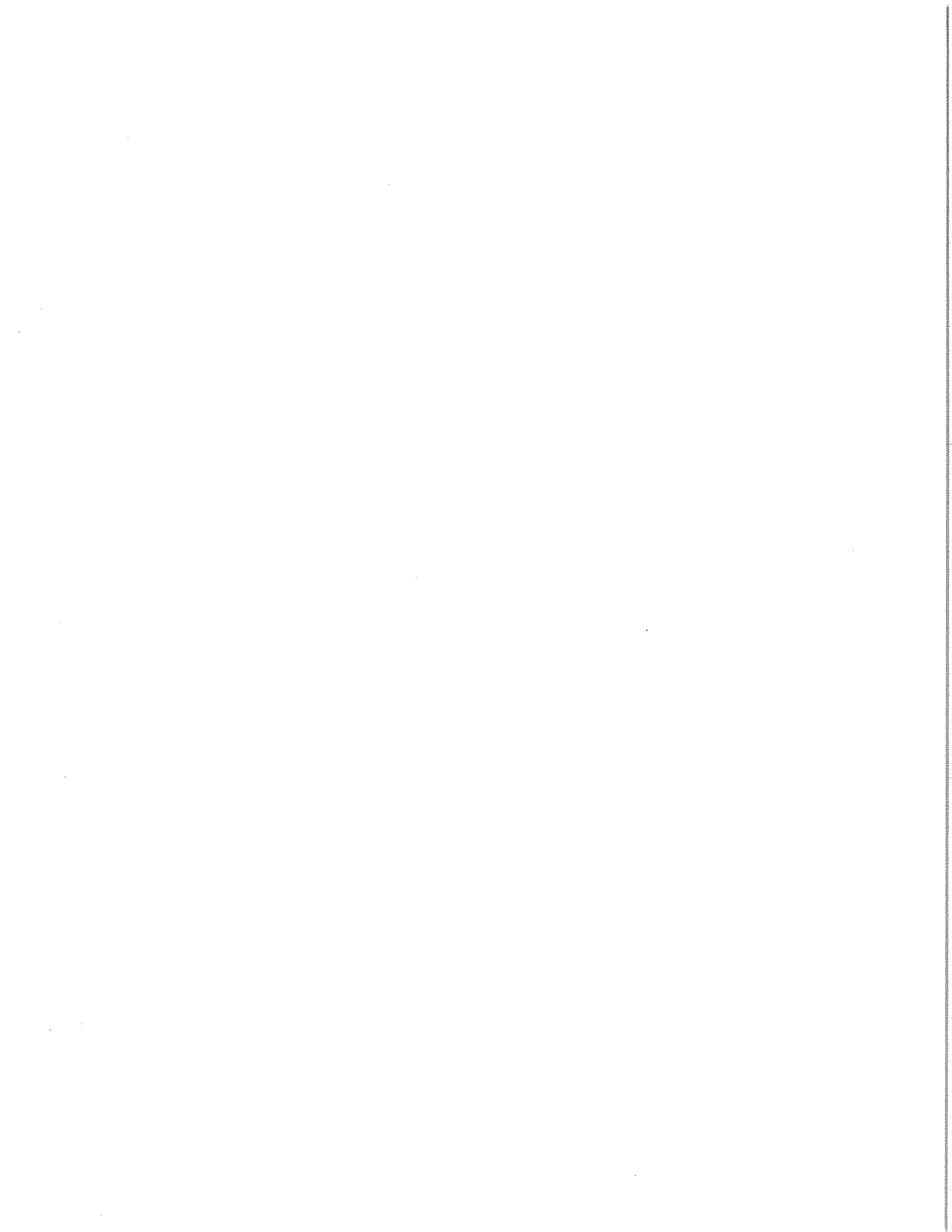

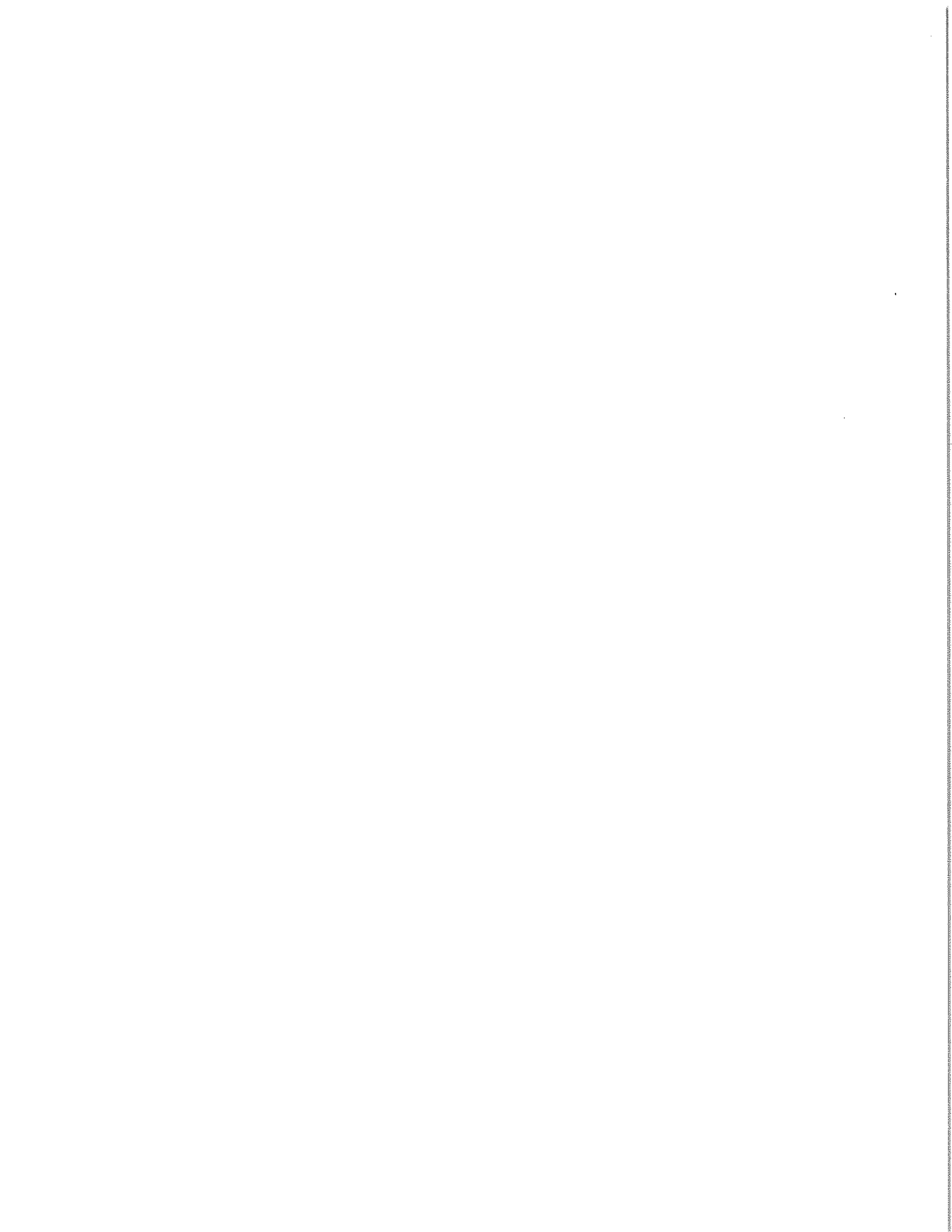

Dear EDAC Team,

I came across an article about a Shop Local program that incentivizes residents to shop local to earn property tax credits and or rebates (renters).

In light of Shirley's ideas for a coupon book and my concern during our last regular meeting about upkeep and having someone dedicated to entering online coupons, etc. This program seems to take care of that approach and allows for direct contact with enrollees/residents about how the participating businesses are supporting the community in other ways. Tax credits are earned via "discounts/coupons" offered by businesses that are established when they sign up to participate. Those discounts get deposited into the property tax card program and then deposited into the individual tax accounts annually.

The role that EDAC would play would be in recruiting businesses to participate and possibly doing a tax newsletter insert mailing the cards to property tax owners and promoting the program through media channels that we control as well as press releases/PSAs.

When we were working on splitting up our walk around list of businesses, it occurred to me that the great majority of the businesses in town are service/retail/restaurant related and this may be just the kind of program that could help attract other businesses to Mansfield and minimize our vacancies.

Please review and let me know what you think. We could include a short presentation about this program to those that participate in the Business Roundtable to get their feedback on pros/cons and interest in participation.

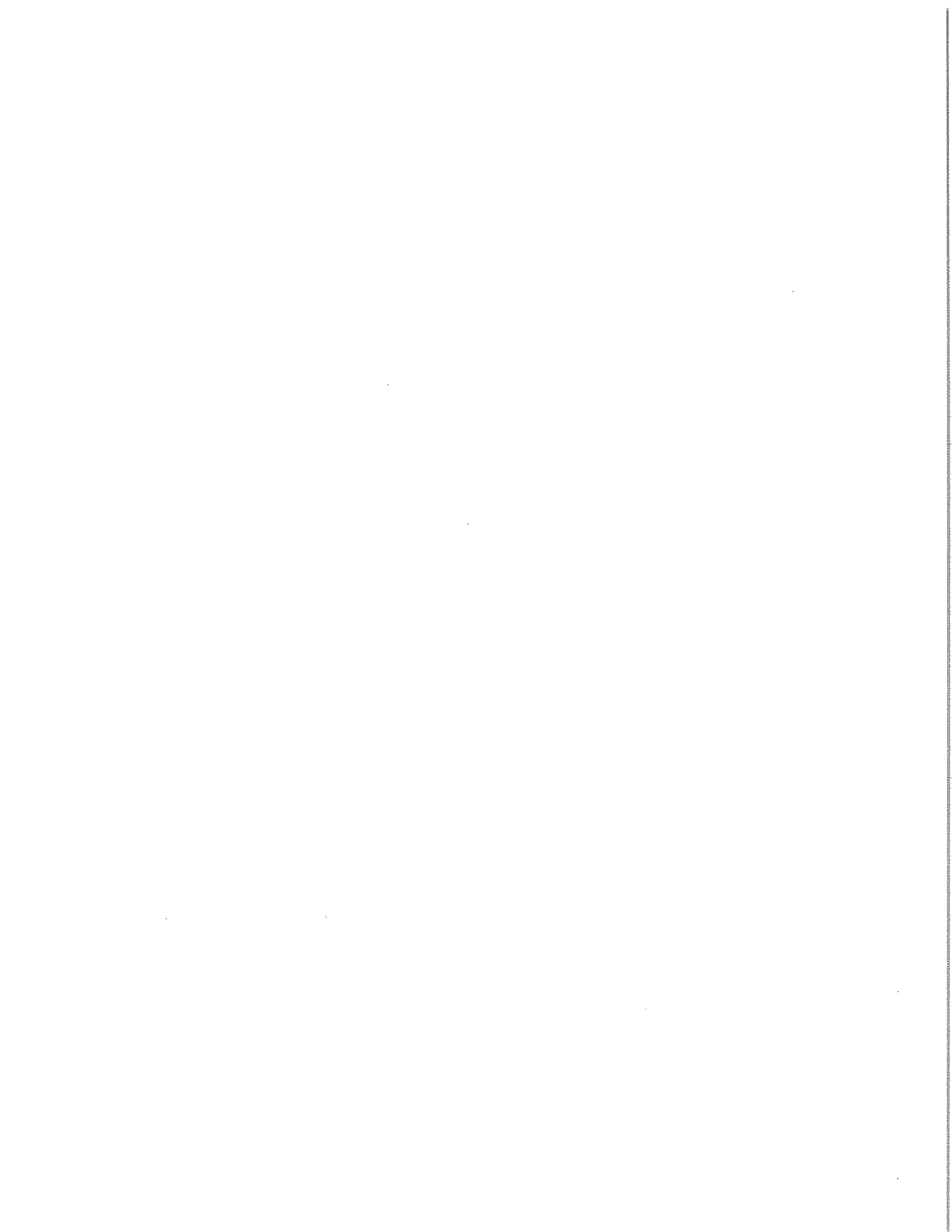

Mr. Onderko,

I learned last night at the Township Committee meeting that you cancelled your first Mansfield Township EDAC meeting as EDAC Chairperson scheduled on February 1, 2017 due to lack of a "quorum."

I would like to inform you that Mayor Watters appointed an additional member to EDAC during the Township Committee meeting on January 25, 2017 bringing membership to four which is a quorum. Additionally, the ordinance does not require a quorum for the Advisory Council meetings. The Advisory Council is just that, an advisory council to provide advice and provide recommendations to the Township Committee. Specifically, the "Advisory Council shall collect information on opportunities for commercial and industrial business and investment in Mansfield Township. The Advisory Council shall prepare and distribute pamphlets explaining opportunities in the Township and outlining Township regulations affecting businesses; subject to the prior approval of the Mansfield Township Committee."

I also learned that you have already postponed the business roundtable scheduled on the EDAC Workshop date in February and that the joint meeting with the Warren County EDC scheduled will no longer be a joint Mansfield/Warren County Economic Development meeting as originally planned and scheduled, but just a change in venue for the Warren County EDC to hold their regular meeting at the Mansfield Township municipal building.

Further, it was also stated that the survey that was developed for Mansfield Township residents would not be deployed to the community until a quorum on Mansfield Township EDAC existed. It is not necessary to have a quorum to deploy the survey. It was already recommended to and approved by the Township Committee in 2016. This is also a moot delay reason as a quorum does indeed exist.

The above illustrates progress has ceased on the Mansfield Township EDAC. The 2017 plan is already off schedule and communication between the Mayor and Township Committee and EDAC is lacking.

As per the ordinance, the Mayor is a member of the Mansfield Township EDAC. I am disappointed to hear that Mayor Watters did not communicate to you, the EDAC Chairperson, the additional appointment on January 25, 2017. This further demonstrates his lack of commitment to the Mansfield Township Economic and Development Advisory Council. For the record, another person was appointed during last night's Township Committee meeting. I would highly recommend Mayor Watters attend the Mansfield Township EDAC meetings as he is a member of the Council, you attend the Township Committee meetings, you attend the Township Committee meeting audio and listen to it or you debrief with the Mayor after the meetings.

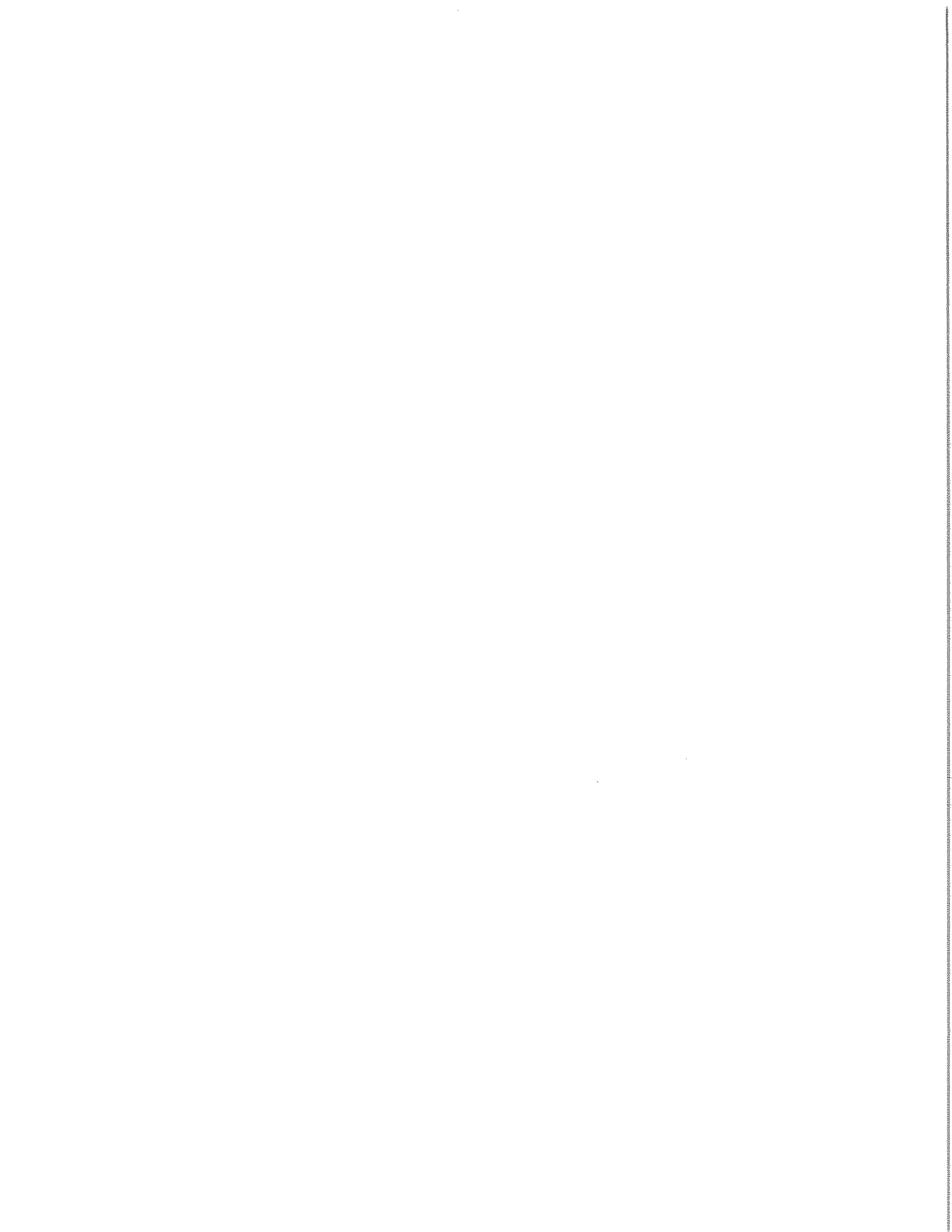

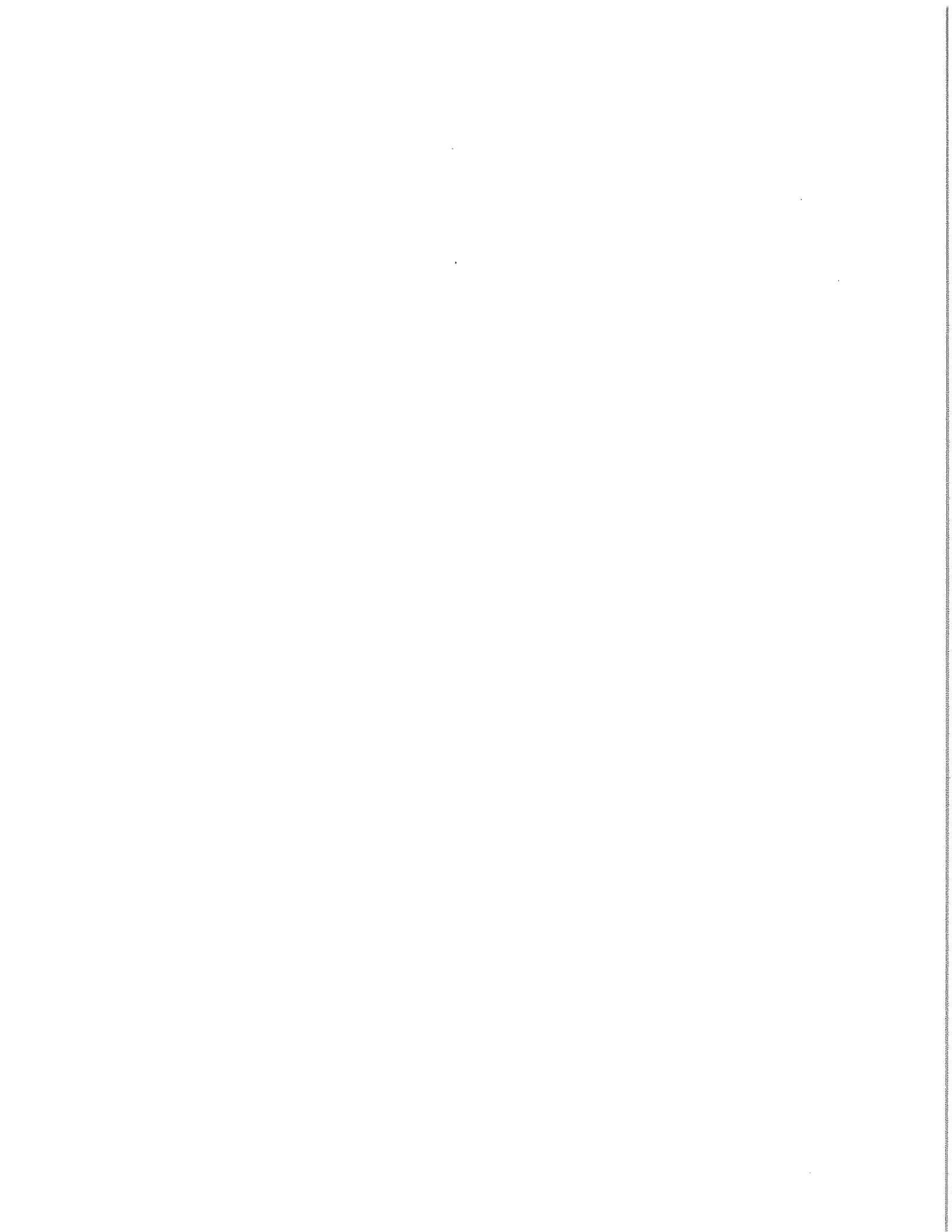
