On the above date and time, the subject above was arrested for 2C:5-5, 2C:5-1, and 2C:20-3. The subject was witnessed trying to steal a bike from Fourth Avenue and Ocean Avenue. At this point the subject was placed in handcuffs behind the back, which were checked for proper fit and double locked. The subject was placed in the rear of a patrol vehicle #22 to be transported to police headquarters. The vehicle was searched before and after, yielding negative results for contraband. Upon arrival at police headquarters, weapons were stored in the weapons locker and the subject was secured in booking to be processed.
