Purpose: This Affidavit/Certification is to more fully describe the facts of the alleged offense so that a judge or authorized judicial officer may determine probable cause.

1. Description of relevant facts and circumstances which support probable cause that (1) the offense(s) was committed and (2) the defendant is the one who committed it:
On September 30th 2020, at approximately 1924 hours, the Lacey Township Police Department received a 911 call for an elderly male unresponsive at the Lakeside Diner. Officers responded and found the victim, Robert Clark ([REDACTED]) bleeding from a head wound. He was unconscious from the time of their arrival until he was transported to Jersey Shore University Medical Center by air.

Patrolman Holt and Patrolman Plis conducted preliminary interviews from multiple witnesses on scene. An abridged summary of the interviews is as follows:

The victim arrived at the Lacey Diner with Kathryn Conklin (aka KIT) for a birthday celebration. At some point, a verbal altercation ensued due to Kit being kicked out of a motorcycle club called the Wawa Crew. Timothy and Albina Nagy, the leaders of this charity motorcycle social club, were present and involved in the altercation, which was said to be instigated by Kathryn Conklin. The owner of the Lakeside Diner advised all involved that they needed to leave. A secondary argument ensued in the parking lot, and at some point, the victim, Robert Clark, was walking towards Timothy Nagy, who had his back turned to Robert Clark. The defendant, Edward Chadler (DOB: 04-07-1966 SSN: [REDACTED] 94 Iron Ore Rd, Manalapan N.J.) saw him approaching Nagy and heard someone yell "knife". He then moved toward Robert Clark and struck him in the face one time with a closed fist. The victim fell to the ground, causing severe trauma to his head. It was stated that the victim was agitated, but was not aggressive towards anyone involved.

Edward Chandler was interviewed by Detective Flynn of the Lacey Township Police Department formally and admitted to striking the victim one time in the face. He admitted that he did not see a knife when he struck Robert Clark but that he head someone say "knife".

Purpose: This Affidavit/Certification is to more fully describe the facts of the alleged offense so that a judge or authorized judicial officer may determine probable cause.

1. Description of relevant facts and circumstances which support probable cause that (1) the offense(s) was committed and (2) the defendant is the one who committed it:

On September 30th 2020, at approximately 1924 hours, the Lacey Township Police Department received a 911 call for an elderly male unresponsive at the Lakeside Diner. Officers responded and found the victim, Robert Clark (DOB: [REDACTED]) bleeding from a head wound. He was unconscious from the time of their arrival until he was transported to Jersey Shore University Medical Center by air.

Patrolman Holt and Patrolman Plis conducted preliminary interviews from multiple witnesses on scene. An abridged summary of the interviews is as follows:

The victim arrived at the Lacey Diner with Kathryn Conklin (aka KIT) for a birthday celebration. At some point, a verbal altercation ensued due to Kit being kicked out of a motorcycle club called the Wawa Crew. Timothy and Albina Nagy, the leaders of this charity motorcycle social club, were present and involved in the altercation, which was said to be instigated by Kathryn Conklin. The owner of the Lakeside Diner advised all involved that they needed to leave. A secondary argument ensued in the parking lot, and at some point, the victim, Robert Clark, was walking towards Timothy Nagy, who had his back turned to Robert Clark. The defendant, Edward Chadler (DOB: 04-07-1966 SSN: [REDACTED] 94 Iron Ore Rd, Manalapan N.J.) saw him approaching Nagy and heard someone yell "knife". He then moved toward Robert Clark and struck him in the face one time with a closed fist. The victim fell to the ground, causing severe trauma to his head. It was stated that the victim was agitated, but was not aggressive towards anyone involved.

Edward Chandler was interviewed by Detective Flynn of the Lacey Township Police Department formally and admitted to striking the victim one time in the face and heard someone yell "knife". He admitted that he did not see a knife when he struck Robert Clark.

On 10/1/2020 at approximately 1500 hours, Dr Dante Ragasa conducted a post mortem examination of Robert Clark. Subsequent the examination, the preliminary cause of death was determined to be a close head injury secondary to fall and the manner of death to be Homicide.
