

AN ORDINANCE FIXING THE SALARIES AND WAGES FOR VARIOUS OFFICIALS AND EMPLOYEES OF THE BOROUGH OF MILLTOWN AND PROVIDING FOR THE MANNER OF PAYMENT THEREOF FOR THE YEARS 2015, 2016, 2017 AND 2018 – DEPARTMENT HEADS

BE IT ORDAINED by the Borough Council of the Borough of Milltown, County of Middlesex and State of New Jersey as follows:

SECTION 1.

That the following salaries and wages shall be paid to the various officials and employees of the Borough of Milltown as are hereinafter specified, to take effect January 1, 2015:

SECTION 2.

The salaries of the Borough Attorney, Engineer, Tax Assessor, Construction Code Official, Building Sub-Code Official, Electric Sub-Code Official, Plumbing Sub-Code Official, Construction Office Control Clerk, Fire Sub-Code Official, and Municipal Magistrate shall be paid in equal monthly installments.

The salary of the Municipal Prosecutor and Municipal Public Defender shall be paid on a per meeting appearance basis on voucher submitted for said court session attended.

SECTION 3.

All other employees of the Borough of Milltown shall be paid on Thursday of every other week.

SECTION 4.

The salaries of the Borough Clerk (starting 3/1/2016), Building Sub-Code Official, Electric Sub-code Official, Plumbing Sub-Code Official, Fire Sub-Code Official and Director of Municipal Utilities shall be set by Resolution of the Borough Council within the ranges established herein.

SECTION 5.

Compensation paid to the Borough Clerk, Borough Tax Collector, Business Administrator, Chief Finance Officer, Director of Social Services, Municipal Magistrate, Construction Code Official, Building Sub-Code Official, Electric Sub-Code Official, Plumbing Sub-Code Official, Fire Sub-Code Official, Director of Recreation and Parks and Zoning Official shall be in lieu of all statutory fees.

SECTION 6.

Compensation for services of a special nature beyond the regular routine business of officials or other employees shall be authorized by appropriate Resolution of the Borough Council.

SECTION 7.

All Ordinances or parts of Ordinances inconsistent herewithin are hereby repealed.

SECTION 8.

This Ordinance shall become effective upon final publication as required by law except for the Borough Clerk, Borough Tax Collector, Business Administrator, Chief Finance Officer, Borough Attorney, Director of Social Services, Tax Assessor, Borough Engineer, Municipal Magistrate, Borough Prosecutor, Construction Code Official, Building Sub-Code Official, Electric Sub-Code Official, Plumbing Sub-Code Official, Fire Sub-Code Official and Director of Recreation and Parks, which shall become effective twenty (20) days after publication as required by law.

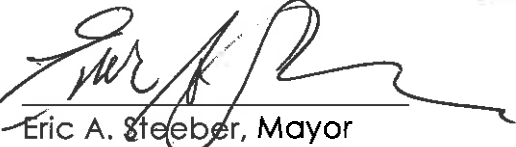
