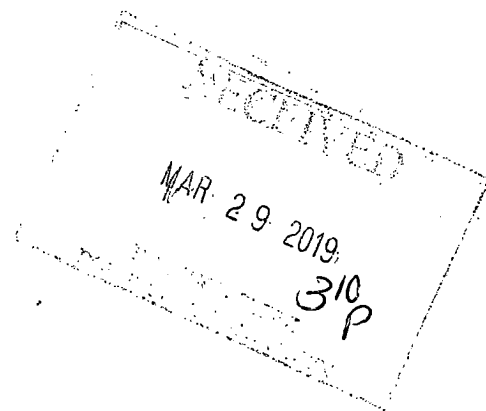

The deadline for filing partisan petitions is Monday, April 1, 2019 before 4:00 PM, as per N.J.S.A. 19:23-14.

Please see that the Request for Position on Ballot forms are supplied to everyone picking up petitions. Inform them that they are to be filed in the office of the County Clerk, at the address given on the form, within two days after the last day for filing petitions (April 3, 2019). Please photocopy if more are needed.

The petitions can only be used for persons running as a member of the major political parties (Republican or Democratic). Any person desiring to run on any other platform at the General Election should be directed to the Elections Division of the County Clerk's Office for the proper petition and instructions at the address and telephone printed above.

Attached are two (2) fillable petitions; one (1) for a single candidate and one (1) for multiple candidates. Any group of candidates running for the same office should find the petition for several candidates to be preferable, (i.e. Borough Council, Township Committee). However, if they wish to file separate petitions, that is acceptable too.

Please note that the signature page of the petition can be copied to provide additional space. Also note that there is a separate page in the petition stating the designation requested by the candidate to be printed on the ballot. This is not a replacement for the Request for Position on Ballot form merely a statement of the slogan to be used by the candidate. It stays in your office as part of the petition.
