At approximately 1200 hours, I was positioned on the shoulder of U.S. Route 46 East in the area of Main Street conducting stationary traffic enforcement. While monitoring westbound traffic, I observed a vehicle traveling at a high rate of speed approximately 1,000 feet from my location. The vehicle was emitting a large volume of thick smoke, which appeared to be originating from the engine compartment area. The amount of smoke was excessive and consistent with a vehicle in mechanical distress, creating a potential hazard to other motorists.

As the vehicle approached the intersection of U.S. Route 46 West and Phillips Avenue, I was able to identify it as a silver Hyundai Sonata. As the vehicle continued westbound, I observed the operator, later identified as [REDACTED] (D.O.B. [REDACTED] 2008), a black male operating the vehicle without a seatbelt.

As [REDACTED]'s vehicle became parallel with my patrol unit, I made direct eye contact with [REDACTED]. Immediately thereafter, [REDACTED] abruptly conducted a right-hand turn into the parking lot of 456 U.S. Route 46 West (Stop & Shine Express Car Wash) without using his turn signal and proceeded toward the rear of the property. Based on the totality of circumstances, including the vehicle's condition, excessive smoke, and the operator's sudden evasive maneuver upon noticing my presence and other motor vehicle violations, I activated my emergency lights and siren to initiate a motor vehicle stop.

Upon entering the property and closing the distance, I observed the vehicle parked and unoccupied. The engine was still producing visible smoke at that time. I immediately exited my patrol vehicle to investigate. A car wash attendant approached me and stated that he observed three black males wearing all black, exit the vehicle and flee on foot by jumping over a nearby fence located at the rear of the property.

While speaking with the attendant, I visually confirmed three individuals matching that description actively running on the opposite side of the fence, moving away from the location of the vehicle.

I returned to my patrol vehicle and immediately notified dispatch of the Maryland registration displayed on the vehicle, bearing registration 3GK7091 in which came back stolen. Dispatch confirmed the vehicle being stolen out of Dover, Delaware.

I then responded in my patrol vehicle to the opposite side of the fence in the direction of travel of the fleeing occupants.

Upon arrival, I exited my vehicle and made contact with a white male who was unloading items from a parked vehicle. I inquired if he had observed three individuals running through the area. The male immediately pointed toward a nearby parking lot, indicating the direction in which the occupants had fled.

I proceeded on foot toward that location and observed three males wearing all black standing together in close proximity. Based on my prior observations and the information provided by two witnesses, I believed these were the same occupants who fled from the stolen vehicle. I issued loud, clear verbal commands ordering all three individuals to stop and to get on the ground.

Upon my commands, two of the males immediately fled on foot in an easterly direction toward Phillips Avenue. The third individual later identified as [REDACTED] (D.O.B. [REDACTED] 2008) attempted to flee but quickly stopped in between two vehicles with both of his hands in his black bubble jacket.

I immediately broadcasted via police radio that two suspects, later identified as [REDACTED] (D.O.B. [REDACTED] 2008) and Isaiah Williams (D.O.B. [REDACTED] 2004), were fleeing on foot eastbound toward Phillips Avenue.

I then focused my attention on [REDACTED] and issued repeated verbal commands for him to get on the ground and remove his hands from his pockets. [REDACTED] refused to comply with these lawful commands and kept his hands concealed, which raised immediate officer safety concerns due to the potential presence of a weapon.

Given the totality of the circumstances, including the involvement in a stolen vehicle, active flight from police, and refusal to show his hands, I un holstered my department-issued firearm and issued additional commands for [REDACTED] to get on the ground and show his hands. After these commands were given, [REDACTED] complied and laid on the ground without further resistance.
