Supplemental Investigation Report



On Sunday, October 19, 2025, I was in the area of Teaneck Road and Forest Avenue when I observed a white and orange motorcycle bearing New Jersey 5KUV3, that had previously eluded me, being operated by the same male party, who was identified as Mr. Kevinangelo Cabrera, traveling southbound on Teaneck Road. I got behind the vehicle but made sure to maintain a small distance as not to raise suspicion.

I notified Teaneck Police Dispatch and the other units on the road of my location and the fact that the vehicle is reported stolen and that the male party is wanted for eluding. While following him, I observed Officer C. Elder #377 approximately two car lengths behind me. Mr. Cabrera then continued under Route 4 and made a right hand turn up Werner Place. Due to the fact that Werner Place is a dead end, I advised Officer Elder to follow him. I proceeded to the next block, cut through the parking lot of 1008 Teaneck Road and proceeded up Werner Place. Towards the top of the block I observed Mr. Cabrera making a u-turn. Believing that he may attempt to elude again, I did not activate my lights and sirens, however I did position my vehicle in front of his. At this point, Mr. Cabrera drove the motorcycle around my patrol vehicle east on the north side of the street. I exited my vehicle and Mr. Cabrera went around my passenger side. Coming up Werner Place was Officer J. Guzman #379, Officer Elder and Officer A. Sanchez #400. At this time, Mr. Cabrera stopped his vehicle long enough that I was able to run down the hill and take custody of him. He was escorted off the motorcycle, handcuffed and placed under arrest. It should be noted that on today's date, Mr. Cabrera was wearing the same helmet, pants and sneakers as the eluding incident.

The vehicle registration and VIN number were confirmed stolen by Teaneck Police Dispatch. The outstanding warrant for Mr. Cabrera was also confirmed. At this time he was searched incident to arrest and escorted into the rear passenger compartment of vehicle #9. Officer Elder then read Mr. Cabrera his Miranda Warnings to which he advised that he would be willing to speak with Officers. Officer Guzman was able to stand by with the vehicle until BCL Towing responding and took possession of the motor cycle.

Mr. Cabrera was transported to Teaneck Police Headquarters where his property was inventoried. Post Miranda, he also advised us that the reason he did not stop initially was because the bike was unregistered. He was then placed in male cell #2. A short time later, Detective Sergeant P. Seretis advised that he would be responding to the Hackensack Police Headquarters to assist with processing. Officer M. Pellegrino #371 and I removed Mr. Cabrera from his cell and escorted him back to vehicle #9. He was then transported to Hackensack Police Headquarters where he was processed and served with his complaint warrant. Once completed Officer Pellegrino and I then transported him to Bergen County Jail where custody of Mr. Cabrera and his property were turned over to Bergen County Sheriff personnel.

At the jail, they advised that they were unable to store his motorcycle helmet. It was brought back to Headquarters and logged into BEAST Evidence System as safe keeping.
