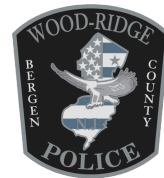

Supplemental Investigation Report



On 09/08/2025, at approximately 2336 hour, I was canvassing the surrounding area for two mopeds that eluded Carlstadt police officers and Ptl. Roncaioli. I was traveling south on Wood Street in Hasbrouck Heights, NJ. I made a right turn onto Lincoln Avenue, headed west bound. I observed a single head lamp facing my direction which appeared to be a headlight coming from a motorcycle or moped. As I approached, I observed three unidentified Hispanic males jump onto two mopeds and accelerate east bound. Reference Ptl. Roncaioli's supplemental report for descriptions of mopeds and suspects.

One moped was occupied by two males and a second moped was occupied by one male party. The moped that was occupied with the two parties crashed as they were attempting to accelerate. While I was making a U-turn, I observed the moped operator lose control. The moped exited the road and struck a concrete block in the driveway of 102 Lincoln Avenue. Both males fell off of the moped but immediately picked up the moped and continued traveling east on Lincoln Avenue.

I then activated my emergency warnings lights and siren, and attempted to conduct a motor vehicle stop on both mopeds. I made a left turn onto Boulevard in Hasbrouck Heights, NJ. Both moped operators refused to stop and continued to travel north on Boulevard in Hasbrouck Heights. At this time, I deactivated my emergency warnings lights and siren. I followed both mopeds at a safe distance along with Ptl. Roncaioli and Carlstadt police officers. At no time, did any law enforcement officer initiate a vehicle pursuit of either moped. I provided headquarters with updates which were then radioed to Hasbrouck Heights Police Department. Reference Ptl. Roncaioli's supplemental report regarding the updates given to headquarters.

Ptl. Roncaioli and I responded to 102 Lincoln Avenue. We observed property damage to the driveway. I observed a broken concrete block and a bush that was damaged due to the moped crash. We also observed personal property and tools that were left at the scene of the crash. The damaged property was photographed and all evidence was seized. Upon my return to headquarters, all evidence was entered into our BEAST Evidence Management System and secured in evidence lock box #009. No further police action taken at this time.
