Regarding the Halbach/LeConey case.

I wouldn't be surprised if they've gone through the car as well. The house is unlocked, there's no crime scene posted on it, there's nothing.

I can't say for sure but a person named Kelli Bean aka Kelly Bowen, has taken it upon herself to attempt to implicate Lynn Mangano and the Coalition for Animals. I believe she is the one putting out the flyers.

I also know someone went in and did a video. It's disgusting. They videotaped two little kittens dead in the bathtub so obviously all the animals weren't taken out of there

But back to people entering the house in general. If they're going through it how can they be finding evidence pertaining to dogs that were either killed or adopted out and the police haven't gone in and gotten that evidence? If they're going in there who's to say Halbach and LeConey aren't going in there as well?

They could possibly have had cash stashed in there. They could have had drugs stashed in there. There could be anything in that house.

If people keep going through that house and removing things how are you going to build a stronger case? Isn't that tampering with evidence?

I truly appreciate all the work that you have done. I know this is a horrendous thing to deal with. I know the house is a nightmare, however, I really really would appreciate it if you guys could lock up that house and stop them from breaking in.

It has turned into a witchhunt on Facebook against other innocent people that had nothing to do with the cruelty. Nor did they know anything about it.
