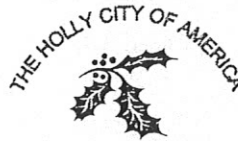

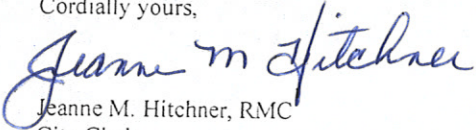

Subject: Uploading documents into Digital Media

Below are instructions on how to scan documents using the scanner/printer in the report room:

- 1) Grab a thumb drive (either personal or one from Sgt office Misc Key box on wall)
- 2) Take thumb drive and documents to Scanner/printer
- 3) Insert thumb drive into USB port (wait a couple seconds for the scanner/printer to respond)
- 4) The screen will now indicate whether if you want to scan ON TO the USB drive or print from it. Select scan on to USB drive (left option)
- 5) Place documents on feeder tray face up
- 6) Press start button (documents on feeder tray will be scanned)
- 7) When documents are no longer on feeder tray wait (while looking at screen) for document images to transfer on USB drive.
- 8) Once transfer is complete, pull out thumb drive and retrieve original documents which are now under the feed tray (file original documents accordingly)
- 9) Insert thumb drive into computer and copy/paste or upload PDF scanned document(s) into Digital Media
- 10) Once uploaded, ensure the uploaded documents actually uploaded. If not repeat Step 9. If so, delete document from thumb drive and you are done.

There have been several occasions where documents are being photographed then uploaded into Digital Media. The problem with this (especially for CJP purposes) is that documents that are photographed print out terribly because it was saved as a photo. If uploaded correctly as a PDF, the document prints out normally. If you are still unsure please ask for assistance from another Officer or Supervisor.

Dear Chief Farabella:

During the late evening hours and through the night of October 12-13, 2016, I felt the urgent need to get guidance from your department for a situation being faced by a loved one traveling in another state who was quite ill, traveling alone, and trying to get home to Millville. I connected with Officer Proffit and explained the situation, and with his assistance we explored some options about trying to locate the individual. When I was finally able to get an approximate location when the individual called me, I again contacted Officer Proffit with this information and, in turn, he contacted the Virginia State Police. The individual was quite ill and a severe diabetic, and was desperately in need of assistance; however, he did not stay at the location he had stated, and because of his level of confusion, he turned off or would not answer his phone.

Officer Proffit was diligent in his efforts to assist in every way possible and kept me abreast of his efforts. Because all contact with the individual was lost, all I could do was pray for his safety. The individual finally again contacted me just before 7:00 a.m. on 10/1 that he had finally made it to New Jersey and I notified Officer Proffit of that before he went off duty. (What should have been a 6-7 hour drive from North Carolina turned into a 13 hour nightmare for me.) Ultimately, the individual was admitted to the hospital.

While I thanked Officer Proffit when I called to let him know the individual was only now a short distance away from home, I wanted you to be aware of all his efforts to try to get assistance for the individual, and he was so professional in keeping me calm and focused, and kept me informed of all his efforts. (He can fill you in on his efforts.) In this time when all police are getting a bad rap, I want you to know what an outstanding job of community responsiveness I experienced with Officer Proffit. Good job, Officer Proffit...I salute you!

During the late evening hours and through the night of October 12-13, 2016, I felt the urgent need to get guidance from your department for a situation being faced by a loved one traveling in another state who was quite ill, traveling alone, and trying to get home to Millville. I connected with Officer Proffit and explained the situation, and with his assistance we explored some options about trying to locate the individual. When I was finally able to get an approximate location when the individual called me, I again contacted Officer Proffit with this information and, in turn, he contacted the Virginia State Police. The individual was quite ill and a severe diabetic, and was desperately in need of assistance; however, he did not stay at the location he had stated, and because of his level of confusion, he turned off or would not answer his phone.

Office Proffit was diligent in his efforts to assist in every way possible and kept me abreast of his efforts. Because all contact with the individual was lost, all I could do was pray for his safety. The individual finally again contacted me just before 7:00 a.m. on 10/1 that he had finally made it to New Jersey and I notified Officer Proffit of that before he went off duty. (What should have been a 6-7 hour drive from North Carolina turned into a 13 hour nightmare for me.) Ultimately, the individual was admitted to the hospital.

While I thanked Officer Proffit when I called to let him know the individual was only now a short distance away from home, I wanted you to be aware of all his efforts to try to get assistance for the individual, and he was so professional in keeping me calm and focused, and kept me informed of all his efforts. (He can fill you in on his efforts.) In this time when all police are getting a bad rap, I want you to know what an outstanding job of community responsiveness I experienced with Officer Proffit. Good job, Officer Proffit...I salute you!
