Re: Open Public Records Act (OPRA) Request

This letter constitutes the response of the Office of the Governor to the above-referenced OPRA request, which states:

Please provide the name of your employee associated to 609-847-9747 and all right to know information related to 17 and 19 East Broad Street Millville, NJ.

With respect to the first item of your request, please be advised that 609-847-9747 is not assigned to any employee in this Office. With respect to the second item of your request, please be advised that OPRA does not allow a blanket request for every document a public agency has on file or a wholesale request for general information. Gannett N.J. Partners, LP v. Cnty. of Middlesex, 379 N.J. Super. 205, 212 (App. Div. 2005); MAG Entm't, LLC v. Div. of Alcoholic Beverage Control, 375 N.J. Super. 534, 549 (App. Div. 2005); Bent v. Twp. of Stafford Police Dep't, 381 N.J. Super. 30, 36-37 (App. Div. 2005); Spectraserv, Inc. v. Middlesex Cty. Utils. Auth., 416 N.J. Super. 565, 578 (App. Div. 2010); N.J. Builders Ass'n v. N.J. Council on Affordable Hous., 390 N.J. Super. 166, 178-79 (App. Div. 2007). Requests for correspondence must identify the individuals or accounts to be searched and be confined to a discrete and limited subject matter. Burke v. Brandes, 429 N.J. Super. 169, 176-78 (App. Div. 2012); see also Elcavage v. West Milford Twp. (Passaic), GRC Complaint No. 2009-08 (Apr. 8, 2010) (stating that a proper request for email correspondence must contain "(1) the content and/or subject of the e-mail, (2) the specific date or range of dates during which the e-mail was transmitted or the emails were transmitted, and (3) a valid e-mail request must identify the sender and/or the recipient thereof").

This request does not have sufficient information to allow this Office to conduct a reasonable search for records. Therefore, if you are seeking records from this Office, please submit a new request with additional detail regarding the records sought. If you seek records or correspondence, please specify the records sought with as much detail as possible. If you seek correspondence, please identify the specific recipients whose records are to be searched, a discrete and limited subject matter, and a specific timeframe.
