These promotions not only affect the functioning of the department, but also the Officers who are candidates. They are unable to make a determination on whether to attend a variety of very costly promotional instruction courses held throughout the state and/or whether they would have to test again for a rank in which they already have worked hard to do.

We were told there would be an interview process in which no one knows what would be asked and were told that it was going to happen in the next couple of weeks, which was months ago.
