Homeowners near the bank have not been able to sell their house because of the turkey vultures and they are threatening to sue the bank if they don't remove the cat colony. They are past the point of trying any option other than removing the cats.

We have committed to take them in and house them until we are able to relocate them. I wanted to coordinate with everyone on this thread about where to house these cats, since they might be with us for awhile.

She needs Transport 1 empty soon to fit incoming dogs, but now hearing that we have 15 more cats coming in to be held for an indefinite period of time, we would need to find space for all of that. The cats in Transport 1 from the hoarding case are slowly getting worked up but they are very shy and not all of them may be adoptable in the end. Nina, Kathy- we'll have to sit down to figure this one out. It's unfortunate we have a few rooms blocked off with cats (ringworm quarantine, hoarding case) that can't move to the adoption floor currently, which has a lot of space ironically.
