The Township of Clark received your Open Public Records Act (OPRA) request on December 11, 2023. The Official Records Custodian, Edith Merkel, received your OPRA request on December 11, 2023. As such, the seven (7) business day deadline to respond to your request was December 20, 2023. On December 21, 2023 I requested a twenty (20) day extension due to the breadth of your request and technical difficulties that had risen in processing the request. This response to your request is being provided to you on the 5th day after the request for an extension.

The following records are being provided in their entirety and are responsive to your request.

At your option, you may either institute a proceeding in the Superior Court of New Jersey or file a complaint with the Government Records Council ("GRC") by completing the Denial of Access Complaint Form. You may contact the GRC by toll-free telephone at 866-850-0511, by mail at P.O. Box 819, Trenton, NJ, 08625, by e-mail at grc@dca.state.nj.us, or at their web site at www.state.nj.us/grc. The Council can also answer other questions about the law. All questions regarding complaints filed in Superior Court should be directed to the Court Clerk in your County.
