Good afternoon. After our conversation, I walked the field to ensure it was safe for play. It seemed like any other natural surface, and large holes or uneven surfaces were not evident. I called and spoke with the event management for the lacrosse tournament to discuss concerns about field use. They are interested in donating \$1,000 to the field maintenance. They also stated that they would also be responsible for any field damage and would repair it. Historically, the fields have not been damaged since it is girls' youth lacrosse, but that is part of the contract with the district, so I wanted to let you know about this.

I did share the request to move the games to the elementary school's fields. Logistically, that would incur additional costs, such as hiring more officials, parking, port-a-johns, and extra safety personnel (trainers, ambulances, etc.). If the recreation department wants to absorb those additional costs, this can be discussed for future tournaments. Unfortunately, it is too late to change the location for the June tournaments.

Lastly, it was discussed that the soccer recreation program may be interested in fundraising at the event. If so, I can share it with the Booster Organization to see potential opportunities. The goal is to work together collectively and collaboratively so everyone can benefit, so please let me know your thoughts.
