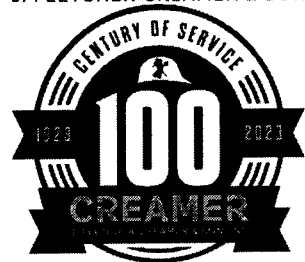

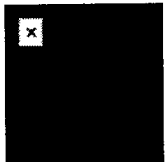

Joseph Marinello reached out to me, knowing I would respond; I simply passed along his inquiry to you. I've known since you since 2015 and not once have I ever witnessed you manage or coach a game, but yet you told the NJSBL you're the 14u coach, that's hutzpah. I have volunteered for every season, be it Recreation or Spring Summer & Fall Travel. In fact, no one has played more travel seasons then my son. Last year my son was on four (4) different teams (**he played for 2 of the 4 Babe Ruth teams simultaneously** - you specifically asked if he would) ; I coached on three of them. I'm the last manager remaining from his Tiny Tims.

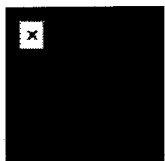

Hi John I hope all is well and Happy New Year. Writing you to revisit something I had emailed you about a while back regarding some improvements that are in the works for Tisdale Field. Chris Caserta and I have been working and communicating with the Buildings and Grounds Supervisor for the past 2 years and recently with Andy Herre the new Athletic Director. We had a meeting this morning and we have a commitment from the High School that they will be replacing the very old backstop and fencing that runs in front of the dugouts. They will also regrade and repitch in the infield of both Tisdale fields. They will be relocating the on deck cages to the opposite ends of the dugouts. They will be installing Blue padding along the fences for safety on the dugout fencing and the backstop with nice Ramsey logos. Lastly, the School Board will also be purchasing the material for a press box for behind Homeplate, and Cedar Hill Construction, my company, has agreed to build it so we can possibly have County tournament games and other tournaments during the season. Should look really great with these upgrades and has been overdue for many years. After visiting almost every high school field, Tisdale is one of the last fields to get upgraded and will be great for the entire program in town.

We will also need to replace the benches inside the dugouts, get some helmet racks, bat racks, a Coaches corner, and some new turf for the inside of the dugouts and on deck cages. We are hoping that the RBSA can help in funding the dugout projects, considering the both fields get used by the RBSA as well. The quote that I have got from a reputable company that makes the dugout benches and racks is \$4,350.00. The turf is around \$500. I will forward the estimate to you and maybe see what the RBSA can help out with. We are also doing our annual fundraising to see what we can put towards this after we complete purchases of new bat bags and helmets for the Varsity team, which are now already very worn and need to be replaced. We have held off on new uniforms and gear and will be using the same uniforms for the 3rd year, which normally gets replaced every 2 years.

I know this is a big undertaking, but we would appreciate your help in finalizing the details for everyone to enjoy. It should be exciting and we can't wait to see the final outcome.

Hello Bruce,

I know its a few months away, but I wanted to check with you on whether the library would be able to run our concerts in the park once again in Finch Park. We had great turnout and responses for all three of the concerts from last year and I was hoping to run them again, albeit with some lessons learned. I was going to speak with Tom at DPW to see if there might be a better location in the park in terms of power acces or an arrangement that might be less of a burden on DPW. Or also, perhaps a better location so that we have less of an impact on any sports or other events that might be going on. However, before I do anything else, I wanted to check on dates to see if there would be availability in the park

on those dates or not. I was thinking of an earlier time in August as I think we ran into the issue of overlapping with football practice in the same area. We tended to use the gazebo area, but also much of the space in front of the gazebo nearly back to the parking lot as we had games, tents, the Friends of the Library and other, extra things going on. We are happy to be placed in another location in the park if that's easier somehow.

Anyway, I was hoping to run three concerts with one each in June, July and August. Also, my children's department staff was wondering if it would be possible to add a 4th date in the park for a children's concert as our summer reading kickoff event, to be held in Finch Park? Everything we are thinking about would be on Thursdays. Here are the dates I was thinking along with the rain dates:

June

Thursday, June 16th at 5pm-9pm

Rain Date: Thursday, June 23rd OR Friday, June 17th

July

Thursday, July 21st at 5pm-9pm

Rain Date: Thursday, July 28th OR Friday, July 22nd

August

Thursday, August 18th 5pm-9pm

Rain Date: Thursday, August 25th OR Friday, August 19th

Kids Summer Reading Concert

Thursday, June 30th 2pm-7pm

Rain date: Thursday, July 7th 2pm-7pm

I'm not sure if Fridays are generally available, so I put down two different rain dates, let me know if Fridays are generally not available. I'm also considering the idea of moving the concerts indoors at that point at the library, which would be much smaller in scale to be sure. Sometimes it can be tricky to get bands to commit to a rain date as well as a main date.

Anyway, let me know if the main days are available and what might be possible for the rain dates. I'm also happy to work with the rec dept head if that's easier and I was thinking to chat with Tom about what other options might be better for us for this year. One final question - I believe that the town may have gotten a portable stage of some kind setup for other events? Is that something the town owns or has access to, or is that something that is generally rented? I'm curious to see what ways I might be able to improve things for this year and make it easier for DPW as far as power access is concerned.
