Hi John,

The Ramsey Renegades had our first fund-raising meeting. Here are the main updates.

1. We would like to hold a raffle before Christmas, giving away an electric scooter. Kristen Daley will purchase the scooter, and I will need to reimburse her once she has purchased it and gives me a receipt. The cost will be approximately \$300. Each family will sell tickets and then give me a lump sum for all of the tickets they have sold. We would like to start the raffle right away, and tentatively have the drawing done by one of the boys on the team on December 20. We will contact the winner directly, but the drawing will be recorded and posted on our social media (announcing the winning ticket number but not the person's name).
2. We are starting to organize for our NFL playoff and Super Bowl pools. They tentatively will start in the beginning of January 2025.
3. I was going to set up a separate Venmo account to handle transactions since RBSA does not have its own. Tentatively it will be up under the name RamseyRenegades2025. I think that I will have to delete my own Venmo Account since there can only be one Venmo account linked to a given cell phone. The alternative would be to set up a business account attached to my personal account, but there is a 2% fee for each transaction associated with a business account. I was going to take care of the Venmo account tomorrow.
4. Please let me know what needs to be done to have access to the Ramsey Renegades bank account. I would like to have everything in place this week since money for the proposed raffle will be coming in next week.
