The Township of Washington received your Open Public Records Act (OPRA) request on October 30, 2025. The official Records Custodian, Susan Witkowski, received your OPRA request on October 30, 2025. As such, the seven (7) business day deadline to respond to your request is November 10, 2025. This response to your request is being provided the 3rd day after custodian's receipt of said request.

Your OPRA Request requested the following:

*"lists of department, name, title, rank, salary, hourly rate, or volunteer status, *demographic information about the age, sexual orientation, disability status, gender and race/ethnicity, date of hire of each person for all fire, *police, and ambulance personnel serving or affiliated with the municipality in the following years 2014-2024"*

**There is no such record responsive to your request.*

Please note demographic information for 2023 and 2024 for the **POLICE DEPARTMENT ONLY is available on the Police Department website [Professional Standards - Township of Washington](#). There are no government records from 2014 to 2022.*

These records are being transmitted to you via electronic format as per your request. Pursuant to N.J.S.A. 47:1A-5. b., the cost associated with this request is no charge.

PLEASE NOTE THE FOLLOWING:

Volunteer fire and ambulance services in New Jersey are generally not subject to OPRA requirements. The New Jersey Supreme Court established in *Verry v. Franklin Fire District No. 1*, 230 N.J. 285 (2017) that volunteer fire companies are not public agencies under OPRA because they are merely instrumentalities of instrumentalities rather than direct instrumentalities of political subdivisions. This principle extends to volunteer ambulance and rescue squads, as confirmed in *Brooks v. Tabernacle Rescue Squad*, 2015 WL 3669795 (App. Div. 2015). Not Reported in A.3d (2015).

This OPRA is considered complete.

If your request for access to a government record has been denied or unfilled within the seven (7) business days required by law, you have a right to challenge the decision by the Township of Washington to deny access. At your option, you may either institute a proceeding in the Superior Court of New Jersey or file a complaint with the Government Records Council (GRC) by completing the Denial of Access Complaint Form. You may contact the GRC by toll-free telephone at 866-850-0511, by mail at P.O. Box 819, Trenton, NJ, 08625, by e-mail at grc@dca.state.nj.us, or at their web site at www.state.nj.us/grc. The GRC can also answer other questions about the law. All questions regarding complaints filed in Superior Court should be directed to the Court Clerk in your County.
