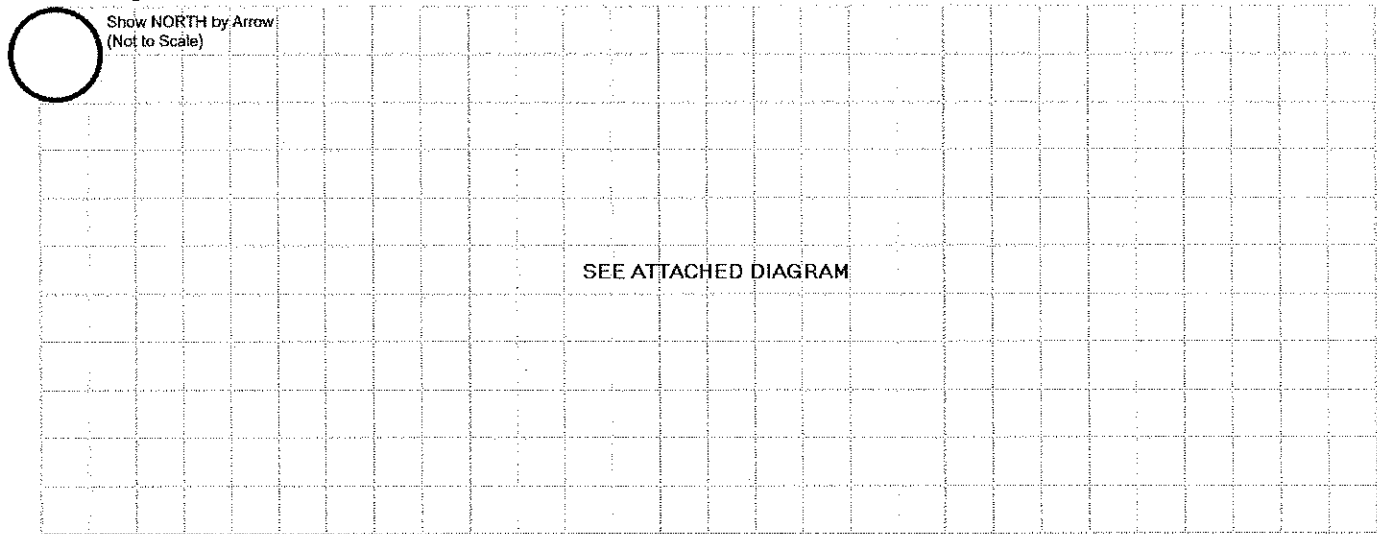

145. Crash Description/Narrative

Vehicle #2 was in the center lane of Herborn Ave E/B, traveling through the intersection of Herborn Ave and Lanes

Mill Road. Vehicle #1 was in the right lane of Lanes Mill Road N/B, traveling through the intersection of Lanes

Mill Road and Herborn Ave. Vehicle #1 collided with Vehicle #2.

Driver of Vehicle #2 stated he was in the center lane of Herborn Ave E/B, traveling through the intersection of

Herborn Ave and Lanes Mill Road. His light was green as he was traveling through the intersection and he noticed

Vehicle #1 was not stopping. He applied his brakes and tried to turn out of the way. At that time his right

front bumper hit Vehicle #1's left rear passenger door.

Driver of Vehicle #1 stated he was in the right lane of Lanes Mill Road N/B, traveling through the intersection of

Lanes Mill Road and Herborn Ave. He thought the light was green when he went through the intersection. After

the crash, he looked up at the light and saw it was red.

Based off my observations and both driver's statements I find Vehicle #1 at fault for failing to obey the traffic

signal. Driver of Vehicle #1 had complaint of neck pain and was treated on scene by Brick EMS. He was cleared

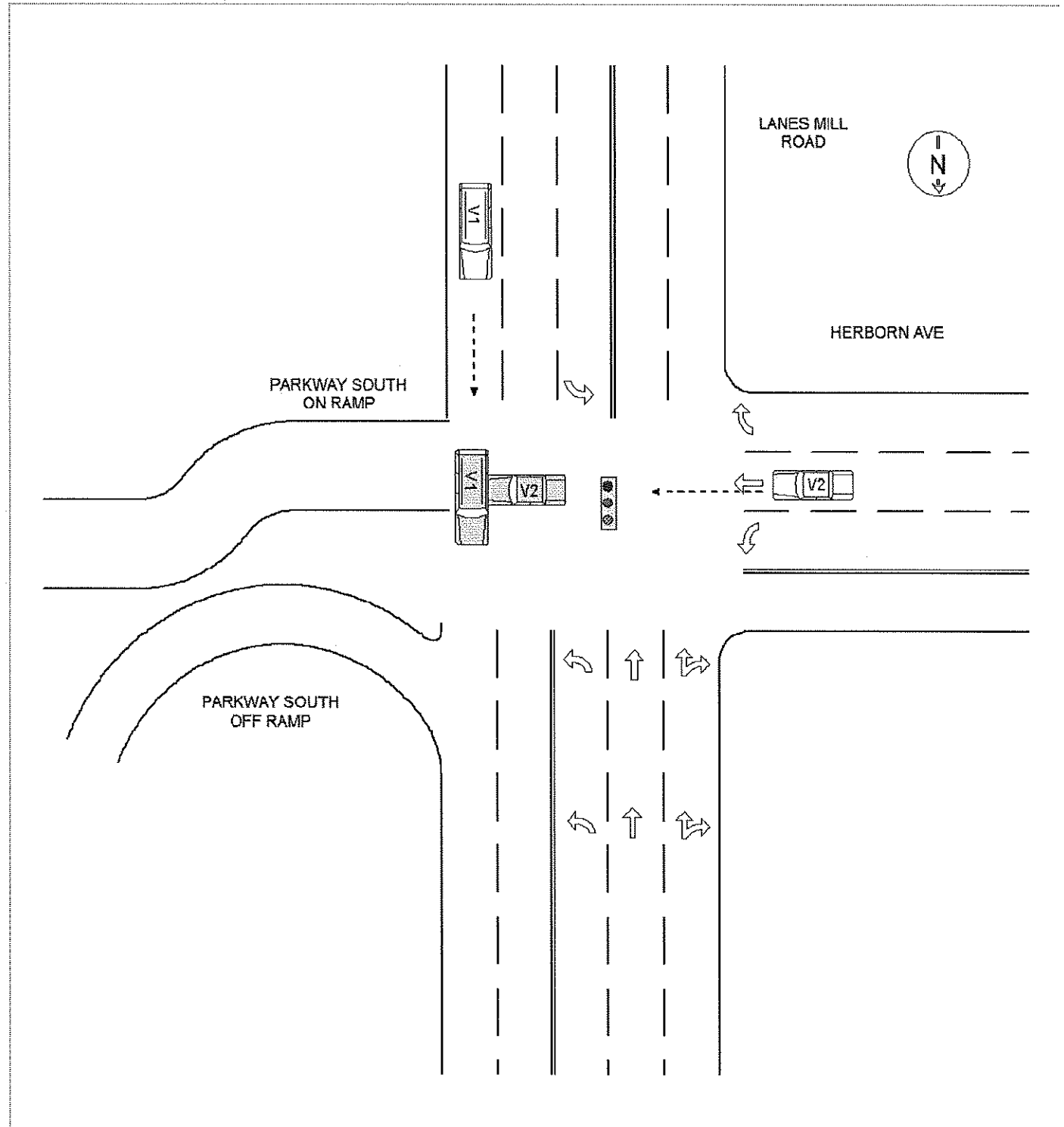
