The County of Monmouth received your Open Public Records Act (OPRA) request on December 6, 2017. As such, the seven (7) business day deadline to respond to your request is December 15, 2017. This response to your request is being provided to you on the 3rd business day after the custodian's receipt of said request.

Your amended request seeks "I'm requesting the following records of any and all employees for the year of 2017. Each employee record should contain: an individual's name, title, position, salary (and longevity pay, overtime pay if applicable), payroll record, length of service, date of separation and the reason for such separation, and the amount and type of any pension received".

- Excel spreadsheet containing requested information for all employees for the year 2017 (270 pages)

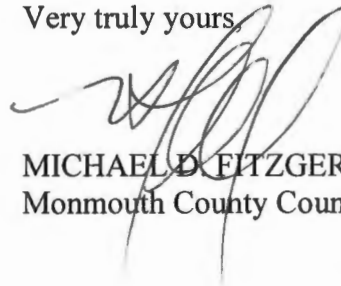
Please note that the amount of pension which is being requested is not maintained by the County as a record and, as such, no documents exist responsive to this aspect of your request.

If your request for access to a government record has been denied or unfilled within the seven (7) business days required by law, you have a right to challenge the decision by the County of Monmouth to deny access. At your option, you may either institute a proceeding in the Superior Court of New Jersey or file a complaint with the Government Records Council ("GRC") by completing the Denial of Access

Complaint Form. You may contact the GRC by toll-free telephone at 866-850-0511, by mail at P.O. Box 819, Trenton, NJ, 08625, by e-mail at grc@dca.state.nj.us, or at their web site at www.state.nj.us/grc. The Council can also answer other questions about the law. All questions regarding complaints filed in Superior Court should be directed to the Court Clerk in your County.
