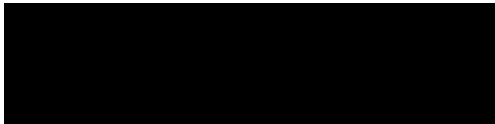

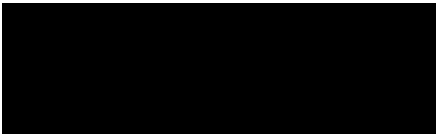

Please understand that if you are submitting a DRAFT Environmental Assessment it will need to be reviewed and approved by NPS NEPA, Section 106, Section 7 (ESA), and environmental compliance people in the regional office and in Washington, DC as well as reviewed by the Regional Solicitor before it can be formally accepted by the NPS.

The NEPA process also involves public engagement including a public hearing specifically on the EA document, a public comment period of 90 days and posting of the EA on the Middlesex County (or other local) website and/or the NPS Planning, Environment and Public Comment website (PEPC) website. <https://parkplanning.nps.gov/>
