AN ORDINANCE TO AMEND AND SUPPLEMENT AN ORDINANCE
ENTITLED, "THE REVISED GENERAL ORDINANCES OF THE
CITY OF NEW BRUNSWICK, 1970: ADOPTED:
OCTOBER 6, 1970, CHAPTER II, ADMINISTRATIVE CODE.

BE IT ORDAINED, by the Municipal Council of the City of New Brunswick, New Jersey,
as follows:

SECTION I

Section 2-5R The Environmental and Pollution Control Commission is hereby amended
in its entirety to read:

There is hereby established an Environmental and Pollution control Commission,
consisting of five (5) to seven (7) members to staggered terms of three (3) years each,
to be appointed by the Mayor and serve without compensation. The Commission shall study
and develop proposals designated to improve the ecology of the Community. This Commission
is established pursuant to N.J.S.A. 40:56A-1 to 40:56A-5. The Commission is established
for the protection, development or use of natural resources, including water resources,
located within the territorial limits of the City of New Brunswick.

SECTION II

All ordinances or parts of ordinances inconsistent herewith are hereby repealed.

SECTION III

This Ordinance shall take effect immediately upon passage and publication
according to law.
