

ORDINANCE 2023-31

**AN ORDINANCE OF THE BOROUGH OF SOUTH RIVER, COUNTY OF
MIDDLESEX, STATE OF NEW JERSEY, AMENDING THE BOROUGH CODE OF
THE BOROUGH OF SOUTH RIVER, SO AS TO AMEND CHAPTER 22,
ENTITLED "BOARDS, COMMISSIONS AND AUTHORITIES"**

BE IT ORDAINED by the Mayor and Borough Council of the Borough of South River, County of Middlesex, and State of New Jersey, as follows:

SECTION 1. Chapter 22 of the Borough Code of the Borough of South River, entitled "Boards, Commissions and Authorities" is hereby amended so as to amend Article IV Environmental Committees, Boards and Authorities so as to amend § 22-18.1 entitled "Membership" so as to amend § 22-18.1 (D) to read as entirely as follows:

§ 22-18.1 Membership

D. In addition to the members appointed to the Environmental Commission/Shade Tree Advisory Board/Green Team, the Borough of South River Council shall appoint two nonvoting junior members. Junior members shall be residents of the Borough and under 18 years of age. The junior members shall serve one-year terms.

SECTION 2. All ordinances or parts of ordinances inconsistent herewith are hereby repealed.

SECTION 3. If any section, subsection, sentence, clause, phrase or portion of this ordinance is for any reason held to be invalid or unconstitutional by a court of competent jurisdiction, such portion shall be deemed a separate, distinct and independent provision, and such holding shall not affect the validity of the remaining portions hereof.

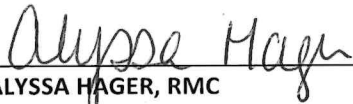
SECTION 4. This ordinance shall take effect after second reading and publication as required by law.

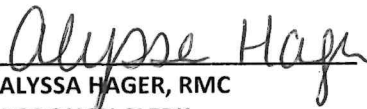

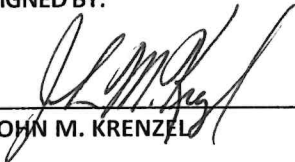

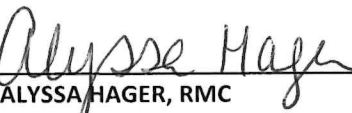
