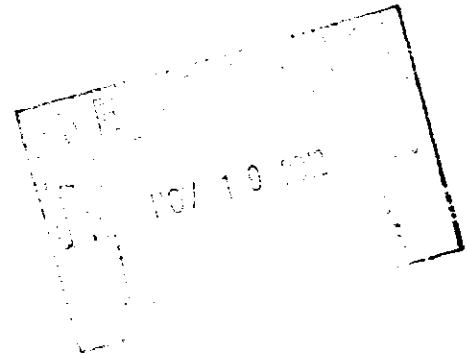

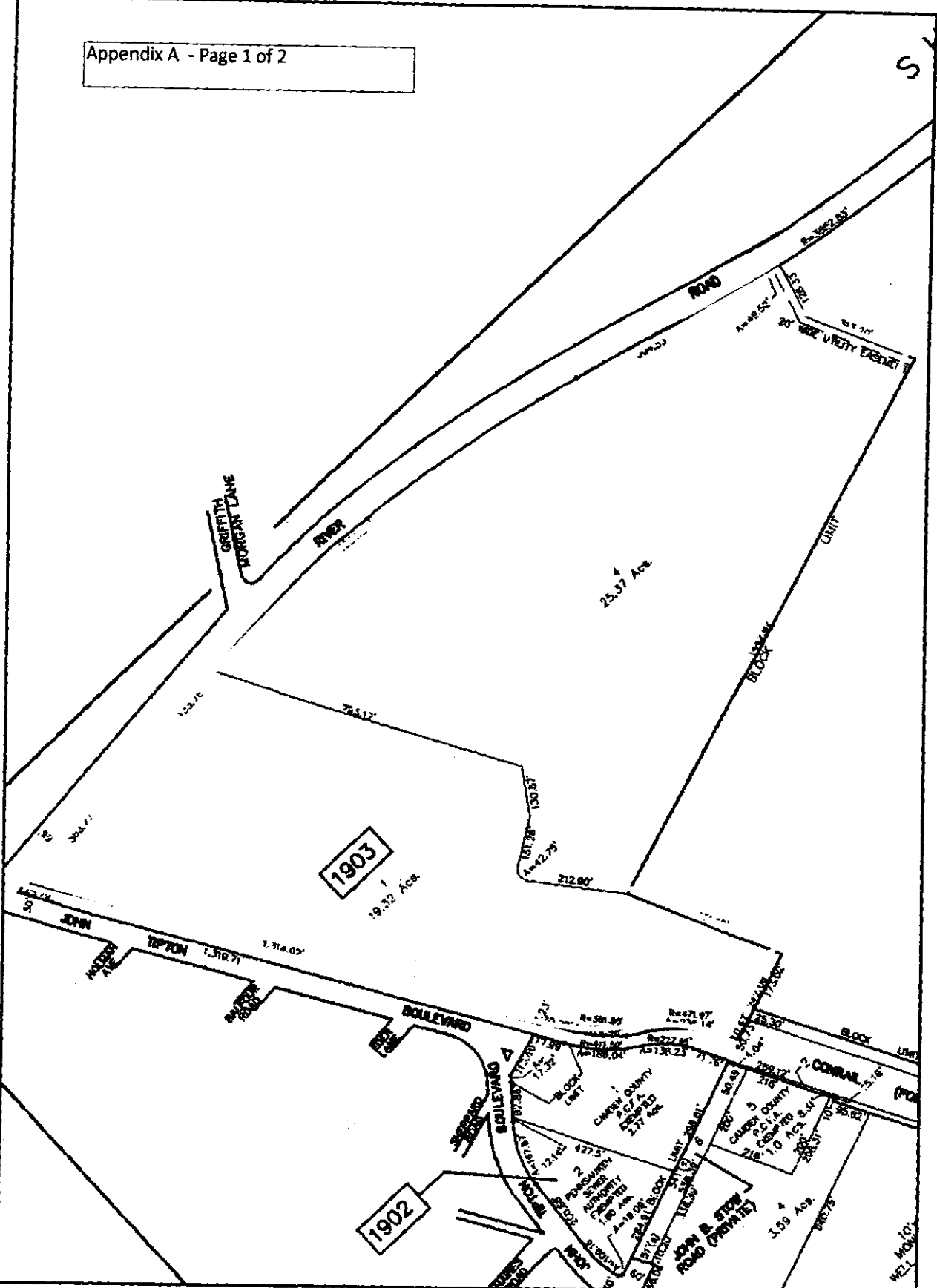

The Department has completed its review of the DICAR, which included two rounds of groundwater sampling analysis submitted on your behalf by BCM Engineers. Based on the Department's records, no further remedial action investigation will be required at the above referenced site.

Therefore, you are hereby directed to properly abandon the two monitor wells, #7 and 8, located at the above noted site by a licensed certified well driller as per the New Jersey Subsurface and Percolating Waters Act, N.J.S.A. 58:4A-1 et seq., and the regulations promulgated pursuant thereto, N.J.A.C. 7:9-9.1, within 90 calendar days of receipt of this directive. Furthermore, within 15 calendar days of proper abandonment, you are hereby directed to submit to the Bureau of Water Allocation a complete Well Abandonment Report (Form DWR-020), with a copy to this office.

Please note, however, that should a discharge of fuel oil that occurred at the site be linked to any further contamination problems, the Department will require you to take additional remedial action.

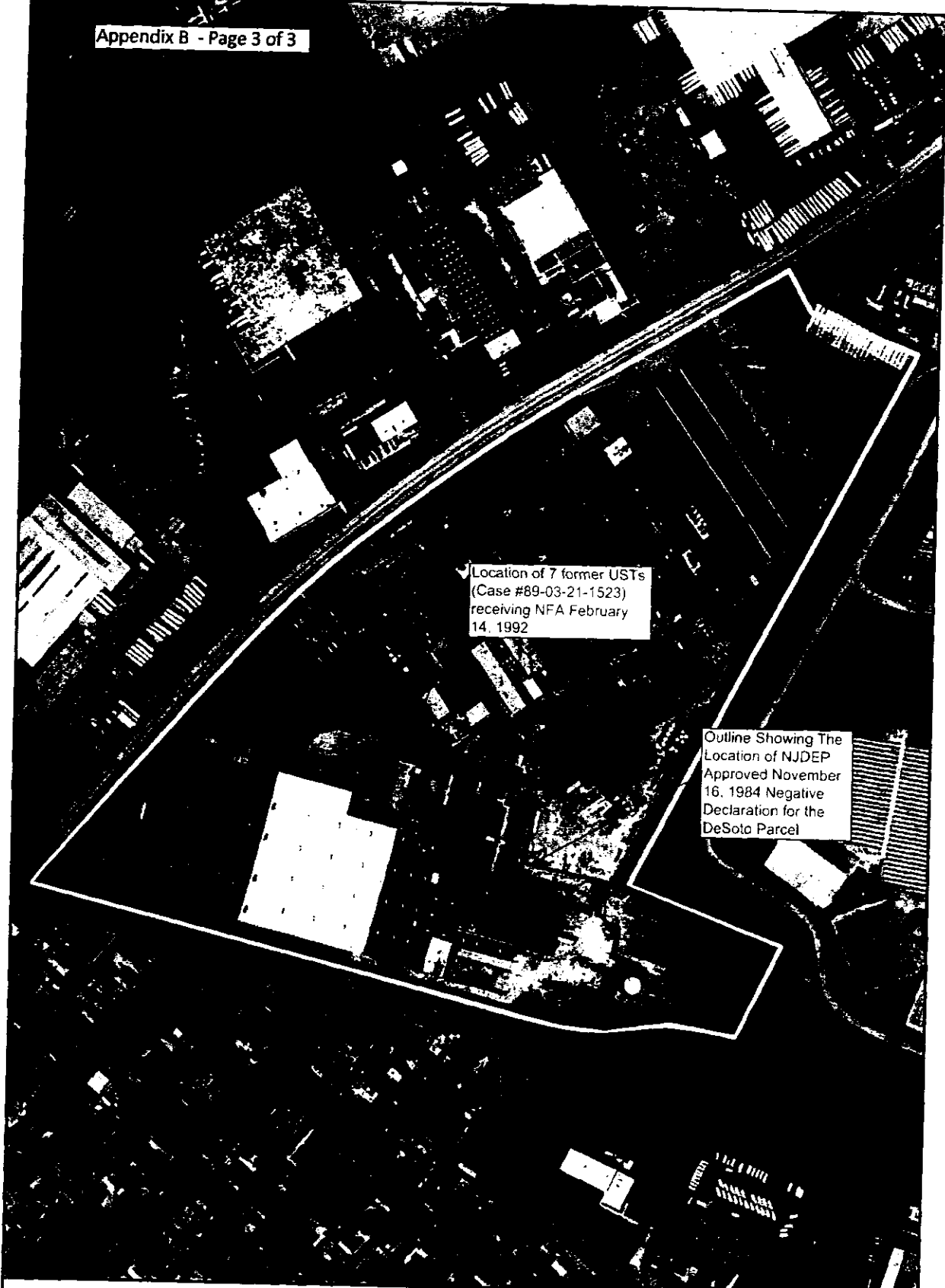
