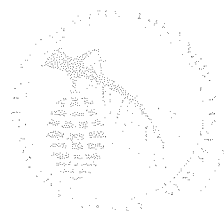

VIOLATION DETAIL: Chapter 180-2.D.(2)-- Allowed ONE inoperable and/or unlicensed vehicles - Nothing herein contained shall be deemed to prohibit the placing, keeping or storage of exactly one motor vehicle, junk automobile or junk automobile body under a formfitting car cover manufactured and sold for the type of vehicle stored, provided that: (a) The vehicle is stored in the driveway or back yard of the premises; or (b) All motor fuels and lubricants are completely drained from the vehicle.

CORRECTION INSTRUCTIONS: Owner or Occupant to remove any vehicles over one allowed by ordinance and the inoperable vehicle must have a formfitting cover and drain all fuels and lubricants.

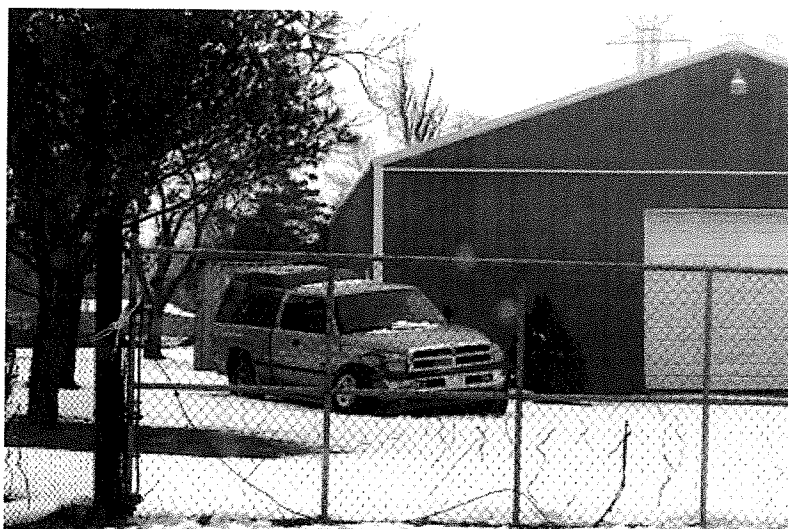
