AMENDED COMPLAINT FORM

I am a member of the Chesterfield Elementary School Board of Education ("CES BOE"). I am not writing or submitting this Complaint as a member of or on behalf of the CES BOE. Further, the writing and submission of this complaint was not authorized by the CES BOE. Rather, I am writing and submitting this complaint as a private citizen and as a concerned community member and mother. All opinions are my own.

I, Christina Hoggan, residing at [REDACTED], Chesterfield NJ 08515, phone number [REDACTED] request the School Ethics Commission to consider a complaint against the above-named Angela Reading, Respondent, whose home address is [REDACTED] North Hanover NJ 08562, in accordance with the authority of the School Ethics Commission to entertain such complaints under N.J.S.A. 18A:12-21 et seq.

The facts upon which this complaint is based are as follows:

1. **Statement of facts: Mrs. Reading created a post on a Facebook Page for Northern Burlington Parents in which she accused the Burlington County Department of Health of malfeasance in relation to COVID-19 guidance for schools based on politics.**

(1) On January 18, 2022, Angela Reading, without posting the requisite disclaimer for Board members, created a Facebook Post in a group called Northern Burlington Parents in which she accused the Burlington County Department of Health ("DOH) of malfeasance in relation to a correction they made regarding a misprint regarding Covid-19 guidance related to schools. In doing so she provided,

FYI: The Burlington County DOH is claiming a "misprint" in their 1/12/22 guidance update which essentially got rid of close contact quarantine for unvaccinated kids (or at least significantly limited it). They revised "mistake" will increase the number the students quarantined [sic]. Regardless of your position on this issue, our health officials should be consistent and should not be publishing guidance before proofreading (although I wonder if the change is based on politics and not someone's "mistake").

(2) Mrs. Reading's post resulted in nearly 70 comments from various community members which included divisive statements and ultimately, after multiple community members reported the post, the administrator of the page turned the post's comment section off.

(3) Among the comments were several by Mrs. Reading in which she repeatedly accused the DOH of lying to the public about a change they made to COVID-19 guidance related to schools, including those in the Northern Burlington Regional School District. She continually alleged that the DOH's correction of a misprint related to COVID-19 guidance for schools was based on politics and not because it was actually a misprint. In relation to the post, Mrs. Reading made statements such as,

This is an egregious and irresponsible "misprint" that confuses the public and has school administrators and leaders scrambling. "Mistakes" like this cause the public to lose trust, which is not good for anyone.

If I'm being honest, the change is very suspect. This does not appear to be a "mistake" based on someone typing the wrong thing. This appears to be a change based on politics. Which is truly unfortunate. Exhibit "A" at p. 2.

(4) Mrs. Reading noted that "[c]hanges like this cause chaos for school leaders and the public. Also, they should be honest about the change. It is difficult to believe that this was a mistake. I believe this change was based on politics. I wish they would be honest." Exhibit "A" at p. 7.

(5) Mrs. Reading further remarked "...I have never held a job that would have allowed me to make such a major mistake. **This guidance impacts 2,493 schools and 686 school districts. Admins made changes based on last week's guidance and are now forced to change again.** This is very problematic." Exhibit "A" at p. 9. Emphasis added.

(6) When asked by a community member "So what exactly is the purpose of this post on Northern Burlington Parent's Facebook page, attacking the DOH? Seems like more of an ax to grind than something that helps the parents of kids at Northern." Mrs. Reading replied that,

...to update parents on the NEW guidance. The 1/12/22 guidance made close contact quarantine for unvaccinated students VERY RARE. Parents were updated on this change last week. NOW it appears that the guidance has changed again (based on a "mistake"). Thus, parents of unvaccinated children in our community should be aware of the change and be prepared moving forward. They may want to address this change with school leaders or health officials. I know parents with vaccinated kids may not care about the change, but this impacts many families in our community. Exhibit "A" at p. 11.

(7) Mrs. Reading then posted what can only be categorized as a contentious attack of a parent stating,

... Now, a question for you. So what exactly is the purpose of you alluding to the fact that I was "attacking the DOH"? Was it to discredit me? Was it to portray me in a negative light? How did your comment add to the conversation or help the community? Thanks for this dialogue.

Exhibit "A" at p. 12.

(8) Another community member questioned the appropriateness of Mrs. Reading's posts given her membership on the BOE, stating **"Everything about the post is geared towards discrediting the DOH. Aren't you on the BOE, and if so, is this really appropriate?"** Exhibit "A" at p. 12. Emphasis added.

(9) The community member further noted that Mrs. Reading "posting about an 'error' that the DOH made on this page does nothing to help the community... Yes, it is obviously necessary for school officials but in all honesty what is posting this information going to do for anyone? Exhibit "A" at p. 12.

(10) The community member further posted that "Egregious and irresponsible" aren't exactly words that are singing the praises of the DOH. I would consider that an attack, however subtle or covert it may have been intended to be." Exhibit "A" at p. 13.

(11) Another community member then stated, in reply to the chain "and let's not forget her strong insinuation without proof that this was not a mistake but a political move- that does nothing but divide and discredit- it is hypocritical that she talks about how the DOH should not put anything out without proofreading for mistakes but she does not do that herself even though she goes to law school". Exhibit "A" at p. 13. Emphasis added.

(12) In response to a comment that questioned her post, Mrs. Reading attacked the community member stating,

so sharing guidance and stating the facts is now discrediting the DOH? Or did the DOH discredit themselves by their own mistakes? Reasonable minds can disagree, but unreasonable minds can do it a lot better. I know many of you in this group would like to silence me and use my elected position as your justification to do so. So let me break this down for you. First, I am allowed to share readily available guidance online. Second, I am a mother first. This guidance impacts my children. Third, I am not speaking as a BOE member or sharing any information

particularized to NBC. I am also not being derogatory in any way. Thus, I am not in violation of ethical rules. Finally, just because I hold a public office does not mean I give up my right to speak about public matters. This is a public matter. Exhibit "A" at p. 14.

(13) Mrs. Reading then continued to post comments disparaging the DOH without posting the requisite disclaimer on her subsequent statements.

(14) In response to her posts, some community members questioned Mrs. Reading's motives and noted that she was creating strife for no real reason. One community member noted "[w]e have every right to question authority, but in this instance, all it does is rile people up over something that could totally be just human error." Exhibit "A" at p. 17. Another community member provided, "[y]ou are introducing the idea that the change was based on politics where it really doesn't belong. Simply stating the mistake would have been sufficient. Suggesting that politics were involved simply creates strife." Exhibit "A" at p. 17. See also Exhibit "A" at pp. 19, 21, 23-4, and 28.

(15) Mrs. Reading continued to accuse the DOH of malfeasance and among other things noted that **"the error is not minor (a few words or numbers): it is significant and has major implications on school policy."** Exhibit "A" at p. 18. Emphasis added. Exhibit "A" pp. 19-32.

(16) Mrs. Reading also claimed, "A 'mistake' of this magnitude impacts 2,493 schools in our state and creates uncertainty in school policy and procedures. This in turn, impacts many families in OUR community." Exhibit "A" at p. 32.

(17) Ultimately, the administrator of the group turned off public comments informing Mrs. Reading,

This post has been reported several times. Every single time you use quotation marks around misprint and mistake, you are insinuating distrust in the DOH. And yes that will cause issues in the group. If people also feel it's a mistake, they can surmise that for themselves when they see the change. There is no need to lead people down that path and cause issues here. If people want to have an issue with the DOH, they can certainly figure that out and take it up with the DOH.

Sharing the update itself is perfectly acceptable and welcomed.
Exhibit "A" at p. 33. Emphasis added.

Date of occurrence: January 18, 2022.

(18) I assert this to be a violation of N.J.S.A. 18A:12-24.1 (e) because on January 18, 2022, Mrs. Reading took private action, without issuing the requisite disclaimer, that could compromise the Board. Mrs. Reading, without consulting her fellow Board members, took it upon herself to create a post on a parent based Facebook page for her district in which she accused the DOH of lying to the public in relation to COVID-19 guidance for schools during an ongoing pandemic because she believed they changed their guidance not do to a misprint, but based on politics. Mrs. Reading's actions could have compromised the Board as it could have caused parents and guardians to doubt

that the Board could and would work cooperatively with the DOH and properly enforce their guidance during a worldwide pandemic. Her actions further could have compromised the Board because she could have caused the public to doubt the neutrality of Board and to question their COVID-19 policies. Her actions further could have compromised the Board as Mrs. Reading disparaged the DOH despite the fact that the district needed to be able to work with the DOH with regards to COVID-19 and debasing them by calling their veracity into question could create tension and conflict. Mrs. Reading's actions further could have compromised the Board as her treatment of community members who disagreed with her in relation to the post was demeaning and could cause parents and guardians, especially those who disagreed with her, to be afraid to speak up and ask questions before the Board or to the school. Mrs. Reading's actions also could have diminished the Board's overall integrity in the eyes of the community members.

WHEREFORE, I, as Complainant, request that the School Ethics Commission find and determine that the above-named Respondent(s) has violated the School Ethics Act and that he or she be subject to such penalty as provided by the Act.

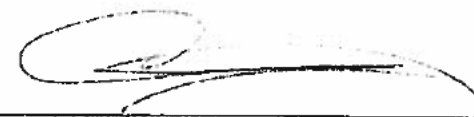

For determining a school based close contact to a COVID-19 case:

- Individuals would be considered exposed during the period between 2 days prior to symptom onset (or positive test date if asymptomatic) and 5 days after
- Individuals would NOT be considered exposed during the case's additional precaution period at day 6-10)

Exception – schools who are using a "Test to Stay" protocol may allow asymptomatic close contacts to return to in-person academic activities immediately so long as the contacts follow the protocol.

For determining the timing of close contact to a COVID-19 case:

- Individuals would only be considered exposed if they had close contact during the case's isolation period (day 1-5)
- Individuals would NOT be considered exposed during the case's additional precaution period at day 6-10).
