PROPOSAL (SCOPE OF WORK):

Having spoken with Detective Captain Mark Distler and having observed the property and evidence function of the Teaneck Police Department, I recommend and am quoting for Property Room Consulting Inc. services for the following needs:

1. An inventory audit of the Teaneck Police Department's Property and Evidence room(s). This audit shall as best as practical consist of 100% verification against the agency log of all CDS, firearms, currency; and jewelry, precious metals and gemstones valued at over \$500, as well as any bodily fluids that may be on hand. General evidence shall be verified at the level of a representative sampling (95% confidence, interval of 5). Complete report of findings to agency CEO, including levels of confidence. Meets or exceeds national and state accreditation standards.
2. Complete examination and analysis of the Department's PE workflow through inspection. Review practices versus policy and make recommendations for modifications, including where current policy and practices are in conflict. Provide agency CEO recommendations and suggested policy revisions, particularly to be in alignment with State law and policy as well as certain best practices consistent with contemporary policing models.
3. Evaluation and development of a general plan of action for the efficient disposition and ultimate disposal of eligible items through the method appropriate for each circumstance. Integration of the plan of action with the features of the BEAST system that are designed for this purpose.

General Instructions

Section references are to the Internal Revenue Code unless otherwise noted.

Purpose of Form

2. Certify that you are not subject to backup withholding, or

If applicable, you are also certifying that as a U.S. person, your allocable share of any partnership income from a U.S. trade or business is not subject to the withholding tax on foreign partners' share of effectively connected income.

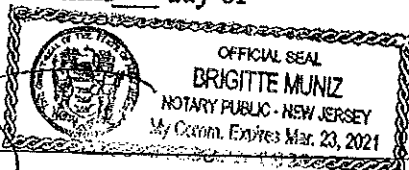
