ON JANUARY 2, 2025, AT APPROXIMATELY 1:13 PM, DURING A MOTOR VEHICLE STOP, LLOYD JOHNSON WAS ARRESTED AFTER DISCOVERING HE HAD AN OUTSTANDING WARRANT FROM EWING. JOHNSON WAS OPERATING HIS GIRLFRIEND'S 2018 HYUNDAI WHEN HE WAS OBSERVED DISREGARDING A STOP SIGN. AFTER OBSERVING THE VIOLATION, A MOTOR VEHICLE STOP WAS INITIATED. DURING THE STOP, JOHNSON DID NOT POSSESS A VALID DRIVER'S LICENSE AND PROVIDED ME WITH HIS NEW JERSEY IDENTIFICATION, WHICH REVEALED THE OUTSTANDING WARRANT FROM OUR JURISDICTION.

JOHNSON WAS ARRESTED NEAR INTERSECTION OF SPRUCE STREET AND SIXTH STREET, HANDCUFFED (DOUBLE LOCKED), SEARCHED INCIDENT TO ARREST, WHICH YIELDED NEGATIVE RESULTS AND PLACED INTO UNIT #626 FOR TRANSPORT. THE PATROL VEHICLE WAS SEARCHED PRIOR TO TRANSPORT, WHICH YIELDED NEGATIVE RESULTS. JOHNSON WAS TRANSPORTED TO POLICE HEADQUARTERS FOR PROCESSING. AT HEADQUARTERS, JOHNSON WAS TAKEN INTO BOOKING AND HIS PERSONAL PROPERTY WAS INVENTORIED (SEE THE PRISONER PROPERTY SHEET).

THE PATROL VEHICLE WAS SEARCHED AFTER TRANSPORT, WHICH YIELDED NEGATIVE RESULTS FOR ANY CONTRABAND. JOHNSON WAS IDENTIFIED BY HIS NEW JERSEY IDENTIFICATION CARD.
