Investigation Narrative

On February 26, 2020, at approximately 1826 hours, Sergeant Mooney #335, Officer Elwood #425, Officer Geskey #432, and I responded to Exxon, located at 851 Route 37 West, on the report of a simple assault. Upon arrival, I located the victim, sitting in the rear seat of a black 2015 Dodge Durango, bearing NJ registration .

Upon speaking with , I observed that his upper lip was split and his face was covered in blood. When I inquired on how he was injured, responded that he fell on the pavement. stated that he was not involved in a physical altercation and there was no suspect involved. also refused to provide me with any form of identification and refused to answer any further questions.

I then spoke with a male witness, who did not wish to identify himself. The witness stated that was involved in a physical altercation with another male, who he believed to be . The witness informed me that left the area in an unknown direction prior to police arrival.
