Monmouth County (New Jersey) jail officers slammed Amit Bornstein's head into the ground, punched and kicked him, and continued to beat him even after he was handcuffed and shackled, an inmate who witnessed the 2010 incident testified during a wrongful death lawsuit.

"(Bornstein) was pleading with them that he was with them and didn't want to fight with them," said Jared Weaver, a former Matawan resident who now lives in Florida.

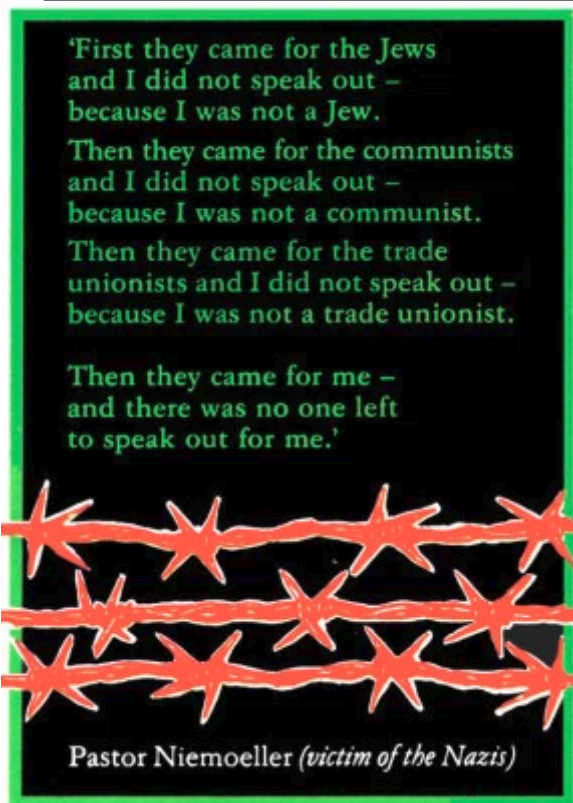
