PURPOSE The Brick Township Police department endorses the secure use of social media to enhance communication, collaboration, and information exchange, streamline processes, and foster productivity. This policy establishes this department's position on the utility and management of social media and provides guidance on its management, administration, and oversight. This policy is not meant to address one particular form of social media; rather social media in general, as advances in technology will occur and new tools will emerge.

POLICY Social media provides a new and potentially valuable means of assisting the department and its personnel in meeting community outreach, problem-solving, investigative, crime prevention, and related objectives. This policy identifies potential uses that may be explored or expanded upon as deemed reasonable by administrative and supervisory personnel. The department also recognizes the role that these tools play in the personal lives of some department personnel. The personal use of social media can have a bearing on departmental personnel in their official capacity. As such, this policy provides information of a precautionary nature as well as prohibitions on the use of social media by department personnel.

I. DEFINITIONS

- A. **Employee** – A sworn or non-sworn member of the Brick Township Police Department.
- B. **Blog** – A self-published diary or commentary on a particular topic that may allow visitors to post responses, reactions, or comments. The term is short for "Web log."
- C. **Page** – The specific portion of a social media website where content is displayed, and managed by an individual or individuals with administrator rights.
- D. **Post** – Content an individual shares on a social media site or the act of publishing content on a site.
- E. **Profile** – Information that a user provides about himself or herself on a social networking site.
- F. **Social Media** – A category of Internet-based resources that integrate user-generated content and user participation. This includes, but is not limited to, social networking sites (i.e. Facebook, MySpace), microblogging sites (i.e. Twitter, Nixle), photo- and video-sharing sites (i.e. Flickr, YouTube, Instagram). Wikis (i.e. Wikipedia), blogs, and news sites (i.e. Digg, Reddit).
- G. **Social Networks** – Online platforms where users can create profiles, share information, and socialize with others using a range of technologies.
- H. **Speech** – Expression or communication of thoughts or opinions in spoken words, in writing, by expressive conduct, symbolism, photographs, videotape, or related forms of communication.
- I. **Web 2.0** – The second generation of the World Wide Web focused on shareable, user-generated content, rather than static web pages. Some use this term interchangeably with social media.
- J. **Wiki** – Web page(s) that can be edited collaboratively.

II. ON THE JOB USE

A. Department-Sanctioned Presence

1. Determine Strategy

- a. Where possible, each social media page shall include an introductory statement that clearly specifies the purpose and scope of the agency's presence on the website and shall clearly indicate they are maintained by the department and have department contact information prominently displayed.
- b. Where possible, the page(s) should link to the department's official website. All department related social media sites or pages shall be approved by the Chief of Police or designee.

2. Procedures

- a. All Brick Township Police Department social media sites or pages shall be approved by the chief executive or designee and shall be administered by the Public Information Officer in the Community Policing Division. Where possible, social media pages shall clearly indicate they are maintained by the department and shall have department contact information prominently displayed.

- b. In those cases where social media sites or pages are utilized for investigative purposes (i.e. Child Luring), those investigations and sites or pages must have the approval of the Chief of Police, designee, or the division commander to allow their use.
 - 1. Investigators may view social media sites and pages that are available and accessible by the general public to further the investigation.
 - 2. Creation of a false identity, web site, social media page or account to access areas of the site or pages that are limited, must be in accord with federal and state laws and guidelines and must have the approval of the Chief of Police, designee, or the division commander prior to the creation.
 - c. Social media content shall adhere to applicable laws, regulations, and policies, including all information technology and records management policies.
 - 1. Content is subject to public records laws. Relevant records retention schedules apply to social media content.
 - 2. Content must be managed, stored, and retrieved to comply with open records laws and e-discovery laws and policies.
 - d. Where possible, social media pages should state that the opinions expressed by visitors to the page(s) do not reflect the opinions of the department.
 - 1. Pages shall clearly indicate that posted comments will be monitored and that the department reserves the right to remove obscenities, off-topic comments, and personal attacks.
 - 2. Pages shall clearly indicate that any content posted or submitted for posting is subject to public disclosure.
3. Department-Sanctioned Use
- a. Department personnel representing the department via social media outlets shall do the following:
 - 1. Conduct themselves at all times as representatives of the department and accordingly, shall adhere to all department standards of conduct and observe conventionally accepted protocols and proper decorum.
 - 2. Shall identify themselves as a member of the department.
 - 3. Shall not make statements about guilt or innocence of any suspect or arrestee, or comments concerning pending prosecutions, nor post, transmit, or otherwise disseminate confidential information, including photographs or videos, related to department training, activities, or work-related assignments without express written permission.
 - 4. Shall not conduct political activities or private business.
 - b. The use of department computers by department employees to access social media is prohibited without authorization.

- c. Department personnel use of personally owned devices to manage the department's social media activities or in the course of official duties is prohibited without express written permission from the Chief of Police or designee.
- d. Employees shall observe and abide by all copyright, trademark, and service mark restrictions in posting materials to electronic media.
- e. All department employees that access the department sanctioned social media sites or pages, whether from the department devices or from their personally owned devices, shall be considered as representing the department.

B. Potential Users

1. Social media is a valuable investigative tool when seeking evidence or information about:
 - a. missing persons;
 - b. wanted persons;
 - c. gang participation;
 - d. general crime information;
 - e. crimes perpetrated online (i.e., cyber-bullying, cyber-stalking);
 - f. photos or videos of a crime posted by a participant or observer; and
 - g. photos or video of a crime where the department needs the media's assistance, as approved by supervisory personnel.
2. Social media can be used for community out-reach and engagement by:
 - a. providing crime prevention tips;
 - b. offering on-line reporting opportunities;
 - c. sharing crime maps and data; and
 - d. soliciting tips about unsolved crimes (i.e. Tips411, Crimestoppers, text-a-tip).
3. Social media can be used to make time sensitive notifications related to:
 - a. road closures;
 - b. special events;
 - c. weather emergencies;
 - d. missing or endangered persons; and
 - e. accidents and/or crime scenes where the public may be affected.
4. Social media may be used for:
 - a. recruiting;
 - b. advertising employment positions;
 - c. publicizing volunteer positions; and
 - d. offering training opportunities.
5. Persons seeking employment and volunteer positions use the internet to search for opportunities and social media can be a valuable recruitment mechanism.
6. This department has an obligation to include internet-based content when conducting background investigations of job candidates.
7. Searches should be conducted by a non-decision maker. Information pertaining to protected classes shall be filtered out prior to sharing any information found online with decision makers.

8. Persons authorized to search internet-based content should be deemed as holding a sensitive position.
9. Search methods shall not involve techniques that are a violation of existing law.
10. Vetting techniques shall be applied uniformly to all candidates.
11. Every effort must be made to validate internet-based information considered during the hiring process.

Another fun fact is the John Brogan and Joe Coronato relationship ... John Brogan and Joe Coronato have had a very unholy alliance, since shortly after Coronato came into office. Chief Riccio and his police department have refused to give me the address of a former Brick Police Detective who libeled me on the OCPO's Facebook page. This former Brick cop stated that I had stalked and harassed people in the past and was arrested for it. What he left out was that Judge Peterson not only ruled that I was innocent, he also ruled that the detective falsified evidence against me and had me falsely arrested twice. Chief Riccio told me my complaint about this former cop was petty.

When I told Chief Riccio that I was going to complain to the FBI about his conduct towards me, he had a panic attack. He started breathing heavily, turned red in the face and started crying and then grabbed his chest and said he was having chest pains. As he walked away from me I heard the sound of flatulence as if he had a bowel movement in his pants. He didn't act much better during the council meeting of 03/13/18 when I asked him about the SWAT weapons the Brick police had., and if Brick needed a SWAT team, since we already were paying for one with the Ocean County Sheriff's Department.

Good morning, I am sending this as a private message instead of posting it publicly to protect those involved. We live on the cul-de-sac side of Patriot Ave. We have 11 children who attend Lanes Mill School. The bus stops on Burrsville Road, at the top of our street. Our bus driver is amazing. That is not the issue. What is the law concerning shoveling sidewalks after it snows? Yes, one side of the road is shoveled, but if you look at that side, it is too close to busy Burrsville for the children to stand safely. Cars travelling on Burrsville tend to pass any cars stopped to turn left onto Patriot on the right shoulder. We parents do not feel that corner is safe. We have relocated to the opposite corner, where the kids can stand a bit back from Burrsville until the bus arrives, yet be close enough to not make the bus and traffic wait too long for the children to board the bus. Since the past snowfall, the sidewalks on that 'safe side' corner of Burrsville and Patriot have not been shoveled. Actually, the residents, whose sidewalks run on their property, have never shoveled those sidewalks. Usually my husband or another neighbor, who live further into the cul-de-sac have gone up to shovel the other residents' property to make it safe for our children. Unfortunately my husband has been stuck at work for this snowfall and has not been home to shovel up to the bus stop. I would not allow my 87 year old father to run the snowblower up that far, or shovel that far. I will most likely bring my shovel up to clear a path. I live several houses in and my sidewalks are done and safe, even for the mail carrier to reach our mailbox safely. I am not sure if you have ever noticed, but the gentleman on the corner, whose driveway is off Burrsville, parks on Patriot. He walks through his backyard to reach his car. If you look today, he has footprints in the snow to his car. His driveway is shoveled which tells us the sidewalk bus stop area could have been shoveled at the same time. Due to the covered sidewalks, our children have to wait and run down the middle of Patriot Ave to get on the bus while it is stopped on Burrsville, thus making traffic wait longer for the bus to move on. We

have already had problems with cars running the bus' red stop lights. My question is what are the laws concerning the clearing of snow on a person's property? What can be done to ensure our children are safe while waiting for the bus since this 'safe side' bus stop sidewalk isn't shoveled? Thank you for your attention to this safety issue. And a big thank you to the public works department for clearing our street and making it safe for our children to wait in the middle of for the bus.
