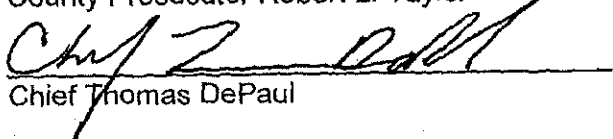

I. PURPOSE

The purpose of this directive is to provide guidance to members of Police Departments in Cape May County concerning their personal web pages, websites and other electronic social networking sites.

II. POLICY

It is the policy of the Cape May County Chiefs of Police Association while employees have a right to maintain personal web pages and websites, their status as members of a Police Department in Cape May County requires that the content of those web pages and websites not be in violation of existing agency rules, regulations, policy, procedures, or orders.

III. DEFINITIONS

Personal Web Page: pages on the World Wide Web that are created by an individual to contain the content of a personal nature rather than on the behalf of an employer or institution.

Social Networking Web Page: is an online service, platform, or site that focuses on building and reflecting of social networks or social relations among people, who, for example, share interests and/or activities. A social network service essentially consists of

a representation of each user (often a profile), his/her social links, and a variety of additional services. Most social network services are web based and provide means for users to interact over the Internet, such as e-mail and instant messaging. Sites include, but are not limited to Facebook®, MySpace®, YouTube®, Twitter®, other social networking sites, etc.

IV. **PROCEDURES**

1. General

- A. Employees have the potential to be called as a witness in court proceedings related to their employment as a member of this agency. Credibility and character are subject to challenge and potential impeachment. The nature of postings on personal web pages, websites, and other electronic social networking sites from any time, past or present can be used as the basis for such challenges.
- B. Employees must be cognizant of the potential adverse consequences of internet postings such as their credibility during cross-examination in court, future employment, and possible embarrassment in the media.
- C. Conduct both on and off duty is subject to the rules and regulations of the police Agency. Any activity that brings discredit to the Agency and of an employee's status as an employee of the Agency is prohibited.
- D. Employees shall not express personal opinion as official agency policy or position.
- E. Any item, object, material, or account that could be used or misconstrued as official agency sanctioned property or position shall not be used or depicted on any personal Internet posting without the expressed written permission of the Chief of Police.
 - 1. These items, objects, or materials include, but are not limited to: photographs, images, reproductions or other depictions of agency badges, patches, equipment, weapons, marked or unmarked units, reports, evidence, property, crime or crash scenes, etc.
 - 2. Internet posting also includes accounts of agency activity or investigations (criminal, civil, or administrative) on Twitter®, similar electronic networking site or an employees personal Web Page.
- F. Employees are prohibited from posting to or accessing personal web pages, websites, and electronic social networking sites while working, except in the performance of official duties.
- G. Employees are prohibited from posting to or accessing personal web pages or websites from Agency computers or electronic devices, except in the performance of official duties.
- H. All employees must promptly report any information they may have concerning any violation of this Policy.

v. **APPROVAL PROCESS**

1. Any employee seeking approval to use any item, object, or material described above on a personal webpage or site shall:
 1. Submit a request for approval to the Chief of Police through the chain of command.
 2. Describe the proposed reference to the agency and purpose.
 3. Provide a list of media to be used on the web page.
 4. Provide a printed layout of the material that is the subject of the request.
2. The Chief of Police will approve or deny the request based upon its compliance with existing agency policy, procedures, orders, or public policy.

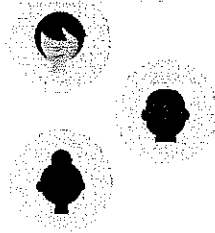

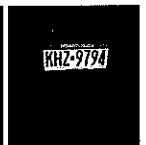

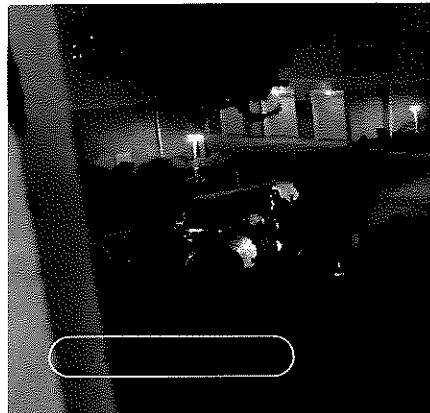
