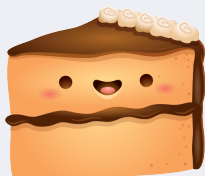

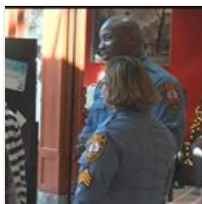

NHTSA has identified a very serious issue relating to certain 2001-2003 Honda and Accura vehicles equipped with Takata airbags. Tests on this subset of vehicles (part of a larger 70 million vehicle recall effort) show a 50% chance of ruptures during air bag deployment, which can lead to serious injuries and even fatalities. We estimate about 300,000 such cars are still on the road today that need to be repaired immediately, so much so that our warning to owners is that these vehicle be driven for one purpose only: to go straight to a dealership for repair.

There are many reasons why these vehicles remain unrepaired, including the difficulty in identifying vehicle owners and, once identified, urging them to take action.

There are many ways to help. Here are just two:
Enlisting the support of your State DMV.

New York State DMV began urging vehicle owners to check www.safercar.gov for recall information through press releases (see below), notices on vehicle inspection reports, and other methods. Puerto Rico's licensing agency has done similar outreach, including linking its website to www.safercar.gov.

Enlisting the support of partner organizations

CPS communities, which regularly interacts with vehicle owners, could support this effort through activities ranging from disseminating vehicle safety information to actual VIN lookups via tablets or cell phones. Other organizations such as local AAA clubs (through its "Car Fit" program and by providing travel services), dealer associations, and the like also interact with the motoring public and can help in similar ways.
