WHEREAS, a need exists in the Fire Department for the purchase and delivery of New 3M Scott Air-Paks Self-Contained Breathing Apparatus (SCBA's) with Voice Amplifiers & Cylinders; and

WHEREAS, the Fire Department recommends purchase of 3M Scott Air-Paks SCBA's with Voice Amplifiers & Cylinders in accordance with the New Jersey State Contract 24- FLEET Purchasing; and

WHEREAS, the New Jersey State Public Contract Law 40A:11-3 et. seq. states that when accepting an item under a cooperative contract, specifically, New Jersey State Contract 24- FLEET – 61850 Vendor ID#00000570, a resolution must be adopted by the Governing Body; and

WHEREAS, the manufacturer for the SCBA's will be Scott Fire & Safety, Monroe, North Carolina for forty (40) 3M Scott Air-Paks, eighty (80) 4500 Cylinders and twenty (20) Voice Amplifiers to be purchased through their dealer, New Jersey Fire Equipment Co. 119-131 Route 22 East, Green Brook, NJ 08812 and the pricing of the equipment is through the New Jersey State Contract 24- FLEET Purchasing Program and is not expected to exceed \$535,000; and

WHEREAS, Certificate of the Chief Financial Officer certifying the availability of adequate funds for this contract, prepared in accordance with N.J.A.C 5:30-1.10, has been furnished to the Town Clerk with expenditure of funds pursuant to this contract being charged to Special Ordinance No. 2025-01

NOW, THEREFORE, BE IT RESOLVED that the Town of Westfield award a contract in an amount not expected to exceed \$535,000.00 to New Jersey Fire Equipment Co. 119-131 Route 22 East, Green Brook, NJ 08812 for forty (40) 3M Scott Air-Paks, eighty (80) 4500 Cylinders and twenty (20) Voice Amplifiers, to be charged to Special Ordinance S.O. 2025-01, account C-07-25-001-7A1, under Purchase Order 25-01702.

BE IT FURTHER RESOLVED, that the proper Town Officials be, and they are hereby authorized to take whatever actions are appropriate in the execution and discharge of this Contract.
