RESOLUTION FURNISHING AND DELIVERY OF SIXTY (60) NEW FIRE
HELMETS AND ONE HUNDRED (100) FIREFIGHTER HOODS FOR THE

WHEREAS, bids were received by the Director of Purchasing on Wednesday, April 23, 2025, for Furnishing & Delivery of Sixty (60) New Fire Helmets and One Hundred (100) Firefighter Hoods; and

WHEREAS, it is recommended by Chief Patrick Trentacost that the bids received from Turn out Uniforms Inc., Little Falls, NJ, and Galls, LLC, Lexington, KY be rejected as they were non-responsive to the specifications as per the Local Public Contracts Law **40A:11-2 (27)**; and

WHEREAS, a full list of vendors that downloaded specifications from the website can be obtained from the Purchasing Department; and

WHEREAS, it is the recommendation of Fire Department Chief Patrick Trentacost that the contract for Furnishing & Delivery of Sixty (60) New Fire Helmets and One Hundred (100) Firefighter Hoods be awarded to AA Emergency Supply Co., Inc., of White Plains, NY, in the amount of **\$36,240.00**.

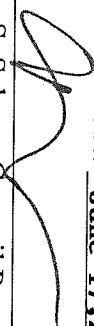

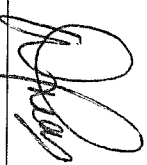
