Narrative

William Foy called NCPD and reported a smell of animal urine and feces coming from the properties of 135 and 139 Summit Ave. I subsequently spoke with Foy who reported an abundance of cats in the area, all drawn to the listed locations. While in front of Foy's home, I could smell the distinct odor he described and the odor intensified as I approached the addresses.

Upon inspection of the exterior of the residences, they are both extremely overgrown with brush, weeds, grass, and trees. There were swarms of flies surrounding both residences, and garbage and debris present. While standing outside the house, piles of debris/ belongings were piled up in the doors and windows. I knocked on both doors and was overwhelmed by the smell, which was nauseating. I received no answer from either residence, I did observe numerous cats running loose around the residences and on the property.

I contacted Neptune City Code Enforcement Officer Robert Reynolds Sr who responded to the scene. The only access point to the property was through the yard of 65 Avondale Ave. A check of the rear of 135 Summit Ave revealed more overgrown weeds, brush, and trees. There were numerous open containers of cat food out, swarms of flies, garbage all over the property, clothes on hangers hanging in bushes, standing water, and the smell of cat urine and feces was unbearable. There was also a hose set up on the side of 139 Summit Ave that appeared to be a bathing station. Cats were observed running throughout the property, on the roofs, and running out of contained areas. Mr. Reynolds reported he did not believe the homeowner, Felicia Berardesco, was home; as her vehicle was not parked in the street.

Mr. Reynolds contacted the Monmouth County Health Department and was advised they would respond at approximately 12:30pm. I contacted Monmouth County SPCA Lt. Michael Goldfarb and advised him of this case. He reported he would also be responding. I notified NCPD Humane Officer Det. VanEtten and advised him of this case.

I later met with Monmouth County SPCA Lt. Michael Goldfarb, Monmouth County SPCA Officer Michael Magliozzo, Neptune City Code Enforcement Officer Reynolds, and Monmouth County Health Department Specialist John Borja. All officers inspected the area. The Monmouth County SPCA gave Berardesco a notice to contact them within 24 hours and will subsequently give her a timeframe to fix conditions or receive violations. The Monmouth County Health Department was going to issue summonses for insect harborage as well as the food/debris violations. Neptune City Code Enforcement would issue violations for the overgrown weeds, the trash/rubbish, and the abandoned vehicle in the back yard of 135 Summit Ave.
