RESOLUTION OF THE TOWNSHIP OF LACEY, COUNTY OF OCEAN, STATE OF NEW JERSEY, CERTIFYING THE LISTS OF VOLUNTEER FIREFIGHTERS AND EMERGENCY SERVICE SQUAD MEMBERS WHO HAVE QUALIFIED FOR THE LENGTH OF SERVICE AWARD PROGRAM (LOSAP) BENEFITS FOR THE YEAR 2017

WHEREAS, pursuant to N.J.S.A. 40A: 14-191, the voters of the Township of Lacey approved by referendum participation in the Length Of Service Award Program (LOSAP) for the Benefit of Volunteer Firefighters and Emergency Service Squads; and

WHEREAS, the Fire Chiefs and First Aid Squad Captains of the Lanoka Harbor, Forked River and Bamber Lake Fire Companies and the Lanoka Harbor and Lacey Township First Aid Squads have submitted their list of Volunteer Firefighters and Emergency Service Squads members who have met the Qualification Criteria established for the Year 2017 (Exhibit 1 annexed hereto); and

WHEREAS, the Volunteer Firefighters and Emergency Service Squads members on the attached lists have met the Criteria for LOSAP for the Year 2017.

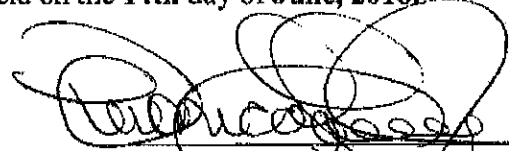
NOW, THEREFORE, BE IT RESOLVED by the Township Committee of the Township of Lacey, County of Ocean, State of New Jersey, as follows:

1. That the lists of Volunteer Firefighters and Emergency Service Squads members attached hereto are hereby certified to have met the Criteria for the Length Of Service Award Program (LOSAP) Benefits for the Year 2017.
2. That a certified copy of this resolution and the certification list shall be forwarded to the Lanoka Harbor, Forked River and Bamber Lake Fire Companies and the Lanoka Harbor and Lacey Township First Aid Squads for posting for a period of thirty (30) days to allow sufficient time for membership review.
3. That a certified copy of this resolution and the certification list shall be posted at the Office of the Municipal Clerk for a period of thirty (30) days.
4. That appeals to the certification list must be in writing and shall be mailed to the Municipal Clerk and must be received within thirty (30) days of the posting date of the certification list.

5. That following the thirty (30) day period for filing an appeal, and subject to holding payment of any members being appealed, payment shall be made by the Township of Lacey to Lincoln National Life Insurance Company and Lincoln Financial Group, its agent, for deposit into the LOSAP account in the deferred income program.
