Description

Synopsis: On Monday March 6, 2023 at 1345 hours the West Tuckerton Fire Company was dispatched to 7 Harvest Way for a possible structure fire. On arrival, 7150 arriving on engine 7101 requested a working fire assignment. Heavy smoke and flame were coming from the residence. Heat from the fire was melting the siding on the homes on each side of the fire building. Protection lines were set up between the homes as well as a master stream from 7101. Assist Chief Antony DeAndrea 7110 arrived and assumed command. Mutual aid fire companies arrived and assisted in extinguishing the fire. With the fire knocked down the Fire Marshal's Office was requested.

Scene Examination: On Monday March 6, 2023 at 1416 hours the Ocean County Fire Marshal's Office was requested to respond to 7 Harvest Way in Little Egg Harbor Township for an origin and cause fire investigation. On arrival I first spoke with Assistant Fire Chief Anthony DeAndrea for information on the fire. Chief DeAndrea stated that the structure was fully engulfed in flames when he arrived and that there was possibly someone missing in the structure. I then spoke with Sergeant Thomas Haskell of the Ocean County Prosecutors Arson Investigation unit to update him as to the status of the possible missing person. He stated that Arson Detective John Mount would be heading to the scene. Deputy Fire Marshal's John Pasola and Darlene Genovese arrived to assist in the investigation. I then spoke with Little Egg Harbor Twp. Police Detective Joseph Falkiewicz for information on the owner on the home and the possible missing person.

Det. Mount arrived and was briefed on all known information. Fire personnel located the missing person in a front room of the home. Fire Investigators then secured the area to preserve the scene. Fire personnel continued with the overhaul operations. At this time the Ocean County Fire Marshal's office continued to assist with the fire investigation. Any additional information on the origin/cause of the fire will come from Detective John Mount and the Ocean County Prosecutors office.
