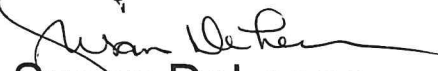

On 11/13/2021 I was dispatched to 43rd and Park for the report of a tree on fire.

I responded in an emergent manner to this location, where I was flagged down by the caller of the incident.

Upon my arrival, the tree was actively on fire within the inside, smoking, with visible flames.

Myself and Ptl. Haugh #43 utilized our fire extinguishers to control the fire until the Fire Department arrived on scene.

Upon the Fire Departments arrival, they were able to put out the fire and cut down the tree as to prevent any further fire hazard.

All units cleared the scene after the scene was deemed safe by fire.
