CPD 404, 434 and 442 responded to the above address on an activated fire alarm. Upon arrival officers observed heavy smoke coming from the vent on the roof of the building. CVFD member Grenci, Along with an employee, Ramirez, were on scene and advised of a grill fire inside the restaurant. CPD 442 and Grenci made entry and were able to knock the fire down with chemical extinguishers. CVFD and WCFD responded to the scene. CPD 442 and Grenci were given oxygen and assessed by WEFAS on scene. Officers made contact with the owner of the restaurant, Apostolopoulo, who was advised of the incident. CPD 405 advised the building department and health department were notified and would be responding. The chemical fire extinguisher from vehicle 53, 55 and 59 were utilized on scene and were taken out of service and replaced. CVFD cleared the scene. CC: 426
