To Whom it May Concern:

The Department of Corrections has received your Government Records Request. Your request has been assigned Request ID No. 15513 for tracking purposes. You have requested copies of the following records:

1. Any and all information and/or records generated since 6/1/2016 in reference to "First (1st) Amendment Audits", "Police Accountability", "Copwatching", "Copblocking", "Citizens Video Recording" and/or any other activities addressing persons who video record and/or photograph local, municipal, county, state, federal, and/or military personnel and/or property for the purposes of accountability, education, and/or public awareness of law enforcement/government conduct, including but not limited to documents, emails, memos, bulletins, notices, letters, directives, "bolos", videos, slideshows, presentations, etc.
2. Any and all records and/or documents generated since 6/1/2016 referring to "Matt Tim", "Police State: New Jersey", "PSNJ", "Gunnison Undercover", "Time to Change, Jersey Style", "NJ Wandering News", "Ironbound Media", and/or "Ask NJ Media Co." in reference to the above described activities.

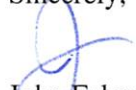
In response to your requests, please be advised that your requests as stated are invalid and improper. Pursuant to MAG Entertainment LLC v. Division of Alcohol Beverage Control, 375 N.J. Super. 534 (App. Div. 2005), your requests do not adequately identify the records you are seeking. OPRA allows for requests of specific records only, not requests for *information, data, or statistics*. OPRA "is not intended as a research tool . . . to force government officials to identify and siphon useful information." *Id.* at 546. In other words, a records custodian is not required "to conduct research among its records . . . and correlate data from various government records in the custodian's possession." *Id.* at 546-47. "To qualify under OPRA then, the request must reasonably identify a record and not generally *data, information or statistics*." Bent v. Township of Stafford Police 381 NJ Super 30 (App. Div 2005). Accordingly, your requests cannot be fulfilled and are denied.

You have a right to challenge the decision by the Department of Corrections. At your option, you may either institute a proceeding in the Superior Court of New Jersey or file a complaint in writing with the Government Records Council

Denial of Access Appeal Info

The New Jersey Open Public Records Act (N.J.S.A. 47:1A-1 et seq.) permits a person who believes he or she has been illegally denied access to a public record to file a complaint with the Government Records Council (GRC), or file suit in Superior Court to challenge the decision and compel disclosure. This poster describes the procedures for taking these actions.

To file a complaint with the Government Records Council:

Contact the GRC by phone at: 1-866-850-0511, by e-mail at grc@dca.state.nj.us, or review the GRC web site at www.nj.gov/grc for information and to register your complaint.

The GRC staff may be able to help resolve the problem over the phone. If not, you can receive a complaint form through the mail or from the web site.

When you file the written complaint, the GRC will offer you and the public agency non-adversarial, impartial mediation.

If mediation is not agreed to or fails, the GRC will investigate the complaint.

The investigation may result in findings or a formal decision by the GRC, which may include a hearing by the Council.

In some cases, the Council can award attorneys fees or fine a records custodian for failing to provide records.

Details of this process are available from the GRC.

There is no fee to file a complaint with the GRC.

To file a complaint in Superior Court:

A requester may start a summary (expedited) lawsuit in the Superior Court. A written complaint and order to show cause must be filed with the court.

The court requires a \$200 filing fee, and you must serve the lawsuit papers on the appropriate public officials.

The court will schedule a hearing and resolve the dispute.

If you disagree with the court's decision, you may appeal the decision to the Appellate Division of Superior Court.

If you are successful, you may be entitled to reasonable attorney fees.

You may wish to consult with an attorney to learn about initiating and pursuing a summary lawsuit in the Superior Court.
