To Whom It May Concern:

I serve as the municipal attorney for the Borough of Avon-by-the-Sea, Monmouth County, New Jersey (hereinafter "Borough"). Receipt is acknowledged of your OPRA request dated May 4, 2018.

You have made the following OPRA request:

"Most recent list of all Avon-by-the-Sea Borough's Fleet vehicles (if known, for example police interceptor), year(s) of manufacture, year(s) of purchase, purchase invoice for each vehicle and for what department its being used for."

The Borough does not retain copies of purchase invoice.

If your request for access to a government record has been denied or unfilled within the seven (7) business days required by law, you have a right to challenge the decision by the Borough to deny access. At your option, you may either institute a proceeding in the Superior Court of New Jersey or file a complaint with the Government Records Council ("GRC") by completing the Denial of Access Complaint Form. 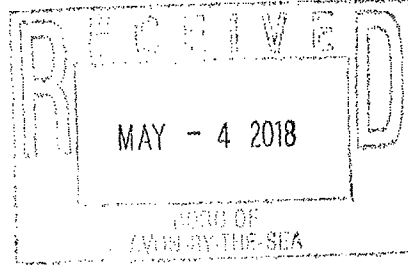
