Dear NJ Ask Media Co.,

This office received your records request dated April 9, 2018 via e-mail on April 9, 2018 and it was received by the records custodian on the same date. You requested the following:

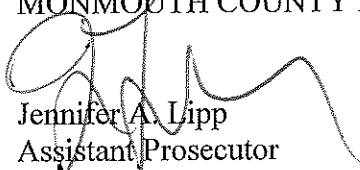
Most recent list of all Monmouth County Prosecutor's fleet vehicles (if known, for example Police Interceptor), year(s) of manufacture, year(s) of purchase, purchase price for each fleet vehicle.

Attached is a list of those vehicles. However, there are certain vehicles that are used for undercover and other law enforcement purposes such as surveillance. Those vehicles have been redacted. In addition, there are vehicles that are no longer used by this Office and were returned to the County. Accordingly, those were also redacted. Lastly, we do not have the purchase price for these vehicles. In order to find the purchase price for over 100 vehicles, some of which date back to 2003, we would have to do extensive research. OPRA does not force government officials to identify and siphon useful information on behalf of the requestor, nor does it compel them to review, analyze, collate and/or compile data or statistics. N.J. Builders Assoc. v. N.J. Council on Affordable Housing, 390 N.J. Super. 166, 177 (App. Div. 2007), cert. denied, 190 N.J. 394 (2007); MAG Entertainment v. Div. of Alcoholic Beverage Control, 375 N.J. Super. 534, 548 (App. Div. 2005). The money to purchase these vehicles comes from various sources including grants, county funds, state and federal forfeiture funds, and so on. This information is stored in different locations and is not readily accessible. Therefore, we cannot provide a purchase price for the vehicles.

In the event of a clarification or appeal, this office reserves the right to raise any other ground for denial not raised in this response. The failure of this office to assert an exception or privilege at this time does not act as a waiver of any grounds for denial.
